John,

This is a follow up from our conversation with Elmore Richardson earlier today. After further reviewing the Housing Authority Act (310 ILCS10) from the Illinois Compiled Statutes, it seems to say that commissioners cannot receive reimbursement for housing related duties if the population is under 25,000. As we discussed on the phone, you are to contact your attorney, as well as the State of Illinois, for clarification and interpretation of this law, as it relates to travel reimbursement of commissioners.

I sent the following message to John Kraft: "After receiving your email, and after further discussion with our management staff, I was directed by Mr. Richardson to issue the following: The Housing Authorities Act (310 ILCS 10) from the Illinois Compiled Statutes supersedes the Title 24 Code of Federal Regulations as it relates to reimbursement for travel expenses for Commissioners. The Housing Authority was established by the County of Edgar, under Illinois law."

Linda -

Our HA is a IL NAHRO member and I had a question that I hope you or other members could help me with.

Our Commissioners have traditionally been reimbursed for expenses relating to attending training conferences as well as mileage to attend monthly board meetings. Recently a citizen of our community questioned these costs and cited the Housing Authority Act (310 ILCS 10) from the Illinois Compiled Statutes. (See attached).

The statute says that counties with a population over 25,000 may allow these costs. Edgar County, as is the case with many of your member counties, has less than 25,000 people.

Although we obviously do not receive funding from the state, it appears most Housing Authorities in Illinois were established by the state. I was hoping that you could point me in the direction of any HUD regulations that would supersede this Illinois statute.

Thank you in advance for any help you or any IL NAHRO member could provide.
