In preparing a response to your request for additional information or documentation, I ran across two cases [Phelps v. U.S., 831 F.2d 897 (9th Cir. 1987) and Ungaro v. Desert Palace, Inc., D.Nev.1987, 732 F.Supp. 1522] that run contrary to what I thought was a normal interpretation of the statute.

These cases hold that the information sought is not confidential in the hands of the Water District.

Knowing that the requested information is not confidential, the Water District has no problem turning over the document requested.
