FOIA REQUEST FOR REVIEW - 2013 PAC 25089

In preparing a response to your request for additional information or documentation, I ran across two cases [Phelps v. U.S., 831 F.2d 897 (9<sup>th</sup> Cir. 1987) and Ungaro v. Desert Palace, Inc., D.Nev.1987, 732 F.Supp. 1522] that run contrary to what I thought was a normal interpretation of the statute.

These cases hold that the information sought is not confidential in the hands of the Water District.

Knowing that the requested information is not confidential, the Water District has no problem turning over the document requested.

Attached is a copy of the 1099 that was requested. It has been redacted by striking out the private information pursuant to Section 7(1)(b) of the act.
