FINDINGS OF BOARD EXAMINER

NOW COMES David J. Silverman the duly appointed Examiner of the Election Officers Electoral Board for Community College District 502 and states as follows:

1. That I am a duly licensed practicing attorney in the State of Illinois and have been so since 1988.
2. That I have experience in election law matters and have been engaged to represent numerous individuals and public entities in matters of this nature.
3. That I conducted an examination of the voter's records in the Office of the DuPage County Election Commissioner on the 13th day of January, 2017.
4. That Board attorney John Kness was present for a portion of the examination.
5. That Objector Edward Franckowiak was present for the entire examination.
6. That Objector Solyom did not appear for the examination.
7. That the Candidate Husna T. Ghani did not appear for the examination.
8. That the Petition Papers provided to me were not numbered, however, the pages were numbered by me for convenience of reporting and to correspond to the Objections.
9. That based upon the Objections presented, I have made the Findings with regard to the Objections as set forth on Exhibit A attached hereto and incorporated herein.

10. That to the extent available the signature cards in dispute have been provided to the Board for inspection by the Candidate, the Objectors and the Board.

11. That many of the Objections were sustained as not matching the records on the voter registration card because the “signature” was printed on the Petition and appears in cursive on the registration card.

12. The Appellate Court of the Second District of Illinois has ruled in the matter of the *Board of Education of DuPage High School District 88 et. al. v. Pollastrini et al.* 2013 IL App (2d) 120460 that printed names on a Petition do not substantially comply with the Election Code when cursive signatures appear on the corresponding registration form. All printed signatures for which the Objections were sustained had cursive signatures on the signature card.

13. That the Petition presented contained a total of eighty-six signatures.

14. That in the opinion of the Examiner forty-nine (49) of those signatures should be stricken for the reason set forth on Exhibit A and the corresponding Objections.

15. That in the opinion of the Examiner the Petition sheets contain thirty-seven (37) valid signatures.
