This is notification that your child has been removed from the Cumberland JFL Cheer squad by a unanimous vote. Your child can also never participate in future seasons of CJFL Cheer or Dance. You are also notified that your presence at any CJFLCD events or activities is not welcomed. This decision has been made by the Cumberland JFL Cheer and Dance Board on this date, September 26, 2017 and is effective immediately. Therefore, she will not be allowed to cheer at our 2017 Post Season Games.

This decision was made based on the documents signed in regards to parental code of conduct and our by-laws.

"Unsportsmanlike conduct will not be tolerated."

"We are a squad/team and will act like a squad/team even off the field"

"We are not affiliated with the school, but will act as if we were. We are the future of Cumberland cheerleading and dance. You represent not only yourself and team but also the school."

"Any parent that would like to speak to the coach or the board about a concern should make an appointment with one of the board members."

"The Cumberland Jr. Pirate Cheer and Dance parents will abide by all relevant Cumberland Jr. Pirate Cheer and Dance by-laws, rules, and code of conduct."

"Misconduct by a cheerleader or **parent** shall result in bench time or removal from the team. Shall a parent or cheerleader/dancer argue with a coach or board member during any Cumberland JP Cheer/Dance activity to an uncontrollable extent to cause harm whether physical, mental, or emotional to a coach, cheerleader, dancer, school, football league, or board member that parent will be asked to leave the premises with their cheerleader/dancer. End result will result in one missed game on the cheerleader's record. If the problem continues the Cheerleader or Dancer will be removed from the team by a $\frac{2}{3}$ board vote."

Per the paperwork signed, you have agreed to return the uniform, in full or pay the fee of \$100. (undershirt, uniform top and bottom, sweatshirt, pants)

Per your agreement with Creative Portraits by Jodi to photograph your daughter, cost was incurred by the CJPCD organization and therefore reimbursement in the amount of \$20.00 is due. Upon receipt of payment - photographs will be available.

Dues remaining for your child's participation in this year's completed season are outstanding at \$125.00.

These remaining fees include reimbursement to Amy Baker for purchases at Casey's Pizza Hut in the amount 31.96.
