Mr. Komenda:

It has come to my attention that you have once again sought to malign me. As relayed to me, you, in your capacity as a reporter/Agent for the Northwest Herald, have published to third parties false statements that I billed Algonquin Township Road District for work related to the response I filed on 6/12/18. Yet you alleged that I had not completed nor filed on behalf of the Algonquin Township Road District that responsive pleading.
