**PLAINTIFFS’ RESPONSE TO MOTION TO MODIFY COURT ORDER**

- 1) The motion to modify a prior order of this court is advanced by Algonquin Township.

- 3) Algonquin Township has not been a party to this action at any time.
- 4) Algonquin Township is not a named Defendant in this cause.

- 9) The Motion to Modify Court Order is signed by counsel for counter-defendant, Charles Lutzow. Mr. Lutzow has no obligation to respond to Plaintiff's 4<sup>th</sup> Amended Complaint because he is not a named defendant to the 4<sup>th</sup> Amended Complaint.
- 10) Charles Lutzow has never been named as a Defendant.
- 11) The motion is advanced for no legitimate purpose and serves only to waste the court's time.

Wherefore, Plaintiffs Andrew Gasser, Algonquin Township Highway Commissioner, and the Algonquin Township Road District pray for the following relief:

- A) This court deny the relief sought in the Motion to Modify  
Court Order;

B) For such other and further relief this court deems just and equitable.

**MOTION TO MODIFY COURT ORDER**


