Thank you for the correspondence. In regards to Mr. Kraft's request, I responded with our ordinance and a draft ordinance (which I'm not even required to provide). He has asked for written correspondence and emails, texts with developers for a project that hasn't asked for a permit yet. I will have a wealth of correspondence (I'm quite sure) once an application has been received. I have and will continue to meet with prospective developers. Unless you tell me differently, any notes that I take in these meetings are mine alone. Any further conversations that may have taken place in regards to wind were between myself and an attorney which we had in developing an ordinance, and I am not required to divulge that information.

I'd like to assure the kind people at "Illinois Leaks" that they are welcome to correspondence as it is received, but I will continue to minimize any communications other than "face to face" because of this type of behavior. Thank you.
