



INFORMATION

Special Prosecutor Lorinda M. Lamken in the name and by the authority of the People of the State of Illinois, charges the defendant as follows:

COUNT I

On or about May of 2010, in Edgar County, Illinois, the defendant, JASON R. BALL committed the offense of UNAUTHORIZED BRINGING OF CONTRABAND INTO A PENAL INSTITUTION BY AN EMPLOYEE, in that said defendant, an employee of Edgar County Jail, knowingly and without authority of any person designated or authorized to grant such authority, brought an item of contraband, a computer, into Edgar County Jail, a penal institution, in violation of 720 ILCS 5/31A-1.2.(a)(1).

CLASS 1 FELONY (4-15 years Dept. of Corrections)

COUNT II

On or about March or April, 2010, in Edgar County, Illinois, the defendant, JASON R. BALL committed the offense of UNAUTHORIZED DELIVERY OF CONTRABAND IN A PENAL INSTITUTION BY AN EMPLOYEE, in that said defendant, an employee of Edgar County Jail, knowingly and without authority of any person designated or authorized to grant such authority, delivered an item of contraband, alcoholic liquor, to an inmate of the Edgar County Jail, a penal institution, in violation of 720 ILCS 5/31A-1.2.(c)(1).

CLASS 3 FELONY (2-5 years Dept. of Corrections)

COUNT III

On or about June 12, 2010, in Edgar County, Illinois, the defendant, JASON R. BALL committed the offense of UNAUTHORIZED DELIVERY OF CONTRABAND IN A PENAL INSTITUTION BY AN EMPLOYEE, in that said defendant, an employee of Edgar County Jail, knowingly and without authority of any person designated or authorized to grant such authority, delivered an item of contraband, alcoholic liquor, to an inmate of the Edgar County Jail, a penal institution, in violation of 720 ILCS 5/31A-1.2.(c)(1).

CLASS 3 FELONY (2-5 years Dept. of Corrections)
