Special Prosecutor Lorinda M. Lamken in the name and by the authority of the People of the State of Illinois, charges the defendant as follows:

COUNT I

On or about May or June, 2010, in Edgar County, Illinois, the defendant, KENT A. RHOADS committed the offense of UNAUTHORIZED BRINGING OF CONTRABAND INTO A PENAL INSTITUTION BY AN EMPLOYEE, in that said defendant, an employee of Edgar County Jail, knowingly and without authority of any person designated or authorized to grant such authority, brought an item of contraband, a computer, into Edgar County Jail, a penal institution, in violation of 720 ILCS 5/31A-1.2.(a)(1).

CLASS 1 FELONY (4-15 years Dept. of Corrections)

COUNT II

On or about April, 2010, in Edgar County, Illinois, the defendant, KENT A.
