
Operation Concerns at Edgar County Airport

- 1) Proof of liability insurance for your various private or commercial operations (to include lessons/instruction, banner towing, agricultural operations, charter service);and
- 2) Documentation listing Edgar County/Edgar County Airport as additional insured on certificates of insurance.

Failure to comply with this request will put your continued operation from the grounds of the Edgar County Airport in jeopardy.

Dear Mr. Wells:


I met with Rusty Bogue, President of RSB Aviation, Inc. and he has asked me to contact you regarding your letter to him dated June 28th. Initially, Mr. Bogue has asked that I point out that your letter erroneously indicates that he is operating a charter service. He advises that he is not operating a charter service (which is governed by 14CFR135). None of the aspects of his business activities include a charter service. His operations are governed by 14CFR91.

Mr. Bogue has spoken with others who are operating out of the Edgar County Airport and he is aware of no one else who has received a letter similar to that sent to him. We are wondering why you are singling him out for inquiries as to his insurance information and why are you asking for the proof of insurance? If such a requirement arises from a statute or regulation, please provide me with a copy of the same. You have requested documentation listing Edgar County/Edgar County Airport as additional insured on certificate of insurance. Please advise upon what basis this request is being made. Please provide me with copies of any contracts, statutes or regulations which require such coverage.

You concluded your letter by stating that if Mr. Bogue fails to comply with your request, it will put his continued operation from the grounds of the Edgar County Airport in jeopardy. Again, I ask that you provide me with copies of the contracts, statutes or regulations on which you rely making such a statement. If you are not making this same request to all of the other operators out of the Edgar County Airport, please advise why you are singling out Mr. Bogue and his businesses.

In summary, if you can provide clarification as to why you are making these requests and the basis upon which the requests are being made, it will assist Mr. Bogue as he completes his response to your letter.
