COMPLAINT FOR DECLATORY JUDGMENT, RELIEF BY MANDAMUS AND INJUNCTIVE RELIEF

NOW COME Plaintiffs, John Kraft and Kirk Allen, who pray that this court render a declatory judgment and grant relief by mandamus and grant injunctive relief under the Open Meetings Act (OMA), 5 ILCS 120/1, et seq. For this Complaint as follows:

- 1. Plaintiffs John Kraft and Kirk Allen. The Plaintiffs are residents of Illinois, the County of Edgar, and the Clark-Edgar Rural Water District (CERWD).
- 2. Defendants Edgar County Electoral Board (ECEB), a "public body" as that term is defined by 5 ILCS 120/1.02, August Griffin, in his official capacity as ECEB chairman, Mark Isaf, in his official capacity as ECEB member, and Karen Halloran, in her official capacity as ECEB member.
- 3. On January 11, 2013, the ECEB held an open public meeting. Public comments were disallowed during this meeting, even after requests were made from attendees for a public session to address the board. Pursuant to 5 ILCS 120/2.06 (g), any person shall be permitted an opportunity to address public officials during public meetings. Disallowing comments violated the letter and intent of this paragraph. A true and correct copy of the January 11, 2013 meeting agenda is attached hereto and incorporated herein as Exhibit A.
- 4. On January 23, 2013, the ECEB held an open public meeting. Public comments were disallowed during this meeting, even after requests were made from attendees for a public session to address the board. Pursuant to 5 ILCS 120/2.06 (g), any person shall be permitted an opportunity to address public officials during public meetings. Disallowing comments violated the letter and intent of this paragraph. A true and correct copy of the January 23, 2013 meeting agenda is attached hereto and incorporated herein as Exhibit B.
- 5. On January 25, 2013, the ECEB will hold an open public meeting.
 A true and correct copy of the January 25, 2013 meeting agenda is attached hereto and incorporated herein as Exhibit C.

COUNT ONE

(Violation of the Open Meetings Act, 5 ILCS 120/1, et seq.)

- 6. Plaintiffs reaffirm paragraphs 1-5 as though fully restated herein.
- 7. Plaintiffs have been irreparably harmed by Defendants' failure to allow any person to address public officials during the public meeting on January 11, 2013.
 - 8. Plaintiffs have no adequate remedy at law.

COUNT TWO

(Violation of the Open Meetings Act, 5 ILCS 120/1, et seq.)

- 6. Plaintiffs reaffirm paragraphs 1-5 as though fully restated herein.
- 7. Plaintiffs have been irreparably harmed by Defendants' failure to allow any person to address public officials during the public meeting on January 23, 2013.
 - 8. Plaintiffs have no adequate remedy at law.

COUNT THREE

(Violation of the Open Meetings Act, 5 ILCS 120/1, et seq.)

- 6. Plaintiffs reaffirm paragraphs 1-5 as though fully restated herein.
- 7. Plaintiffs have probable cause to believe they will be irreparably harmed by Defendants' failure to allow any person to address public officials during the public meeting to be held on January 25, 2013.
 - 8. Plaintiffs have no adequate remedy at law.

WHEREFORE, Plaintiffs pray that the Court:

A. Declare the Defendants to be in violation of the Open Meetings Act, 5 ILCS 120//1, et seq.; and,

- B. Grant a Relief by Mandamus by requiring that future ECEB meetings allow any person to address public officials during the public meeting; and,
 - C. Grant an injunction against future violations of the Open Meetings Act; and,
- D. Award Plaintiffs attorney's fees and other litigation costs reasonably incurred;
 and,
 - E. Order such other and further relief, as outlined in 5 ILCS 120/4.
