Ms. Clark,

I received partial information from the FOIA listed below.

Specifically, Item #8 was a request for the receipt/invoice that generated the \$1000.00 payment **from** the FIPHD. What I received was a repayment check made by a private nonprofit to the FIPHD and a copy of a promissory note. That is not what I was asking for. I want a copy of the bill, invoice or request from the foundation that triggered the payment from FIPHD **to** the foundation.

Also, item 9 you report you have don't have any receipts or invoices that match that vendor. In 2011 the FIPHD paid out over \$13,763.00 and you don't have any receipts or invoices to support what those payments were for? Receipts are the general accounting term commonly used so maybe you just didn't understand what I was looking for.

Do you have ANY records that would inform the public what those payments were for? Even if you don't have them in your possession, you are required to obtain them from any private company that you are doing business with as it is considered a public record.

I await your response on those matters.

In addition, I am also requesting the following.

1. A copy of all banking documents authorizing the FIPHD to operate as a lending institution as outlined in (205 ILCS 5/) Illinois Banking Act.
2. A copy of all rent payments and rental agreements for a private corporation (Ford-Iroquois Public Health Foundation) to operate their non-profit business from the FIPHD property for the last 2 years.
3. A copy of the board minutes authorizing the operation of a private company to operate from the public facility known as the FIPHD.

This request is not a commercial request and in accordance with the FOI Act of Illinois I am requesting a waiver for any charges or a reduction in charges as the information is in the public's interest and will be used to share with the public. Electronic copies are preferred whenever possible. Please note, if records are in electronic format you are required to provide them in that format.
