Be it ordained and resolved by the Board of Commissioners of the County of Clark that it be annexed into the Rides Mass Transit District on July 1, 2013.

As a county member of the Rides Mass Transit District, Clark County will have representation on the District Board according to the Local Mass Transit District Act (70 ILCS 3610) and the Rides Mass Transit District By-Laws, one Trustee to be appointed by the Chairperson of the County Board.

Further be it ordained and resolved that all assets received by the Clark County Treasurer upon the dissolution of the East Central Mass Transit District shall be transferred, assigned and conveyed by the County Treasurer to Rides Mass Transit District as the County's contribution to Rides Mass Transit District.

Further be it ordained and resolved that Rides Mass Transit District is herewith given immediate authority to apply for any and all Grants and Operating Assistance for public transportation services in the County for periods on and after July 1, 2013 the date of annexation of the County to Rides Mass Transit District.

The resolution shall be effective when adopted by an official vote of the Clark County Board and have an effective date when such resolution and ordinance is approved by 2/3 vote of the Rides Mass Transit District Board.
