Dear Ms. Clark, Mr. Corbett & Mr. Kirk:

The Public Access Bureau is not available to offer legal determinations on any specific situation except in the form of a determination letter written in response to a written Request for Review. However, our office does answer hotline inquiries in the form of general information about the statute and determinations we've issued previously.

This office has previously determined (8615, 9808) that where a requester has asked for information on a party name, the issuance of the party's city and zip code would readily allow for cross-referencing with phone books and property tax records for discovery of the street address and can therefore be properly redacted under section 7(1)(b). I don't know that we've ever opined on the redaction of the "state" information and whether the same would be true for that, much broader, geographical information.

Again, this is not a determination or indication as to how a Request for Review on your specific facts would be determined; it is merely general information on how we've decided related issues in the past.
