The purpose of this report is to open the case of KRISTOPHER E. MYLES.



#### NARRATIVE SECTION

On Wednesday, February 22, 2012, Zone 5 Investigations was contacted by Edgar County Sheriff Department Chief Deputy Steve Guess regarding the conduct of Edgar County Correctional Officer KRISTOPHER E. MYLES. In a February 21 interview conducted by Edgar County Deputy Greg Metcalf with Inmate KACIE KRABEL, she alleged MYLES grabbed her arm while she was out of her cell and told her he could get her XANAX while she was incarcerated in the jail, in exchange for sex. An inventory of inmate MADONNA SCHMITT'S XANAX prescription indicated of 90 pills, 85 where accounted for and 5 pills were missing. MYLES has access to inmate prescriptions including SCHMITT'S Xanax. Zone 5 will investigate MYLES for Official Misconduct.





The purpose of this report is to document the interview of MADONNA LYNNE SCHMITT.

On Friday, March 16, 2012 at approximately 9:50am, I, Sgt. Tim Drake #3978 and Edgar County Sheriff Department Chief Deputy Steven Guess met with MADONNA LYNNE SCHMITT in an interview room at the Edgar County Jail at 228 N. Central St. in Paris, Illinois. The purpose of the interview was to discuss SCHMITT'S role in an incident that occurred in the jail on February 9, 2012. SCHMITT is currently incarcerated at the jail is is due to be released April 29, 2012. I explained to SCHMITT this interview was strictly voluntary and that she did not have to talk to me. She stated she understood and wanted to cooperate. The following are results of that interview not verbatim.

SCHMITT stated she has been in the Edgar County jail since November 14, 2011. She is housed in the female section of the jail and was cellmates with BRANDY BARNES, DANA BUNTAINE, and KACIE KRABEL. SHE stated she was friends with KRABEL and "took care of her."

SCHMITT stated she receives medication at the jail that includes XANAX. She stated a nurse dispenses it for the week and it is given to her in accordance with her prescription by correctional officers. The C/O will watch her take it. She takes a XANAX in the morning and the evening.

SCHMITT stated she has trustee status at the jail and is allowed out of her cell to work. She could not recall the exact day, but stated she was out of her cell buffing floors in the hall near the Coke machine when she saw C/O KRIS MYLES bring KACIE KRABEL from the kitchen door to the stairs. KRABEL was wearing a T-shirt and blue pants. They both stood there and SCHMITT heard MYLES say "Let's go to the basement, there's no cameras there." SCHMITT stated MYLES was pushing her in that direction. KRABEL got upset and said she wanted to go back to her cell. She started to cry and MYLES took her back. SCHMITT walked back to the female cell and she heard KRABEL say to MYLES "give me some XANAX or I"II tell."

SCHMITT stated later that day, MYLES confronted her about the arrest of several other C/O's last year. SCHMITT told him she did not know anything about that. She also stated MYLES begged her not to say anything about the incident and as he was leaving the jail at the end of his shift he put his finger to his lips and she understood that to mean to be

quite. SCHMITT was confused about the time this incident occurred at first saying it was on the 3am to 3pm shift. Then a midnight to 8am shift. Finally, she stated it was while MYLES was working the 3pm to midnight shift on a Wednesday. She stated the incident in the hallway occurred about 10:30pm and MYLES put his finger to his lips as he was leaving at the end of his shift at 11:00pm or 12am.

SCHMITT stated she saw MYLES give KRABEL a small plastic cup at the cell "chuck-hole" about 11:00pm. She assumed it to be XANAX and she had heard KRABEL got some, but she did not know for sure.

SCHMITT stated she confronted KRABEL about the incident and KRABEL told her she took a couple of XANAX. SCHMITT stated the next day KRABEL told her MYLES wanted her to go down stairs to have sex. KRABEL also told her MYLES "better stay the fuck away or I'll beat him."

SCHMITT stated she saw MYLES one other day he worked, but she stayed away from him and had not seen him since. She has heard of no other instances of an incident like this.

The interview was concluded at 10:40am.

On 02-09-2012 at approximately 10:00am, I(Dep. Metcalf) had a conversation with C/O Sanders in reference to missing medication. Sanders stated that Madonna Schmitt told him, (Sanders) about what she overheard.

Sanders stated that Schmitt told him John Board was talking about Xanax's to C/O Myles. Sanders went on to state that Myles had Board out walking around and there was no information on the C/O log. Sanders also informed me that he had five Xanax pills missing from the medicine cabinet.

After my conversation with C/O Sanders, Sanders stated that he would inform Sheriff Motley.

On 02-10-2012 at approximately 11:50am, I conducted an interview with Schmitt. Schmitt stated that the incident occurred on Wed., 02-08-2012 at approximately 10:00pm. Schmitt stated they were making so much noise that they woke her up. Schmitt stated that Board was out of his cell and that Board was not to be out of his cell. Schmitt stated that Board was talking to Dana Buntain. Schmitt went on to stated that she overheard both Buntain and Board talking about Xanex and the crazy things they did while on it.

Schmitt stated that Board would walk back and forth from the bullpen to the women's cell and pass information. Schmitt also stated that Board had information on her and that the only person she told was Eddie Shelton. Shelton and Board are housed in two different areas of the jail.

On 02-10-2012 at approximately 4:00pm, I conducted an interview with T/C Collier. Collier stated that he seen Board in hallway via the surveillance monitors. On 02-13-2012 at approximately 4:00pm, I conducted an interview with T/C Cochran. Cochran stated he was in the kitchen and seen Board in the hallway.

On 02-20-2012 at approximately 11:05am, Deputy Chief Guess and I(Dep. Metcalf) conducted an interview with Wendy Nicoson. Nicoson was asked a question about Myles and his conduct. Nicoson stated that Myles would give Schmitt extra Zannex because Myles tried to pull Kacle Krabel into the basement. They would ask Myles for favors so they wouldn't tell.

On 02-20-2012 at approximately 11:30am, Chief Guess and I conducted an interview with Dana Buntain. Buntain stated that in the month of December of 2011 while she was taking a shower, Myles was at the entry door of the cell block watching her. Buntain stated that someone had to put a blanket on the entry door to block the window.

On 02-20-2012 at approximately 11:58am, Chief Guess and I conducted an interview with Madonna Schmitt. Schmitt stated that she witnessed Myles watching Buntain taking a shower. Schmitt stated that this happened a couple of months ago. Schmitt also stated that Myles took her to the booking room and asked her if she was a snitch because of Rhoads and Ball.

On 02-20-2012 at approximately 1:00pm, Chief Guess and I conducted an interview with John Board. Board stated that he got a letter from Krabel talking about Myles and some of his actions. Board stated that from the letter Myles offered Krabel Zannex for sex. Board also stated that Myles let him out of the cell a couple times. One time was for about an hour and a half and the second time was for about ten to fifteen minutes. Board went on to state that Myles let Krabel out of the cell to help Schmitt.

On 02-21-2012 at approximately 10:38am, I conducted an interview with Kacie Krabel at her residence located at II. Her telephone number is Krabel stated that she was helping Schmitt with the floors by the Coke machines. Krabel stated that Myles came up to her and asked her what would you do for some Zannex. Krabel stated that Myles grabbed her arm and tried to take her upstairs. Krabel stated that Myles told her there is lots of places they could go to. Krabel stated that she broke away from Myles and tried to go

back to her cell. Krabel stated that Myles grabbed her arm a second time and told her that he was just kidding and not to tell on him.

On 2-9-2012 at approximately 10:00 a.m. I C\O Sanders got Madonna Schmitt out to work. She pulled me aside and stated that she overheard John Board talking about Xannex's and she stated that she heard C\O Myles and John talking about them.

C\O Myles got Johnathan Board out for some reason, and Madonna stated that he got John out to work. Which is not supposed to happen. She also stated that John was conveying messages between the lower cell block and the female side of the new cell block.

I C\O Sanders then counted Madonna's Xannex's in the medicine cabinet which is located on the south wall of the booking room, which is kept locked. The only one that has access to the keys is the C\O's. She had in her bottle 22 pills and 13 in her daily medicine boxes. I then figured up how many she had taken which were 50 pills. She had #90 pills come in on the 24<sup>th</sup> of January. I have accounted for 85 pills, as far as I can see, there are 5 pills not accounted for.

C\O Myles did not log that Johnathan Board was out of the cell block.

There were: 22 in the Bottle

13 in the daily med box 50 were taken from the 24<sup>th</sup> of January till 9<sup>th</sup> of February Total 85 accounted for out of 90 pills

On Wednesday, April 4, 2012 at approximately 4:00pm I, Sgt. Tim Drake #3978 met with LPN RUTH E. BOTTOM in an interview room at the Paris Police Department. BOTTOM has been the Nurse for the Edgar County Sheriff's Department for 7 years and is in charge of the receiving and distribution of medication at the jail.

BOTTOM stated she has been an LPN since 2000 and works full time at SARA BUSH Hospital. She was contracted through ECSO to distributed medication to inmates of the jail. She explained she will visit the facility twice a week, usually Monday and Thursday. Pearman's Pharmacy will deliver medication to the facility where it is locked up in a cabinet in the book-in room. She will arrive on Monday and organize all inmate medication in a weekly pill box with their name on it. The Correctional Officers will dispense the medication according to the inmates prescription and make a notation on a log that indicates that the medication was given.

BOTTOM stated she knew MADONNA SCHMITT was taking XANAX and remembered that as she had been filling her weekly pill box it looked like she did not have enough remaining pills to reach the end of the month.

She stated she met with ECSO C/O Jaime Sanders #302 and they determined 5 XANAX pills were not accounted for. BOTTOM could not recall when this count was done and stated she recalled the unaccounted amount was 6 pills (Report Attached).

BOTTOM stated that if a pill is lost usually a note is left for her. She stated all C/O's have keys for the medical cabinet and this type of incident involving missing medication had never happened in her 7 years at the jail.

On 2-9-2012 at approximately 10:00 a.m. I C\O Sanders got Madonna Schmitt out to work. She pulled me aside and stated that she overheard John Board talking about Xannex's and she stated that she heard C\O Myles and John talking about them.

C\O Myles got Johnathan Board out for some reason, and Madonna stated that he got John out to work. Which is not supposed to happen. She also stated that John was conveying messages between the lower cell block and the female side of the new cell block.

I C\O Sanders then counted Madonna's Xannex's in the medicine cabinet which is located on the south wall of the booking room, which is kept locked. The only one that has access to the keys is the C\O's. She had in her bottle 22 pills and 13 in her daily medicine boxes. I then figured up how many she had taken which were 50 pills. She had #90 pills come in on the 24<sup>th</sup> of January. I have accounted for 85 pills, as far as I can see, there are 5 pills not accounted for.

C\O Myles did not log that Johnathan Board was out of the cell block.

There were: 22 in the Bottle

13 in the daily med box 50 were taken from the 24<sup>th</sup> of January till 9<sup>th</sup> of February Total 85 accounted for out of 90 pills

The purpose of this report is to document the interview of DANA A. BUNTAIN, W/F, DOB:

## DETAILS:

On Thursday, June 21, 2012, at approximately 1:45 p.m., Edgar County Chief Deputy S. Guess and I (Special Agent K. Cessna) interviewed DANA A. BUNTAIN on the porch of her residence which is located BUNTAIN agreed to speak with us. The following is a synopsis of BUNTAIN'S interview and should not be considered verbatim unless otherwise noted.

BUNTAIN was incarcerated in the Edgar County Jail from February 06,2012 to March 03, 2012. On February 08, 2012, BUNTAIN was incarcerated with inmates MADONNA SCHMITT, WENDY NICOSEN, TAMMY JOHNSON, CARI HAMM, and KACIE KRABEL. It is unknown however exactly what cells the females were incarcerated in, and it is possible each female either had their own cell or shared a cell with other females.

I asked BUNTAIN if she knew why we were speaking with her today. She told us she thought it was probably about the "KRIS" guy. I asked BUNTAIN who "KRIS" was and she told us he was a correctional officer at the Edgar County Jail. Although BUNTAIN did not witness anything first hand, she reported the following. BUNTAIN saw KACIE KRABEL when she was returned to the cell block. BUNTAIN described KRABEL as "being upset". BUNTAIN did not know the exact reason why KRABEL was upset but BUNTAIN heard that KRIS had asked KRABEL to do something with him. When asked exactly what this was, BUNTAIN told us she did not know, because this had happened in the other room.

BUNTAIN heard KRIS was trying to get KRABEL into the basement. BUNTAIN also heard KRABEL say something about "leading KRIS on" or something to that effect. BUNTAIN thought KRIS was involved in some sort of relationship with not only KRABEL but also "DONNA" (MADONNA SCHMITT). BUNTAIN does not know if KRABEL and KRIS were involved in any type of sexual relationship. BUNTAIN never witnessed anything between KRABEL and KRIS.



BUNTAIN just heard KRIS had taken KRABEL to the basement and then she heard KRABEL had threatened to tell on KRIS and she (KRABEL) was basically holding whatever over KRIS' head unless he gave her (KRABEL) Xanax. KRIS never gave BUNTAIN any Xanax. BUNTAIN reported that when KRIS came to the female cell block, KRABEL would not even look at him. When KRIS would walk away, KRABEL would make comments that he was "lucky" and KRABEL made it sound like she had a lot on KRIS. BUNTAIN reported that KRIS was the only correctional officer to come back there. She couldn't say for sure who all was incarcerated with her at the time she was in Edgar County but she knew of KRABEL and MADONNA SCHMITT for sure. BUNTAIN told us KRIS gave her a "creepy" vibe but KRIS never did anything inappropriate with BUNTAIN and BUNTAIN never witnessed anything inappropriate between KRABEL and KRIS. At approximatley 1:55 p.m. the interview ended.

The purpose of this report is to document the interview of KACIE A. KRABEL, W/F, DOB:

## DETAILS:

On Friday, July 20, 2012, at approximately 9:10 a.m., Tpr. Derek Weston and I (Special Agent K. Cessna) interviewed KACIE A. KRABEL outside her residence located at KRABEL woluntarily agreed to speak with us. The following is a synopsis of KRABEL'S interview and should not be considered verbatim unless otherwise noted.

KRABEL was incarcerated in the Edgar County Jail from December 18, 2011 to February 16, 2012. KRABEL was incarcerated in the jail for Possession of Methamphetamine Manufacturing Material. In early February 2012, KRABEL was outside of her cell sitting on the steps by the "bullpen" with Edgar County Inmate "Donna" (MADONNA SCHMITT). SCHMITT was a trustee so SCHMITT was routinely out of her cell performing different tasks which include doing the laundry and mopping the floors. On this particular night, SCHMITT was mopping the floors by the Coke machine. It was not uncommon for the correctional officer to let KRABEL out of her cell even though she was not a trustee. KRABEL told us the correctional officer who would let her out of her cell to visit with SCHMITT was a guy she knew as "KRIS". KRABEL described KRIS as a white male with dark short hair possibly around 30 years of age. KRIS was married and KRABEL knew this because KRIS would often talk about his wife, however, KRIS would remove his wedding ring while he was working.

As KRABEL was sitting on the steps talking with SCHMITT, KRIS approached and said something to KRABEL like he knew where they could go where nobody would see them. I asked KRABEL what she thought KRIS met by that and she responded I know exactly what he meant because he said "I want to fuck you, I really want to fuck you now." After hearing this, KRABEL told KRIS he must have her confused with someone else because she was in jail for methamphetamine and not for prostitution. KRIS did offer to give KRABEL some "xanies" but KRABEL told him she did not want any Xanax and she was not going to have sex with him. KRABEL starting walking back towards her cell and KRIS stopped her by grabbing her arm. Again KRABEL told KRIS she was not having sex with him and that he needed to let KRABEL back into her cell. KRABEL stood at the cell door for a few seconds but then eventually KRIS did let KRABEL back into the cell. Although not positive on the time, KRABEL thought this happened after 5 pm because KRIS normally worked the late night shift.

After this incident, KRABEL stopped talking to KRIS, and in fact she said this entire incident made her feel scared and she was kind of afraid of KRIS. KRABEL told us she felt as if she put herself in that situation because she should not have went out to visit with SCHMITT. While incarcerated, KRABEL would often see KRIS standing in the "chuck holes" and looking in the cell windows. Although not positive, KRABEL thought KRIS stood there and watched SCHMITT take a shower. Besides SCHMITT, KRABEL was incarcerated with a girl possibly named KRISTY PROUSE and a lady named DEBBIE. KRABEL also told us a lady by the name of "Big Beth" was also incarcerated with her, but Beth was released prior to KRABEL being released. BETH has been identified as ELIZABETH ALBERS. KRABEL told us she had heard a rumor that KRIS and ALBERS had sex, however, this was after ALBERS was released. KRIS was alleged to have taken ALBERS to breakfast, and then had sex with ALBERS. While incarcerated, KRABEL did hear KRIS tell ALBERS "I want to titty fuck you."

When asked if anybody else may have heard any of these comments KRABEL said there was a temporary worker that was a female that was in either painting or cleaning and there was also an intern. KRABEL thought the intern's name may have been KRISTEN, however, the intern has been identified as MELINDA DEER. KRABEL advised she never flirted with KRIS and she never made any comments to him to make him think she was interested in him. KRABEL couldn't specifically remember but thought KRIS would always wear his correctional officer uniform to work, and she thought KRIS was wearing his uniform the night he asked KRABEL to have sex with him.



KRABEL never received any Xanax from KRIS but she did hear there were some Xanax missing. KRABEL knew that SCHMITT had a prescription for Xanax and that after a pill count SCHMITT has some Xanax that were missing. KRABEL thought there was in excess of 20 pills missing. KRABEL has not seen or talked to KRIS since she has been released. KRABEL told us if she saw KRIS she would probably "punch him in the face." After this incident KRABEL did not know what to do and so she authored a letter to JOHNNY BOARD telling him what had happened to her while incarcerated. KRABEL told us she felt that KRIS was very unprofessional in the way he acted and he displayed this because KRIS was always making "very sexual" comments and KRABEL thinks of him as "perverted" and "horrible". At approximately 9:25 a.m. the interview ended.

The purpose of this report is to document the interview of Courtney R. Swinford, W/F, DOB who stated she had no knowledge of Mr. Myles or the allegations made against him.

## **DETAILS:**

On Monday, July 23, 2012, at approximately 12:00 p.m., Special Agent Kim Cessna and I (Trooper Weston) interviewed COURTNEY R. SWINFORD while she was incarcerated in the Edgar County Jail. SWINFORD voluntarily agreed to speak with us. The following is a synopsis of SWINFORD'S interview and should not be considered verbatim unless otherwise noted.

In August 2011, SWINFORD was incarcerated in the Edgar County Jail with inmates AMANDA STACY and LORA EBLER. It is unknown however exactly what cells the females were incarcerated in, and it is possible each either had their own cell or shared a cell with other females.

I asked SWINFORD if she could remember who the correctional officers were at the jail in Aug. 2011. SWINFORD stated she knew Jamie, Clayton, Steve and Judy. SWINFORD could not remember the names of any other correctional officers. I further asked SWINFORD if any of the jailers ever asked for her phone number or asked to see her at the jail or outside the jail. SWINFORD said no jailer ever asked for her phone number or to spend any time with her nor did she ever notice anything abnormal. SWINFORD did think some of the correctional officers were cute but it was just a thought in her head.

I asked SWINFORD if she could remember anyone else working at the jail. SWINFORD replied there was one other guy who was balding, in his late 20's or early 30's but she could not remember his name but he talked to the other girls a lot. At approximately 12:05 p.m. the interview ended.

On Monday, July 23, 2012, at approximately 10:55a.m., Special Agent Kim Cessna and I (Trooper Weston) interviewed AMANDA LYNN STACY while she was incarcerated in the Edgar County Jail. STACY voluntarily agreed to speak with us. The following is a synopsis of STACY'S interview and should not be considered verbatim unless otherwise noted.

STACY was incarcerated in the Edgar County Jail in August 2011 with inmates COURTNEY SWINFORD, LORA EBLER, CATHY MORRIS and BRITTANY unknown last name. It is unknown however exactly what cells the females were incarcerated in, and it is possible each female either had their own cell or shared a cell with other females.

I asked STACY if she could remember the correctional officers that worked in August 2011. STACY replied "well the KRIS guy was working". I asked STACY to tell me about Kris and if he ever asked her for any favors. STACY stated that KRIS asked her to do sexual things to him for commissary items. I asked STACY if she did any sexual favors for KRIS. STACY stated "yes, just once" while KRIS was working as a jailer wearing his uniform. STACY further advised that she "just jacked him (KRIS off once ". The incident took place in the room down the hall where there were four individual cells that each have there own chuckhole that is separate from the main cell door. After the incident STACY advised that KRIS gave her a bag of corn or regular chips from the commissary.

STACY stated that she was the only girl that she knew of that had any involvement with KRIS during the time that she was incarcerated. STACY further stated that she felt bad about the incident and had no more contact with KRIS during the rest of her time in jail. I asked STACY if KRIS ever tried to contact her once she was out of jail. STACY stated that early in 2012 he called her and asked her to meet him up at the truck stop in Danville out by the state line near the prison. STACY advised she did not give KRIS her phone number that he must have gotten it from the booking information form. STACY further advised that she did not attempt to reconnect with KRIS at the truck stop or anytime since she has been out of jail.

STACY described KRIS as a white male, balding no glasses that wore his jailer or correctional officer uniform most of the time. I asked STACY if she ever received any Xanax from KRIS or if any of the other female inmates had gotten any Xanax. STACY advised she never took any nor was she ever given

EBLER voluntarily agreed to speak with us. The following is a synopsis of EBLER'S interview and should not be considered verbatim unless otherwise noted.

EBLER was incarcerated in the Edgar County Jail from August 01, 2011 to August 27, 2011. EBLER was incarcerated with inmates AMANDA STACY, COURTNEY SWINFORD, CATHY MORRIS and BRITTANY unknown last name. It is unknown however exactly what cells the females were incarcerated in, and it is possible each female either had their own cell or shared a cell with other females.

I asked EBLER if she could remember who the correctional officers were at the jail in August 2011. EBLER stated she knew Clayton, Jamie, Ray, Judy and a Kris "bald headed guy" who worked a lot and seemed nice "real friendly".

EBLER further stated that Clayton would get items for the inmates quickly and was "real friendly" but she did not pay too much attention to him. EBLER advised that Kris was an "on the ball, good jailer" who would always get the inmates their stuff quickly. EBLER stated that Kris was really nice but she did not notice anything out of the ordinary about him.

I asked EBLER if any of the jailers approached her attempting to interact with her away from the other inmates or if she exchanged phone numbers with any of them. EBLER advised that she had no interaction with the jailers nor did any of them ask for her phone number.

EBLER stated there was an incident with AMANDA STACY where the older jailer "Kris" startled STACY as she was exiting the shower area and STACY'S towel almost fell to the ground.

I asked EBLER if she ever received any Xanax from Kris or if any of the other female inmates had gotten any Xanax. EBLER advised she never took any nor was she ever offered Xanax for anything. EBLER did not know if any of the other inmates received any Xanax. At approximately 1:20 p.m. the interview ended.

## DETAILS:



On Thursday, August 16, 2012, at approximately 10:50 a.m., Edgar County Sheriff's Department Chief Deputy S. Guess and I (S/A K. Cessna) interviewed MELINDA K. DERR in an interview room located inside the Edgar County Jail. DERR voluntarily agreed to speak with us. The following is a synopsis of DERR'S interview and should not be considered verbatim unless otherwise noted.

DERR was an intern with the Edgar County Sheriff's Department in 2012. As part of her internship, DERR assumed the duties of an Edgar County Correctional Officer. DERR started her internship in January 2012, and worked until February 05, 2012 when she had to leave for a short time for gall bladder surgery. DERR returned from her surgery in March 2012, and completed her internship in April 2012. DERR currently works at T.R.W. in Marshall, IL.

During her internship DERR primarily worked days on Mondays and evenings on Wednesdays and she would sometimes work the weekends. I asked DERR if while she was an intern she had any interaction with Edgar County Correctional Officer KRISTOPHER MYLES. DERR told us she did not work with MYLES on a regular basis and she thought she only had worked with MYLES on two separate occasions.

The times she did work with MYLES, DERR remembers MYLES talking about having marital problems. DERR reported MYLES never said anything inappropriate to her. DERR remembers the names of a couple of the inmates who were incarcerated in Edgar County during her internship. The female inmates that DERR rembers was MADONNA PROUSE (SCHMITT) and KACIE KRABEL. It was from one of the female inmates that DERR heard talking and they said MYLES allegedly said something to one of the inmates. DERR didn't think she heard this from PROUSE or KRABEL and thought she may have heard it from an inmate with the first name of WENDY, possibly WENDY NICOSON. Again DERR never personally observed MYLES do anything inapprorpiate.

DERR told us she could "sense" something was going on at the jail and she remembers asking another correctional officer what was going on. DERR was never provided with any specific details but she told us she could "sense" that something was going on. DERR added she thought MYLES was "very immature" with females. DERR told us she thought MYLES would "flirt" with another employee who was painting at the jail. DERR didn't know her last name but knew her first name was MICHELLE, (MICHELLE CLOUSE). DERR didn't have anything else to add and at approximately 11:00 a.m the interview ended.

The purpose of this report is to document the interview of ELIZABETH A. ALBERS, W/F, DOB:

# **DETAILS:**

On Monday, July 23, 2012 at approximately 9:50 a.m. Special Agent Kim Cessna and I (Trooper Weston) interviewed ELIZABETH A. ALBERS at the Edgar County Jail. ALBERS voluntarily met and agreed to talk to us. The following is a synopsis of ALBER'S interview and should not be considered verbatim unless otherwise noted.

ALBERS was incarcerated in the Edgar County Jail from October 26, 2011 to December 01, 2011. After ALBERS was released from Edgar County she still continued to visit the jail to see her boyfriend Adam Whordell as well as her mother Carol Collier.

I asked ALBERS if she had interacted with the correctional officers that worked at the jail. ALBERS stated "you are here to ask me about KRIS that works here at Edgar County and the Danville Prison". ALBERS further stated KRIS was the only one she knew of that talked a lot with her and the other female inmates. ALBERS did state the other correctional officers CLAYTON and JAMIE were nice guys, easy to get along with and most of the time they worked by themselves and always in uniform. ALBERS described KRIS as W/M, tall in his 30's, balding and was married. ALBERS advised KRIS removed his wedding ring when working. ALBERS stated KRIS worked at the Edgar County Jail with the previous jailers (Rhodes and Ball) who had gotten into trouble for having sex with a female inmate. ALBERS advised to her knowledge KRIS never had sex or anything related to sex with any female inmate. ALBERS further advised KRIS told her RHODES and BALL did a" stupid thing".

After ALBERS was released from the Edgar County Jail in December 2011, she continued to visit both her mom and her mom's fiancée Chris Kennedy while they were still incarcerated. On one occasion KENNEDY told KRIS that ALBERS needed a good man in her life. KRIS advised KENNEDY that he would take ALBERS to breakfast see how things go.

Approximately the second or third week in December, ALBERS agreed to meet KRIS at BJs restaurant located just north of the Edgar County Jail by the railroad tracks for breakfast. While at breakfast ALBERS stated she and KRIS sat next to each other in the same booth like boyfriend and girlfriend and KRIS placed his hand on her thigh.

After breakfast, KRIS wanted to show her his house and they left in his silver extended cab truck that had a console in the middle. ALBERS described the route they traveled as follows, they headed east out towards the Clinton road, then drove pass a white building on the left possibly a church before turning

right into what looked to by a "ritzy neighborhood" just before the golf course. Once at the house ALBERS advised KRIS parked the truck in the garage. ALBERS described the house in detail stating it was a "richey" house with a 2 car garage and a picture window in front with a star on the siding. The house had 2 or 3 bedrooms, a 15ft. by 10ft. garden tub, a formal dining room, a large living room to the left of the kitchen and the kids rooms were on the right side as you walk down the hallway.

ALBERS advised KRIS took her into his bedroom which had a large walk in closet. While in the bedroom KRIS propositioned ALBERS to have sex with him. KRIS remarked he and his wife were having ongoing problems because she did not want to have sex with him. KRIS told ALBERS it had been six months since he and his wife had engaged in sex. KRIS informed ALBERS if they were to have sex, the sex could be a reoccurring event if she was interested. ALBERS denied having sex with KRIS but later admitted to giving KRIS oral sex in the bed room. ALBERS advised the oral sex by her was all that occurred. ALBERS stated it was only one time and she was committed to her boyfriend Adam Whordell.

KRIS attempted to reconnect with her in Febuary of 2012 by asking her mom (CAROL COLLIER) who was still incarcerated at the Edgar County Jail for ALBERS cell phone number. ALBERS advised KRIS wanted to meet at the Edgar Co. Bank before his shift started. ALBERS never went to the bank to meet with KRIS because she had no transportation to get to the bank. ALBERS has not had any further contact with him since the day at KRIS'S house.

I asked ALBERS is she ever received any Xanax from KRIS or if any of the other female inmates had gotten any Xanax. ALBERS advised she never took any nor was she ever given Xanax. ALBERS stated she knew the Xanax was getting smuggled into the Edgar County Jail through "Fixodent" by other female inmates but she did not know which females were doing the smuggling. At approximately 10:30 a. m. the interview ended.

On Wednesday, February 22, 2012, Zone 5 Investigations was contacted by Edgar County Sheriff Department Chief Deputy Steve Guess regarding the conduct of Edgar County Correctional Officer KRISTOPHER E. MYLES. In a February 21 interview conducted by Edgar County Deputy Greg Metcalf with Inmate KACIE KRABEL, she alleged MYLES grabbed her arm while she was out of her cell and told her he could get her XANAX while she was incarcerated in the jail, in exchange for sex. An inventory of inmate MADONNA SCHMITT'S XANAX prescription indicated of 90 pills, 85 where accounted for and 5 pills were missing. MYLES has access to inmate prescriptions including SCHMITT'S Xanax. Zone 5 will investigate MYLES for Official Misconduct.

The purpose of this report is to document the interview of MICHELLE M. CLOUSE, W/F,

## DETAILS:

On Monday, August 20, 2012, at approximately 2:00 p.m., Edgar County Sheriff's Department Chief Deputy S. Guess and I (S/A Cessna) interviewed MICHELLE M. CLOUSE, in an interview room located inside the Edgar County Jail. CLOUSE



voluntarily agreed to speak with us. the following is a synopsis of CLOUSE'S interview and should not be considered verbatim unless otherwise noted.

CLOUSE is employed with Edgar County and as part of her duties she works both at the jail as well as the courthouse. CLOUSE also picks up meals in Vigo County, IN. and delivers them back to Edgar County. In October 2011, CLOUSE started painting at the county jail. CLOUSE thought it took her until March 2012 to finish all of the painting. While at the jail, CLOUSE personally did not see Edgar County Correctional Officer KRISTOPHER MYLES interact inappropriately with any female inmate. CLOUSE did say that MYLES would say things they she felt were "inappropriate." CLOUSE was not always in the same room as MYLES and told us she often was in a different part of the building painting.

CLOUSE heard from one of the female inmates, specifically, MADONNA PROUSE (SCHMITT) that inmate BETH (ELIZABETH ALBERS) "flashed" her breasts at MYLES. When ALBERS was released from custody she (ALBERS) and MYLES "ended up" together at MYLES' house. ALBERS was not incarcerated when she and MYLES allegedly "hooked up."

CLOUSE never witnessed MYLES do anything with the inmates, however, she said MYLES "struck her" as the type of person that would do something inappropriate. CLOUSE was rarely with the female inmates because she was busy painting the building. CLOUSE described MYLES as a white male with short black hair. She did not believe MYLES wore glasses.

CLOUSE told us about a text message she received from MYLES. At one time, CLOUSE was employed at 6th Avenue, which she explained as being a topless bar. MYLES knew about CLOUSE'S previous employment. CLOUSE received a text message from MYLES that said something like "you can come strip for me if you want." CLOUSE sent a message back saying "LOL." CLOUSE never gave MYLES her cell phone number and assumed MYLES obtained her phone number from the board. Since CLOUSE was working at the jail, her phone number was posting on a board in case folks needed to call her for work purposes. CLOUSE was a little angry that MYLES obtained her phone number this way and did not think that was appropriate. CLOUSE never had any other phone contact with MYLES and she never asked MYLES about the message.

CLOUSE heard MYLES was being "investigated over the whole pill thing." When asked CLOUSE told us she heard there were some prescription pills that came up missing. This did not involve CLOUSE and she only heard this because she heard two other correctional officers (JAMIE and RUTH) talking. RUTH did ask CLOUSE if she (CLOUSE) knew anybody that had access to where the prescriptions were kept. CLOUSE told RUTH she (CLOUSE) did not nor did she know of anybody that had access to where the prescriptions are kept. Regarding the prescription pills, CLOUSE heard RUTH was counting pills and there were some prescription pills that came up missing. CLOUSE did not know who she heard this from. At approximately 2:40 p.m. the interview ended.

On Wednesday, February 22, 2012, Zone 5 Investigations was contacted by Edgar County Sheriff Department Chief Deputy Steve Guess regarding the conduct of Edgar County Correctional Officer KRISTOPHER E. MYLES. In a February 21 interview conducted by Edgar County Deputy Greg Metcalf with Inmate KACIE KRABEL, she alleged MYLES grabbed her arm while she was out of her cell and told her he could get her XANAX while she was incarcerated in the jail, in exchange for sex. An inventory of inmate MADONNA SCHMITT'S XANAX prescription indicated of 90 pills, 85 where accounted for and 5 pills were missing. MYLES has access to inmate prescriptions including SCHMITT'S Xanax. Zone 5 will investigate MYLES for Official Misconduct.

## The purpose of this report is to document the interview of KRISTOPHER E. MYLES, M/W, DOB:

It should be noted I spoke via telephone with MYLES on Thursday, August 16,2012 in an attempt to set up an interview. MYLES asked if he needed an attorney to be present when I spoke with him. I asked MYLES if there was an attorney he used on a regular basis and MYLES told me "the state's attorney". I asked MYLES who he was talking about and he told me in the past he has been represented by Edgar County State's Attorney M. Isaf. I told MYLES when we met, I would tell him about the allegations and then he could make a decision if he wanted to speak with me without an attorney.

## DETAILS:

On Monday, August 20,2012, at approximately 2:00 p.m., Edgar County Sheriff's Department Chief Deputy S. Guess and I (S/A K. Cessna) met with KRISTOPHER E. MYLES at the Paris Police Department Investigations Office located on Highland Court in Paris, IL. Prior to the start of the interview, MYLES was told he was free to leave and was not under arrest. MYLES voluntarily agreed to meet with us and to have his interview audio taped. The following is a synopsis of MYLES' interview and should not be considered verbatim unless otherwise noted.

MYLES is currently employed with the Illinois Department of Corrections as a prison guard in Danville, IL. MYLES has worked at IDOC for approximately 12 years. MYLES also worked as a correctional officer in Edgar County, IL, however, MYLES could not recall when he started working in Edgar County and advised it has been almost a year since he has worked in Edgar County. I advised MYLES I was only investigating allegations that were made in Edgar County. I asked MYLES if there was any reason why someone would make allegations against him, and MYLES told me although he doesn't know the specific allegations, he does not know why someone would make allegations against him.

MYLES told me he has only heard "rumors" as to what was going on. Those rumors were that MYLES while working at the Edgar County Jail gave inmates the wrong medications. This was the only rumor MYLES had heard and he does not know of any other allegation. I asked MYLES if he ever took an inmate or former inmate out to breakfast and then back to his residence. MYLES told us he never took an inmate out to breakfast, nor did he ever take inmates or former



inmates back to his house. When asked why someone would make these allegations, MYLES replied he had "no clue". I asked MYLES if at any time while he was working as a correctional officer in Edgar County if he asked an inmate for anything sexual in nature and he said "no ma'am". I asked MYLES why someone would admit to performing a sex act on him and MYLES called them a "liar". MYLES told us obviously all of the victims in this case were lying because there was no way he was going to jeopardize his job for any sexual favors or anything like that.

MYLES did say he remembers during a visitation there was a female inmate showing her breasts to another female inmate during the visit. At the end of the visit, MYLES told the inmate that kind of behavior was not going to be tolerated and if it continued he would report her and she would probably lose her visitation rights. MYLES said the female inmate was "Beth" (ELIZABETH ALBERS). While BETH was incarcerated her boyfriend (ADAM WHORDELL) was also incarcerated. BETH'S mother's boyfriend (CHRIS KENNEDY) was the one who BETH was showing her breasts to during visitation. MYLES reported KENNEDY had said something to MYLES about getting MYLES "hooked up" and MYLES told KENNEDY nothing happened nor was anything going to happen.

Again MYLES denied ever taking any inmate or former inmate to breakfast and then back to his residence. He explained he was also working a side construction job so he would get off of work at the prison at 7 am and then work construction from 8:30 a.m. until about 10:30 a.m. until he had to pick up his daughter. MYLES would then bring his daughter back to the site with him and continue working until about noon or 1 pm. I never mentioned a time frame these allegations were alleged to have taken place, so it is unclear how MYLES knew he was working construction at this time.

I asked MYLES if there was any truth to the rumor in exchange for a sexual favor he would give the inmates Xanax. MYLES said these allegations came from MADONNA SCHMITT and KACIE KRABEL. SCHMITT was a trustee at the jail and MYLES would let KRABEL out of the cell to help SCHMITT with chores. MYLES was told he could not longer let KRABEL out of the cell in addition to SCHMITT and so according to MYLES, KRABEL and SCHMITT made allegations against him. MYLES explained KRABEL "went crazy" when she found out she could no longer be out of the cell. MYLES told KRABEL he could not let her out and he was not going to lose his job for her. Regarding the pills, SCHMITT did take prescription medication. There were days SCHMITT told MYLES she did not receive her medication and so MYLES would go and get SCHMITT'S medication and give it to her. There were 3 days in a row MYLES remembers getting pills for SCHMITT. MYLES said there was no procedure for giving medication at the jail, and the jailers did not watch the inmates take the prescription medication. It is possible SCHMITT handed out her medication once she was given it.

I asked MYLES if there was any truth to the rumor he would stand and watch inmates shower and MYLES said "no ma'am". MYLES told me everything was on camera at the jail and he didn't even watch his wife take a shower. MYLES denies telling an inmate he knew where to go where they would not be captured on camera. MYLES said he did not play those games. Again I asked MYLES why people would make those allegations against him and he told me maybe it was to get even with him because MYLES would not allow them to do things, and maybe there is an issue with the other two guards that got "hooked up". MYLES again told us he was not going to do anything that would cause him to lose his state job. When I asked MYLES to specify what he meant by things he again told the story about SCHMITT and KRABEL and KRABEL was mad because MYLES would no longer let her out to help SCHMITT with chores. MYLES was told he couldn't let KRABEL out of the cell anymore by jail administrator JAMIE.

I asked MYLES if there was any truth to the rumor he received oral sex from an inmate in exchange for commissary and MYLES said "negative." MYLES also denied offering any inmate Xanax in exchange for the inmates keeping quiet. I asked MYLES if he thought it was odd he had not been working at the Edgar County Jail. MYLES told us he just figured they no longer needed his help.

I asked MYLES if he would be willing to submit to a polygraph test, to which he replied he would. I asked MYLES how he thought he would do on that test and he advised he would pass it because he was not guilty of this. I asked MYLES if



he had any questions or if there was anything he forgot to ask me. He told me again he was "innocent" and did nothing wrong and he had done nothing that would have jeopardized his job at the county. He admitted he would "joke" and carry on with other employees and sometimes even other inmates, but by no means did he ever take anything to a sexual level. He said he was innocent and he did not like being accused of things he did not do. At approximately 2:15 p.m. the interview ended.

The audio of MYLES' interview was downloaded onto a CD. The CD has been placed into the case file for retention.

It should be noted I received a phone call from MYLES later in the day. MYLES told me he had informed his boss at the prison in Danville about the allegations made against him. MYLES told me he had nothing to hide and wanted to let his employer know so as not to cause any kind of trouble for him down the road.


I will not be filing any charges in this case and am closing my file. Please do not hesitate to contact me if you should have any questions about this letter.
