Thank you for writing to the Coles County Sheriff's Office with your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.

On Wednesday, November 13, 2013, you requested the following documents:

1. Copy of all credit card statements for the last 12 months for all credit cards under the management / control of the Sheriff's Office.
2. Copy of all documents pertaining to disciplinary action taken against Darrel Cox in his capacity as a deputy with the Coles County Sheriff's Office to include any suspensions and / or other action.
3. Copy of the transaction history for all Sheriff's Office accounts for the last 2 years.
4. Total number of DUI arrests made by the Coles County Sheriff's Office in the last 2 years.
5. Copy of current union contract for deputies of the Coles County Sheriff's Office.
6. Copy of any personnel policy currently in place for the Coles County Sheriff's Office.
7. Copy of any records pertaining to the sale of any weapons no longer needed for pending prosecution in the last 10 years.

Your request is granted in part and denied in part as follows:

We have enclosed copies of the following documents that you requested:

- Copy of all credit card statements for the last 12 months for all credit cards under the management / control of the Sheriff's Office.

Your request is denied for this information due solely to the fact that our Sheriff's Office accounts are kept and maintained by the Coles County Treasurer's Office. Any and all fiscal records will need to be requested thru that office.

You have the right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5 (a). You can file your Request Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State Circuit Court. 5 ILCS 140/11.

If you choose to file a Request Review with the PAC, you must do so within 60 calendar days of the date of this denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
