W-2 Forms

Note: The W-2 forms of public employees contain extensive personal information. The W-2 forms are not prepared for or reviewed by the corporate authorities, and they are not used for any purpose by the municipal employer, except for the sole purpose of complying with federal and state law to document individual earnings and tax compliance for the Internal Revenue Service and for the Illinois Department of Revenue.

Query: Is the W-2 form for a public employee considered a public record as defined in FOIA? Since each W-2 form pertains only to the employee's personal finances, the disclosure of which would be highly personal or objectionable to a reasonable person, is the entire contents of the W-2 exempt under ⁽¹⁾(c) because it contains "private information," as defined in ⁽²⁾(c-5), the disclosure of which would be an unwarranted invasion of personal privacy?
