# ILLINOIS STATE POLICE MERIT BOARD

#### FISCAL YEAR 2014 CONTRACT

This agreement made between the State of Illinois, Illinois State Police Merit Board, 531 Sangamon Avenue East, Springfield, Illinois 60702, hereinafter referred to as ISPMB, and Roger C Marquardt & Co, Inc, 311 S County Farm Road, Suite I, Wheaton, Illinois 60187, hereinafter referred to as "Contractor," provides

SERVICRS: The Contractor agrees to perform for the ISPMB, in a good and workman-like manner the following specific services

Consulting services tracking legislation for ISPMB

COMPENSATION: Total compensation will be \$30,000 00 Payments shall be as follows

\$15,000 00 upon acceptance of contract

\$15,000 00 February 1, 2014

Travel expenses shall not be reimbursed

Obligations of the State will cease immediately without penalty of further payment being required if in any fiscal year the Illinois General Assembly or Federal funding source fails to appropriate or otherwise make available sufficient funds for this agreement

**TERMS:** The term of this agreement shall be for the period commencing August 1, 2013, and shall terminate on June 30, 2014. This agreement may be terminated for violation of terms or at the will of either party thirty days after the postmark on a notice of termination sent by registered or certified mail to the other party.

CONTRACTOR agrees to comply with Public Act 90-609, apv 6/30/98, the same being the Illinois Procurement Code, 30 ILCS 500/50-13

**CONTRACTOR** agrees to comply with the prohibitions against discrimination in public contracts as set forth at Ill Rev State, ch 29, par 17, et seq. Those provisions are made a part of this agreement by reference as though set forth in full berein.

CONTRACTOR agrees not to commit unlawful discrimination or any violation of civil rights as defined in the Illinois Human Rights Act (Ill Rev Stat, ch 68, par 10101, et seq) and further agrees to take affirmative action to ensure that no unlawful discrimination or civil rights violations occur. The Illinois Human Rights Act is made a part of this agreement by reference as though set forth in full herein

**CONTRACTOR** agrees to comply with the Illinois law relating to Prevailing Wage as found at Ill Rev Stat, ch 127, par 132 6-3, and ch 48, par 39s-3, et seq The provisions of those statutes are made a part of this agreement by reference as though set forth in full herein

CONTRACTOR certifies, by signature, that he/she has not been convicted of bribery or attempting to bribe, nor has made an admission of guilt, as defined and described at III Rev Stat, ch 127, par 132 10-1

CONTRACTOR certifies by signature, that he/she is not in default on an educational loan as defined and provided at III Rev Stat, ch 127, par 3553

**CONTRACTOR** certifies that the individual will not engage in the unlawful manufacture, distribution, dispensation, possession, or use of a controlled substance in the performance of the contract according to Public Act 86-1459, Section 4

CONTRACTOR agrees to comply with requirements of the Illinois Purchasing Act (Ill Rev Stat, ch 127, par 132 1, and et seq ) and in particular the subcontractor disclosure provisions found at Paragraph 132 9d

**CONTRACTOR** certifies that he/she is not a State employee, State officer, family member or other party prohibited by the provisions of Paragraph 132 11-1 from entering into this contract. The Illinois Purchasing Act is made a part of this agreement by reference as though set forth in full herein

**CONTRACTOR** agrees that the Equal Employment Opportunity Clause, as found at 44 III Adm Code 750, Appendix A, and required by 44 III Adm Code 750 10, is made a part of this agreement by reference as though set forth in full herein

**CONTRACTOR** certified, by signature, that he/she will provide a drug free work place as required by the Illinois Drug Free Work place Act at Ill Rev Stat, ch 127, par 132 311, et Seq

CONTRACTOR or bidder certifies that they are not barred from being awarded a contract under 30ILCS500 Section 50-11 prohibits a person from entering into a contract with a State agency if they know or should know that they are delinquent in the payment of any debt to the State as defined by the Debt Collection Board The contractor further acknowledges that the contracting State agency may declare the contract void if this certification is false or if the contractor is determined to be delinquent in the payment of any debt during the term of the contract

The contractor acknowledges that the contracting agency shall declare the contract void if this certification is false

**CONTRACTOR** agrees his agreement is in compliance with the requirements of the Corporate Accountability for Tax Expenditure Act (PA 93-0552)

CONTRACTOR agrees to comply with the Americans with Disabilities Act (ADA) (42 U S C 12101, ET Seq) and all pertinent regulations promulgated to enforce this Act (28 C F R 35 130), which prohibits any qualified individual with a disability from being denied the benefits of aid, services, programs, or activities of a public entity, either directly or through contractual arrangements

**CONTRACTOR** agrees to comply with the International Anti-Boycott Certification Act (30 ILCS 582/1 Section 5) which requires that neither the vendor/contractor nor any substantially-owned affiliated company is participating or shall participate in an international boycott in violation of the provisions of the U.S. Export Administration Act of 1979 or the regulations of the U.S. Department of Commerce promulgated under the Act

**CONTRACTOR** certifies in accordance with 30ILCS 500/50-14 that the bidder or contractor is not barred from being awarded a contract under this Section The contractor acknowledges that the contracting agency may declare the contract void if this certification is false

**CONTRACTOR** certifies that they are not required to register as a business entity with the State Board of Elections pursuant to 30ILCS 500/20-160 Further, the contractor acknowledges that all contracts between State agencies and a business entity that do not comply with this Section shall be voidable under Section 50-60 of the Procurement Code 30ILCS 500/50-60

**CONTRACTOR** or bidder certifies that it, or any affiliate, is not barred from being awarded a contract under 301LCS500/50-11 and 50-12. The contractor further acknowledges that the contracting State agency may declare the contract void if this certification is false or if the contractor it, or any affiliate, not barred from contracting for failure to collect or remit Illinois use taxes.

**CONTRACTOR** certifies by signature, that he/she has not been barred from contracting with a unit of State or local government as a result of a violation of Section 33E-3 or 33E-4 of the Illinois Criminal Code of 1961

CONTRACTOR certifies, by signature, that he/she no person or business found by a court or the Pollution Control Board to have committed a willful or knowing violation of the Environmental Protection Act shall do business with the State of Illinois or any State agency from the date of the order containing the finding of violation until 5 years after that date, unless the person or business can show that no person involved in the violation continues to have any involvement with the business

CONTRACTOR agrees to comply with Public Act 87-991 which requires the vendor/contractor shall maintain, for a minimum of 5 years after the completion of the contract, adequate books, records, and supporting documents to verify the amounts, recipients, and uses of all disbursements of funds passing in conjunction with the contract, the contract and all books, records, and supporting documents related to the contract shall be available for review and audit by the Auditor General, Chief Procurement Officer, Internal Auditor and Purchasing agency, and the contractor agrees to cooperate fully with any audit conducted by the Auditor General, Chief Procurement Officer, Internal Auditor and Purchasing agency and to provide full access to all relevant materials.
