

This letter is in response to your Illinois Freedom of Information Act ("FOIA") request received on December 15, 2015. In regard your request:

1.) *Copy of all leases / rental agreements for any space located within Edgar County, PIN: 09-18-02-300-006, or any other such real estate owned by IDOT in Paris, Illinois. I am looking for leases/rentals/agreements where IDOT or the State has leased/rented to outside entities like the "Paris Hi-Way Credit Union". This would include any agreements with "Paris Hi-Way Credit Union" or any similar entity to use space and conduct business within the state building.*

2.) *Copy of the certification of exempt property filed with the Edgar County Supervisor of Assessments listing any/all such leaseholders.*

3.) *Copy of the complete compensation package of Bridgette Borries-Pierson who works in the IDOT District 5 area.*
