Pursuant to 225 Illinois Compiled Statutes 305/1 - 305/40, Part 1150 a Rule does hereby issue to Carla Burkhart and Hurricane Graphics to show cause why an order to Cease and Desist as to providing or offering architectural services should not be entered against you based upon:

- Evidence that Respondents advertised and offered architectural services to the College of DuPage in April 2012 without being duly licensed as an architect or a Professional Design Firm in the State of Illinois.

YOU ARE HEREBY NOTIFIED that you have seven (7) days from the date of this Rule to file an answer to the satisfaction of the Department. Failure to answer to the satisfaction of the

Department shall cause an Order to Cease and Desist to be issued forthwith.

YOU ARE FURTHER NOTIFIED that pursuant to 225 Illinois Compiled Statutes 305/1 - 305/40, any person who engages as an architect is guilty of a Class A misdemeanor. On conviction of a second or subsequent offense the violator is guilty of a Class 4 felony.
