

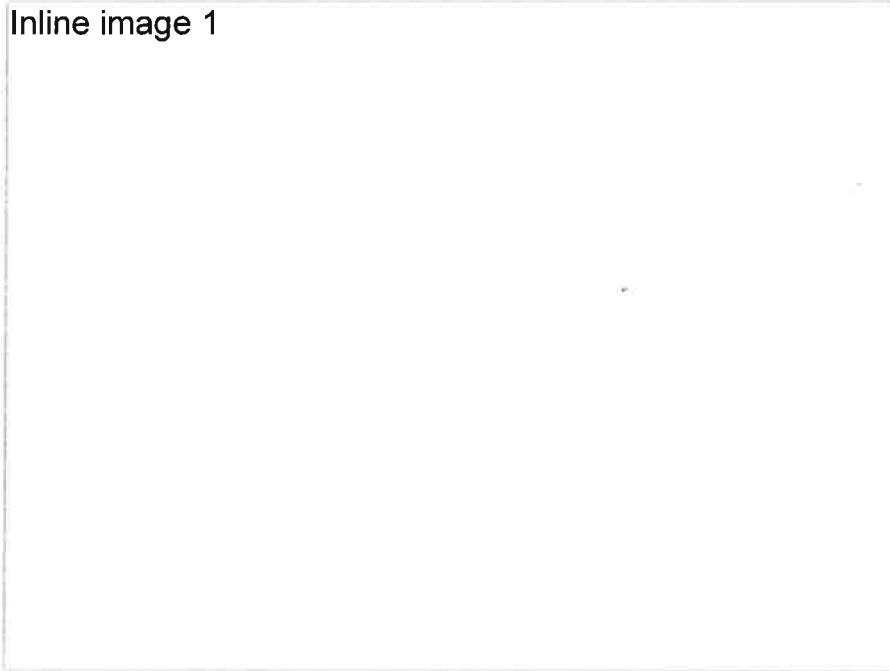



Superintendent McDermott,

Last night I attended the D142 Board Meeting and am concerned about allegations made against board member Roxana Agler. Chief amongst them are the allegations that Agler has been threatening, frightening, and/or harassing parents and teachers in your district. I ask that you please open an investigation into these allegations and thoroughly vet them and then take appropriate action in this situation.

I have never seen a board member behave as badly in public as Agler's behavior on 4/19/16. It was disgraceful. But, this morning I was shocked to read some of the emails that have already been produced under FOIA, where Agler lobs defamatory accusations against fellow board members and community members that are beyond the pale. The vulgarity contained in some of these emails is horrifying considering that Agler sits on an elementary school board. Her behavior should not be tolerated by you or your district. Her ranting and raving seems paranoid, troubled, and appears in some instances to be a cry for help.

I am so concerned by what I have seen in these emails that I am reaching out to our state representatives in Springfield to ask them to assist you in any way they can to get to the bottom of what Roxana Agler has been doing to the parents and teachers in your district. I believe at minimum that she should be censured and I encourage you to look for any available mechanism to remove her from your board. I was able to speak to over a dozen people yesterday who seemed genuinely frightened of Agler and of what they fear she will do to them if they speak out. I have also contacted the Attorney General's Office of the Public Access Counselor about Agler's attempt last night to prevent public filming of your board meeting, which is a clear violation of our state's Open Meetings Act.

I have reviewed your anti-bullying policies and feel that Roxana Agler's treatment of the public and fellow board members is clearly bullying. At minimum, she should be removed from any part in the anti-bullying committee you have, as her involvement renders that committee a farce.

Please view Roxana Agler's horrible behavior for yourself here and listen to what members of your community are saying about how she frightens them. I believe it is your duty as Superintendent to intervene in this situation when a board member has so disgraced herself and has so bullied those around her that she has become a serious problem needing your attention.
