

SALARY RESOLUTION

WHEREAS, 50 ILCS 145/2 requires that the compensation of elected officials of units of local government must be fixed at least 180 days before the beginning of the terms of the aforementioned officers; and

WHEREAS, the Edgar County Circuit Clerk, Coroner, County Board Members of Districts 1, 2, 6 and 7 and States Attorney are such elected officers whose terms begin December 1, 2016; and

WHEREAS, 55 ILCS 5/5-1069 provides that the county board of any county may arrange to provide, for the benefit of employees of the county, group life, health, accident, hospital and medical insurance, or any one or a combination of those types of insurance; and

WHEREAS, under the same statute elected or appointed officials would be included in the term "employee".

THEREFORE, BE IT RESOLVED that the salaries of the aforementioned county officials be set as follows:

THEREFORE, BE IT FURTHER RESOLVED that the Chairman of the Edgar County Board shall be paid \$10 more per county board meeting than the members (\$135 per month/\$1620 annually); and

THEREFORE, BE IT FURTHER RESOLVED that the previous \$10 travel allowance per meeting available to county board members shall be eliminated for Members from Districts 1, 2, 6, & 7; and

THEREFORE, BE IT FURTHER RESOLVED that for any meetings representing the county other than for county board meetings, members from districts 1,2, 6, & 7 shall be compensated \$35; and

THEREFORE, BE IT FURTHER RESOLVED that the Circuit Clerk, Coroner, County Board Members and States Attorney may choose to participate in any life insurance, group health insurance plan, opt out program, dental, vision, Medicare reimbursement or any other related insurance benefit plans offered by or through the County; and

THEREFORE BE IT FURTHER RESOLVED that the aforementioned elected officials may participate in IMRF and any other retirement plan offered by or through the County.




