WHEREAS, the estimated amount of the aforesaid proper and necessary charges and expenses of this Township against each of the above Funds until the next time it shall receive revenue is such that a surplus in excess of such charges and expenses exists in each, such excess being approximately as follows: General Town Fund - \$80,000.00; and, General Assistance Fund - \$40,000.00.



That of the \$80,000.00 surplus monies in the General Town Fund, \$25,000.00 be TRANSFERRED to the Permanent Road Fund of the said Shelbyville Township;

That of the \$80,000.00 surplus monies in the General Town Fund, \$10,000.00 be TRANSFERRED to the Equipment & Building Fund of the said Shelbyville Township;


That of the \$40,000.00 surplus monies in the General Assistance Fund, \$20,000.00 be TRANSFERRED to the Equipment & Building Fund of Shelbyville Township;





WHEREAS, the estimated amount of the aforesaid proper and necessary charges and expenses of this Township against each of the above Funds until the next time it shall receive revenue is such that a surplus in excess of such charges and expenses exists in each, such excess being approximately as follows: General Road Fund - \$58,000.00; Construction or Road Repair of Bridges Fund - \$147,000.00; Road Damage Fund - \$60,000.00; Insurance Fund - \$84,000.00; and, General Assistance Fund - \$81,000.00.

NOW, THEREFORE, be it, and the same is hereby, RESOLVED pursuant to 60 ILCS 1/30-25 by the legal voters of Shelbyville Township, Shelby County, Illinois, at its annual Town Meeting assembled as follows:

That of the \$58,000.00 surplus monies in the General Road Fund, \$10,000.00 be TRANSFERRED to the Equipment & Building Fund of Shelbyville Township;

That of the \$147,000.00 surplus monies in the Construction or Road Repair of Bridges


Fund, \$60,000.00 be TRANSFERRED to the Equipment & Building Fund of Shelbyville Township;

That of the \$60,000.00 surplus monies in the Road Damage Fund, \$20,000.00 be TRANSFERRED to the Equipment & Building Fund of Shelbyville Township;

That of the \$84,000.00 surplus monies in the Insurance Fund, \$15,000.00 be TRANSFERRED to the General Town Fund of the said Shelbyville Township;


