We decided at this point that we would have a board members only meeting in a different town. At this time Amy and Jennifer took it on themselves to bring not only a news crew to my home but many other people who all at one point were on our property and banging on our door demanding a statement on myself at that time. Law enforcement was called all parties left at that time. They all went to the Church parking lot across from my home where they stayed and watched my home with husband and son. They then began to come back and bang on my door many times after they were asked to stay off of the property. The Sheriff was

Called to my home the many people led by the two women continued all evening yelling different things the Sheriff that was sent to my home asked my husband to call him when I came back in town and he would follow me home unsure what could happen. When I pulled into my drive with the Sheriff a block behind me the many cars at the Church began pulling out but when he came around the corner they stopped and went back to parking lot at Church they stayed many hours I felt unable to leave my home or allow my children given the history both of them. They stayed until 1:20 am and this all started about 5:30 pm. I was even afraid to leave my home to walk out to my car as am I am afraid to leave my home alone to day for fear of what could happen. I am afraid for my 14 year old daughter to be home alone even a little while. ~~They~~ Both kids expressed concern this morning even about being at school.

REMEDIES SECTION (Section 20)

Pursuant to the Stalking No Contact Order Act, the Petitioner seeks the following remedies:

- 1. That prohibits the respondent from threatening to commit or committing stalking personally or through third party.
- 2. That the Respondent may not contact the Petitioner and/or other protected persons in any way, directly, indirectly or through third parties, including, but not limited to, phone, written notes, mail, email, or fax.
- 3. That the Respondent be ordered to stay at least 500 feet away from the Petitioner and/or other protected persons, and their residence, school, daycare, employment and any other specified place. That Respondent be prohibited from entering or remaining at the Petitioner's and/or other protected persons':

- place of residence, located at [REDACTED] Toledo IL
- place(s) of employment, located at Dreiferich Elementary + High School
- school(s) or/ and daycare, located at Cumberland High School elementary & Middle School
- and any of the following specified places, when Petitioner and/or other protected persons are present: Football Field where games are played

- 3. That the Respondent be prohibited from possessing a Firearms Owners Identification Card, or possessing or buying firearms.
- 4. Other injunctive relief as follows:



Stalking: means engaging in a course of conduct directed at a specific person, and he or she knows or should know that this course of conduct would cause a reasonable person to fear for his or her safety or the safety of a third person or suffer emotional distress. Stalking does not include an exercise of the right to free speech or assembly that is otherwise lawful or picketing occurring at the workplace that is otherwise lawful and arises out of a bona fide labor dispute, including any controversy concerning wages, salaries, hours, working conditions or benefits, including health and welfare, sick leave, insurance, and pension or retirement provisions, the making or maintaining of collective bargaining agreements, and the terms to be included in those agreements.

DEFINITION OF TERMS USED IN THIS PETITION

1. **Stalking No Contact Order:** an emergency order or plenary order granted under the Stalking No Contact Order Act (the Act), which includes any remedy authorized by 740 ILCS 21/80.
2. **Course of Conduct:** means two or more acts, including but not limited to acts in which a respondent directly, indirectly, or through third parties, by any action, method, device, or means communicates to or about, a person, engages in other contact, or interferes with or damages a person's property or pet. A course of conduct may include contact via electronic communications. The incarceration of a person in penal institution who commits the course of conduct is not a bar to prosecution under this Section.
3. **Emotional distress:** means significant mental suffering, anxiety or alarm.
4. **Contact:** includes any contact with the victim, that is initiated or continued without the victim's consent, or that is in disregard of the victim's expressed desire that the contact be avoided or discontinued, including but not limited to being in the physical presence of the victim; appearing within the sight of the victim; approaching or confronting the victim in a public place or on private property; appearing at the workplace or residence of the victim; entering onto or remaining on property owned, leased, or occupied by the victim; or placing an object on, or delivering an object to, property owned, leased, or occupied by the victim.
5. **Petitioner:** means any named petitioner for the stalking no contact order or any named victim of stalking on whose behalf the petition is brought.
6. **Reasonable Person:** means a person in the petitioner's circumstances with the petitioner's knowledge of the respondent and the respondent's prior acts.
