Township group edgy about convention

Township government supporters seem a bit edgy about the idea of a constitutional convention, fearing that if a convention is held, township government might be at risk.

This November, Illinois voters will have the opportunity to vote for a constitutional convention. This happens every 20 years. In 1988, voters determined there was no need for a convention.

Who knows how the vote will go this year, especially given the poor performance of our state government.

A couple of weeks back. Woodstock resident Ed Riley was surprised to see stickers stating opposition to a state constitutional convention at a Dorr Township meeting.

The stickers stated, "Con. Con No."

Riley inquired as to the township's position on the possibility of a convention and was frustrated with the answers he got

"I wanted too know what the big thing was? I wanted to know why they were [apparently] against it," Riley said.

I wanted to know to so I called Dorr Township.
Supervisor Robert Pierce: I was disturbed that a government entity would have such political material. I was equally dis-

turbed that such material would be so poorly done. Really, who the heck is going to know what "Con Con No No" means?

To my relief, Pierce told me the stickers were not created by the township. The stickers were sent with other material from Township Officials of Illinois, a nonprofit, private organization that represents township government interests in the state.

Pierce said that the Dorr Township board had not taken a position on the constitutional convention. Pierce recommended that I call Bryan Smith, the executive director of Township Officials of Illinois.

Township Officials of Illinois clearly has a position

"We feel that a constitutional convention is not needed," Smith said. "The current constitution is a sound document that can be amended."

Smith cited the potential,

costs of a constitutional convention and said that our current system of local government works just fine. Smith said that a convention could mean the abolishment of sections of local government—like townships.

Why are townships so defensive? Township defenders always talk about how essential township government is, but if that's the case, why the fear that a convention might spell doom?

"From time to time, [people] have crossed ways with town-ship officials," Smith said."
"Some people like to poke at it [township government]."

"Smith said that townships also are not as well known and that many people do not understand what townships do.

What do they do?

Well, townships manage roads that are not under the jurisdiction of the county, municipality or the state, they hand out public aid, and they assess the value of property for tax purposes.

The township assessors do have a big job that is not easy, but it still seems to me that counties could handle all three of those jobs. And if the electorate largely is ignorant of township government, that means voters are not doing a

good job holding them accountable. That would seem to support an argument for elimination. Why do people like methink such thoughts if townships are so important?

"In a lot of cases, township officials are more quiet. They don't like to toot their own horn." Smith said.

Oh.

Perhaps the 1,433 townships that currently exist in Illinois are needed. Maybe it would be cost prohibitive to shift duties to the county.

Pierce told me that no government agency is as responsive in handing out aid as are townships. He said Dorr. Township recently helped out a family-by giving them \$500 in aid, helping them stay in their home.

I have no doubt that many township officials are well-intentioned and work hard at their jobs.

But I still think that a discussion of the need for township government, and many many other taxing districts; needs to happen. And the best place for that would be a constitutional convention.
