

Park/Pavilion Rentals:

1. Sanitation fees: (non-refundable)
Groups of 50-74 people- \$50 Fee
Groups of 75-99 people- \$75 Fee
Groups of 100 or more people-\$100

You may also provide your own porta-johns to have this fee waived by the Board. If bringing extra toilet paper to use with our facilities, it must be porta-john safe.

Park/Pavilion Rental Policies:

- 1. Bring your own garbage bags to replace what you use. Place the tied bags in the dumpster.
- 2. Use the North side of the pavilion for dropping off equipment and handicapped persons. Park vehicles in the parking lot.
- 3. The parking lot will fit 50 vehicles if parked properly. (The Park Manager can advise you.) Avoid parking on the grass if it is raining or the ground is soft.
- 4. The Park Manager is available for help with electrical issues at the pavilion, or with any other problem.
- 5. You are responsible for your guests. You must have let us know on your application and have proof of alcohol insurance if alcohol is present. Since this is a NON-ALCOHOL park, if alcohol is present and no approval and insurance, you will not be refunded for your deposit and will be banned from future rentals. A detailed set of rules is posted at the Park Display Case. Please read.

Boat Ramp Fees:

- 1. All Boats, pontoons, canoes, kayaks, jet skis, etc. are required to pay a \$5.00 per use fee or a \$35.00 (non-resident) -\$30.00 (resident) yearly fee.
- 2. Except for the yearly paid ramp use people, there will be no access to the boat ramp during a whole park rental. A sign will be posted at the entrance to the park for these events.
