NARRATIVE

On 8-16-18 at 1821hrs, Ofc. Kiebles was dispatched to post regarding harassment.

Upon arrival, Ofc. Kiebles met with Sarah Norton and her father, John Norton. Sarah advised she is the county clerk and, along with her father, traveled to the county building located at 21333 W Ballou Rd to do some work. When they arrived, a white SUV (2002 Chevy Tahoe) pulled in behind them and the driver, identified as [REDACTED] began filming them with his phone. It should be noted that there has been many incidents regarding angry residents and county employees at this location in recent months. Sarah advised no one is allowed in the county building without an elected official's permission. Sarah is an elected official. [REDACTED] entered the building and approached the File Room. He stood in the doorway filming Sarah. She advised him he was not allowed in the File Room. [REDACTED] then stepped back outside the File Room, but refused to leave the building.

John had his camera with him and took photos of Esposito in his Tahoe and in the building with his phone in his hand apparently filming. Sarah advised she would like to pursue complaints against [REDACTED]. At approximately 2130hrs, Ofc. Kiebles spoke briefly to [REDACTED] via telephone. He was unable to come into the police department to meet due to an early work schedule in the morning. [REDACTED] stated he will meet with officers tomorrow late afternoon to give his side.
