ORDER DECLARING RESULT OF ELECTION

This matter coming on to be heard this feth day of December, A. D. 1945, that being one of the regular judicial days of this Court, for an order finding the results of the election held on December 12, 1945, pursuant to the order of this Court entered herein on November 9, 1945, and the petitioners appearing by their attorneys and the Court having heard evidence, inspected and canvassed the returns of the election filed with the County Clerk and being fully advised in the premises, finds, orders and decrees as follows:

1. That the election of December 12, 1945 was properly and legally held within the territory embraced in the proposed authority, which territory is described as follows:

Beginning at the Northwest corner of Section 22, Township 21 North, Range 14 West of the Second (2nd) Principal Meridian, said point Being the Northwest corner of Pilot Township; thence East along the North lines of Pilot, Blount and Newell Townships to the Northeast corner of Section 22, Township 21 North, Range 11 West of the Second (2nd) Principal Meridian, said point being the Northeast corner of Newell Township thence South along the East lines of Newell, Dauville and McKendree Townships to the Southeast corner of fractional Section 6, Township 17 North, Range 10 West of the Second (2nd) Principal Meridian in Vermilion County, Illinois, said point being the Southeast corner of McKendree Township; thence West along the South lines of McKendree and Georgetown Townships to the Southwest corner of Section 2, Township 17 North, Range 12 West of the Second (2nd) Principal Meridian, said point being the Southwest corner of Section 2, Township 17 slong the West line of Georgetown Township; to the Southwest corner of Section 2, Township 18 North, Range 12 West of the Section 20 and Section 22 and Section 21, same 2. Township and Range to the Southwest corner of Section 21 to Northwest corner of Section 22 and Section 21, same 21, same 21 North, Range 12 West of the Second (2nd) Principal Meridian; thence West along the South lines of Catlin and Vance Townships to the Northwest corner of Section 24, Township 18 North, Range 14 West of the Second (2nd) Principal Meridian, said point being the Northwest corner of Section 24, Township 18 North, Range 14 West of the Second (2nd) Principal Meridian, said point being the Northwest corner of Section 25, 25 and 27, Township 18 North, Range 14 West of the Second (2nd) Principal Meridian, being on the South line of Vance Township; thence Fine of Sections 25, 25 and 27, Township 18 North, Range 14 West of the Second (2nd) Principal Meridian, being on the South line of Vance Townships to the Southwest corner of the Northwest Quarter of the Northwest Corner of the Northwest Corn

2. That at least thirty days prior to said election, notice of said election was given in conformity with the

requirements of the Statute and of this Court's Order heretofore entered by publication in the Danville Commercial News, a daily newspaper published in Danville, Illinois and having a general circulation within said territory on three separate days, all as is shown by proof of publication filed herein.

- 3. That not less than thirtydays prior to said election and in conformity with the requirements of the Statute and of this Court's Order heretofore entered, printed copies of the notice of election were posted in ten of the most public places in said territory, all as is shown by proof of posting filed herein.
- 4. That the ballot used at said election was

Shall "An Act in relation to Airport Authorities," effective the 4th day of April, 1945, be adopted, and the Vermilion County Airport Authority be established?

(If established, said Airport Authority will have the power, objects and purposes provided by said act, including the power to levy a tax of not to exceed one and one-half mills on the dollar of assessed valuation for airport operation and maintenance and other corporate purposes and the power to issue tax secured bonds.)

and in conformity with the requirements of the Statute. That said ballot was published in the Danville Commercial News, a secular newspaper having general circulation in said territory at least five days prior to the holding of said election on to-wit, December 3.d., 1945 as shown by the certificate of the publisher.

5. That said election within the City of Danville, Illinois was conducted by the Board of Election Commissioners of said City and in the territory outside said City of Danville, Illinois, said election was conducted by the officials and at the polling places designated by the orders of this Court heretofore entered.

- 6. That said election was properly and lawfully conducted and held in all particulars so as to comply with this Court's Order and with the provisions of "An Act in Relation to Airport Authorities" effected the Fourth day of April, 1945, Section 28-3 of the Election Code and the provisions of the Election Code applicable to conducting of general elections within such territory.
- 7. That the said election officials did file with the County Clerk the poll books and returns of said election, which have been duly canvassed by the undersigned County Judge who hereby declares that in the territory outside the City of Danville, Illinois there were cast a total of 1066 votes on said proposition; that 651 votes were in favor of said proposition and 415 votes were against said proposition.
- 8. That after said election the Board of Election Commissioners of the City of Danville, Illinois Filed with the County Clerk a certificate signed by the canvassing board of said municipality, which has been canvassed by the undersigned County Judge and which shows that a total of 1870 votes were east on said proposition; that 1418 votes were in favor of said proposition and 452 votes were against said proposition.
- 9. That within the entire territory above described there were cast 2936 votes; that 2069 votes were in favor of the adoption of said Act and the establishment of Vermilion County Airport Authority and 867 votes were against said proposition. Said results are hereby entered of record in this proceeding and are hereby pracred to be enrolled upon the records of the County Clerk.
- 10. The undersigned County Judge does hereby declare that a majority of the votes east upon the question of the adoption of "An Act in Relation to Kunnutpur Airport Authorities" effective the 4th day of April, 1945 and the

establishment of Vermilion County Airport Authority were in favor of the same, and the inhabitants of said territory are deemed to have accepted the provisions of said Act and the same shall henceforth be deemed an organized Airport Authority under said Act having the name "Vermilion County Airport Authority".

- 11. That the total population of said Authority is 67,170 persons and the population of the City of Danville, Illinois is 36,972 persons; that the City of Danville is the only municipality having a population of 5000 or more within said Authority.
- 12. That said Authority shall be governed by a board of five commissioners, one of whom shall be appointed from the area within the Authority outside said City of Danville, Illinois by the undersigned County Judge, one of whom shall be appointed at large from the area within the Authority by the undersigned County Judge and three of whom shall be appointed from the said City of Danville, Illinois by the presiding officer of such municipality who is the Honorable Don H. Wilson, Mayor of said City; and all such appointments shall be made in writing and a certificate thereof shall be filed in the office of the County Clerk within twenty days after the date of this ofder determining the results of said election. Said Commissioners shall serve for one, two, three, four and five years and shall draw lots to determine the periods for which they each shall serve.
- 13. That the territory above described is hereby declared to be and constitute a separate municipal corporation and body politic to be known as "Vermilion County Airport Authority", subject to and having the powers given by the aforesaid Act.
