**AFFIDAVIT OF CONSTRUCTIVE SERVICE IN FORCIBLE ENTRY AND DETAINER**

1. I am above the age of 18 years, not a party to the above-captioned cause, am aware of the contents of this Affidavit, and can testify competently as a witness if called to so testify.

2. I have been authorized to serve process in this case; Illinois Dept. of Professional Regulation License No. 0129-284381.

3. The Complaint and Summons in the above case is in Forcible Entry and Detainer.

4. I have attempted personal service of the Summons and Complaint, but was unable to do so and, as a result, posted Summons and Complaint upon the premises on 09/29/18 @ 12:10pm and I have also mailed a copy of same pursuant to Section 735 ILCS 5/9-107 of the Illinois Code of Civil Procedure.

5. I was unable to personally serve the Defendant(s) with Summons and Complaint in the above case as a result of the following, upon information:

- The Defendant(s) is (are) not resident(s) of this State;
- The Defendant(s) has (have) departed from this State;
- The Defendant(s) is (are) concealed so that process cannot be served upon him, her, it or they.

6. I have employed due diligence in service of the Summons and Complaint as follows: I have made 3 separate attempts to serve the Summons and Complaint on the following dates and times:

- (1) 09/28/18 @ 8:40pm, no answer, server noted this is a business and the door locked.
- (2) 09/29/18 @ 7:25am, no answer, door locked.
- (3) 09/29/18 @ 12:10pm, no answer. Server spoke with neighboring business owner who states the defendant has been featured in the local news and the business he had here was shut down. Door to business is locked and no one is inside. Server posted summons and complaint to front door of the business.

7. The place of residence of the Defendant(s) is (are) 7010 Kings Mill Court, Springfield, IL 62711 or, if not known, that I have been unable to ascertain the Defendant's(s') place of residence upon diligent inquiry.


