Pursuant to the provisions of Section 11-501.1 of the Illinois Vehicle Code, this is a confirmation that your Illinois driver's license or driving permit and your privilege to operate a motor vehicle or to obtain a driver's license in Illinois are suspended effective on the date shown above.

This action is being taken as a result of this office receiving notification that you were arrested for driving a motor vehicle in this state while under the influence of alcohol, other drug or combination thereof, and that you subsequently refused to or failed to complete the chemical test(s) as required or you voluntarily submitted to chemical test(s) that indicated an alcohol concentration of 0.08 or more, a tetrahydrocannabinol (cannabis) concentration of either 5 nanograms or more per milliliter of whole blood or 10 nanograms or more per milliliter of other bodily substance or any trace of a controlled substance as listed in the Illinois Controlled Substances Act, methamphetamine and/or intoxicating compound as listed in the Intoxicating Compounds Act and Methamphetamine Control and Community Protection Act.

DEAR MR. LYNCHARD:

As a first time DUI offender in Illinois, you have automatically been enrolled in the Secretary of State's Monitoring Device Driving Permit (MDDP) program, which under certain circumstances will allow you to drive during your statutory summary suspension. An MDDP allows you to drive 24 hours per day, seven days a week, as long as you have a Breath Alcohol Ignition Interlock Device (BAIID) installed on the vehicle you are driving.

While a preliminary check of your driving record indicates that you are eligible for an MDDP, a more detailed inquiry will be made upon receipt of your application. You will be deemed ineligible if you fall into any of the following categories:

1. Under age 18;
2. Previously convicted of reckless homicide or aggravated DUI involving death;
3. Driving privileges are otherwise invalid; or
4. Death or great bodily harm resulted from your DUI arrest.

A commercial driver's license (CDL) holder may be eligible for an MDDP to drive a non-commercial motor vehicle but may not operate a commercial motor vehicle with an MDDP.

Application/MDDP Issuance

In order to process your MDDP, please return in the envelope provided the application on page 2 of this letter by 11/18/18.

Upon receipt of your application, the Secretary of State's office will send you a detailed requirements letter and a form with the terms and conditions of the program.

Upon satisfaction of the requirements, your MDDP will be issued. At that time, you will have 14 days in which to have a BAIID installed on every vehicle you will be driving during your suspension.

Employment Exemption

If you need to drive an employer-owned vehicle during work hours and the vehicle is not specifically assigned to you, you may be eligible for an employer exemption. While you would still be required to operate your personal vehicles only if equipped with a BAIID, the MDDP would allow you to drive employer-owned vehicles without a BAIID during work hours. Employment information must be verified with your employer before an employment exemption is granted. You will not be eligible for this exemption if you are self-employed, work for an immediate family member or are allowed to use work vehicles for personal use.

PETITION TO RESCIND STATUTORY SUMMARY SUSPENSION

NOW COMES the Defendant/Petitioner, Garrett S. Lynchard (Shawn), by and through the attorneys of the Lawler Brown Law Firm and for the Petition to Rescind Statutory Summary Suspension states as follows:

1. Defense counsel hereby petitions this Court to rescind the Statutory Summary Suspension heretofore issued in this case due to the issue(s) of:
 - (X) I was not properly placed under arrest for an offense as defined in Section 11-501 of the Illinois Vehicle Code (Driving Under the Influence of Alcohol/Drugs) or a similar provision of a local ordinance, as evidenced by the issuance of Uniform Traffic Ticket to other form of charge;
 - (X) The arresting officer did not have reasonable grounds to believe that I was driving or in actual physical control of a motor vehicle while under the influence of alcohol and/or other drugs, or a combination thereof;
 - (X) I was not properly warned by the arresting officer as provided in Section 11-501.1 of the Illinois Vehicle Code;
 - (X) I did not refuse to submit to and/or complete the required chemical test or tests, pursuant to Section 11.501.1 of the Illinois Vehicle Code, upon the request of the arresting officer;
 - (X) I submitted to the requested test or tests but the test sample of my blood alcohol concentration did not indicate a blood alcohol concentration of .08 or more.



The suspension/revocation shall take effect on the 46th day following issuance of this notice. Subsequent to an arrest for violating Section 11-501 of the Illinois Vehicle Code, or similar provision of a local ordinance or Section 11-401 of the Illinois Vehicle Code, you are hereby notified that on the date shown above, you were asked to submit to a chemical test(s) to determine the alcohol, other drugs, intoxicating compounds, or any combination thereof, content of your breath, blood, or/or other bodily substance and warned of the consequences pursuant to Section 11-501.1 of the Illinois Vehicle Code. You have the right to a hearing to contest your suspension/revocation. You must file a petition to rescind your suspension/revocation within 90 days of this notice.
