Dear Board of Elections:

Please accept the enclosed Complaint for Violations of the Campaign Disclosure Act against the following committees: Friends of Lance Yednock, Friends of Michael J. Madigan and Friends of Marty Durkan.

I am requesting that the State Board of Elections accept my Complaint for Violations of 10 ILCS 5/9-25 and 10 ILCS 5/9-8.5 of the Election Code.

"No person shall make an anonymous contribution or a contribution in the name of another person, and no person shall knowingly accept any anonymous contribution or contribution made by one person in the name of another person." 10 ILCS 5/9-25.

"During an election cycle, a candidate political committee may not accept contributions with an aggregate value over the following: (i) \$5,000 from any individual, (ii) \$10,000 from any corporation, labor organization, or association, or (iii) \$50,000 from a candidate political committee or political action committee." 10 ILCS 5/9-8.5(b).

It is my belief that Friends of Michael J. Madigan laundered a \$55,400.00 campaign contribution to Friends of Lance Yednock through Friends of Marty Durkan.

Marty Durkan was a candidate for a position with the Metropolitan Water Reclamation District of Greater Chicago. Friends of Marty Durkan is the candidate political committee for candidate Marty Durkan.

Michael J. Madigan is the State Representative for Illinois' 22nd District and is currently running for re-election. Friends of Michael J. Madigan is the candidate political committee for candidate Michael J. Madigan.

REPRESENTING THE INJURED AUTO ACCIDENTS • WORKER'S COMPENSATION AND ALL AREAS OF PERSONAL INJURY Lance Yednock is a candidate for State Representative for Illinois' 76th District. Friends of Lance Yednock is the candidate political committee for candidate Lance Yednock.

On or about February 22, 2018, Friends of Michael J. Madigan contributed \$55,400.00 to Friends of Marty Durkan. (Exhibit A). On or about March 19, 20118, Friends of Marty Durkan accepted the \$55,400.00 contribution. (Exhibit B). On or about August 29, 2018, Friends of Lance Yednock accepted a \$55,400.00 contribution from Friends of Marty Durkan. (Exhibit C).

A review of the quarterly reports for Friends of Marty Durkan for the fourth quarter of 2017, first quarter of 2018, and second quarter of 2018, evidence contributions from Friends of Marty Durkan to other political candidates. However, Friends of Marty Durkan's contributions to all other political candidates were \$250.00 or \$500.00. The \$55,400.00 contribution from Friends of Marty Durkan to Friends of Lance Yednock, the exact same amount Friends of Marty Durkan received from Friends of Michael J. Madigan, is 110 times more than Friends of Marty Durkan contributed to any other political candidate.

The \$55,400.00 contribution to Friends of Lance Yednock accepted by Friends of Marty Durkan was actually a contribution to Friends of Lance Yednock by Friends of Michael J. Madigan in violation of 10 ILCS 5/9-25.

In addition to the laundered \$55,400.00 contribution, Friends of Michael J. Madigan contributed directly to Friends of Lance Yednock on five occasions. (Exhibit D). The total of Friends of Michael J. Madigan's non-laundered contributions to Friends of Lance Yednock total \$1,582.21.

The \$55,400.00 contribution to Friends of Lance Yednock laundered through Friends of Marty Durkan in addition to the \$1,582.21 makes the total contributed to Friends of Lance Yednock by Friends of Michael J. Madigan \$56,982.21. Said total contributions violate 10 ILCS 5/9-8.5. Said statute limits campaign contributions to \$55,400.00 (statute says \$50,000.00 but due to inflation, the amount is \$55,400.00). Friends of Michael J. Madigan contributed to Friends of Lance Yednock the sum of \$56,982.21, in excess of the limits of 10 ILCS 5/9-8.5.

I respectfully request that the Illinois State Board of Elections accept my Complaint and set said matter for hearing before the Board.

I declare that this Complaint (including any accompanying schedules and statements) has been examined by me and to the best of my knowledge and belief is a true and correct complaint as required by Article 9 of The Election Code. I understand that the penalty for willfully filing a false complaint shall be a fine not to exceed \$500 or imprisonment in a penal institution other than the penitentiary not to exceed 6 months, or both fine and imprisonment.
