Dear Mr. Kirk:

Please be advised that this Office represents Mr. Mayer regarding the e-mail you had sent him at 10:33 a.m. Friday (December 14, 2018).

Regarding the quote from the court records you have in the referenced e-mail, in reviewing the Court record in its entirety instead of cherry picking one sentence in an unsubstantiated motion containing a false allegation of abuse, in which to my understanding no arrest was ever made nor a police report ever filed, this question would not even come up. You would, instead, have discovered that my client denied the allegations and that an evidentiary hearing on the Motion was held on or about August 19, 2015.
