Dear Mr. Kirk:

Please be advised that this Office represents Mr. Mayer regarding your subsequent letter dated December 19, 2018 and following e-mail dated December 20, 2018. Responding to such I will take it in order of your questions as stated in your most recent December 19, 2018 letter.

Regarding the quote from the court records you have in your December 14, 2018 e-mail, it was already addressed and denied by my client. Your December 19, 2018 letter states and I quote "We now understand there are more records in DuPage County and we will review those as well..." I suggest you review them and do your homework. If allegations of violent acts including forcefully raping someone and sodomy were true there would have been a police report and an arrest. Obviously my client DENIES these allegations and the fact that there was a contested hearing substantiates that denial.

Regarding the issue of child support, this issue remains contested and unresolved. Again there is no order stating that my client owes \$49,000.00 in child support, and it is my understanding from speaking with my client that the issue remains in court and again is not only being contested but my client is also seeking fees and costs due to this unproven claim. My client DENIES owing any past due child support.
