ORDINANCE ESTABLISHING COMPENSATION AND FRINGE BENEFITS FOR ELECTED OFFICIALS COMMENCING IN FISCAL YEAR 2009

WHEREAS, Joliet Township is a public entity which must by action of the Board of Trustees provide for the compensation and benefits payments for elected officials prior to the election in spring of 2009; and,

WHEREAS, it is in the best interest that the action be taken substantially before the election so that all interested persons are advised; and

WHEREAS, the amount of compensation may only be increased prior to a public official being sworn into office and that the schedule of compensation and benefits for elected officials cannot be changed for a period of four (4) years.

NOW, THEREFORE, BE IT ORDAINED by the Supervisor and Board of Trustees of Joliet Township, County of Will, and State of Illinois, that the compensation and fringe benefits of elected officials of Joliet Township is hereby established as set forth on Exhibit "A", which is attached hereto and made a part hereof by specific reference, which new compensation and benefits schedule shall be effective May 4, 2009 for all officials except the Assessor whose new compensation and benefits schedule shall begin January 1, 2010.

THAT THIS ORDINANCE shall be in full force and effect upon its passage, approval and publication in pamphlet form as made and provided by law.
