# TAX RATE OBJECTION COMPLAINT FOR REFUNDS OF 2019 REAL ESTATE TAXES IN MCHENRY COUNTY, ILLINOIS

NOW COME the Plaintiffs, CRYSTAL CORNERS, LLC, ET. AL.<sup>1</sup>, by and through

their counsel, The Dwyer Law Office, and pursuant to 35 ILCS 200/23-15, for their

respective 2018 McHenry County Tax Rate Objection Complaint against the Defendant,

GLENDA MILLER, in her official capacity as McHENRY COUNTY TREASURER and

EX-OFFICIO MCHENRY COUNTY COLLECTOR, complain as follows:

1. The taxing districts whose 2018 McHenry County levies are objected to

remain: Algonquin Township Road District; and Riley School District 18.

2. The Petition herein is filed pursuant to 35 ILCS 200/23-10, and 23-15;

Summaries of the Tax Rate Objections against those taxing entities are attached hereto and incorporated by reference as Exhibit A.

3. Plaintiff, Crystal Corners, LLC, and all additional plaintiffs named herein,

are taxpayers, or entities with the legal capacity and authority to represent the interests'

of taxpayers, who own, have a pecuniary interest in, or are otherwise obligated to pay real estate taxes on parcels of real property in McHenry County, identified by the Permanent Index Number in Exhibit B, attached hereto and incorporated by reference. Exhibit B identifies for each taxpayer, the identifying PIN number(s), tax code, the Equalized Assessed Valuation, and total taxes paid for each parcel.

4. Defendant Glenda Miller is the duly elected and acting McHenry County Treasurer, and Ex-Officio McHenry County Collector.

5. Within sixty (60) days after the penalty date of the final installment of 2018 real estate taxes in McHenry County, all of the 2018 real estate taxes (payable in 2019) for each parcel listed in Exhibit B were paid in full by Plaintiff or Plaintiffs' agents.

6. By filing this tax rate objection, Plaintiffs intend that all of the payments of the 2018 real estate taxes (payable in 2019) in McHenry County be deemed to be paid under protest pursuant to, and in accordance with, 35 ILCS 200/23-5.

7. Plaintiffs seek a refund, with accrued interest pursuant to statute (35 ILCS 200/23-20), of their respective 2018 real estate taxes for the parcels listed herein, by reason of excessive, illegal or voidable levies, assessments and taxes extended against the parcels delineated herein.

8. All of the Associations named herein are authorized by statute and its By-Laws or Declaration to petition for tax relief on behalf of the Association constituents.

9. The Condominium Act and the Common Interest Community Association Act both allow representative lawsuits and contain almost identical language. 10. For purposes of the Homeowners Associations in this Tax Objection, 765

ILCS 160/25 provides:

(j) The board shall have standing and capacity to act in a representative capacity in relation to matters involving the common areas or more than one unit, on behalf of the members or unit owners as their interests may appear.
(Source: P.A. 98-232, eff. 1-1-14; 98-241, eff. 8-9-13; 98-756; eff. 7-16-14; 99-41, eff. 7-14-15.)

11. For purposes of the Condominium Association in this Tax Objection, 765 ILCS 605/9.1 provides:

(b) Board of Managers' standing and capacity. The board of managers shall have standing and capacity to act in a representative capacity in relation to matters involving the common elements or more than one unit, on behalf of the unit owners, as their interests may appear.

12. All of the Associations named herein have, by its Board of Managers

under a 2/3 affirmative vote, authorized the named Associations to participate in this Tax Objection complaint on behalf of its constituents.

13. All of Associations herein have, in accordance with state law, recorded a Declaration which allows the Association to petition for tax relief, in a representative capacity, based upon state law.

14. Regardless, Plaintiffs herein have provided the individual names of each property owner, as the individual property owners are members of the listed property associations.

15. The particular grounds of objection to the valuations, line items, levies extension and taxes of each district for which recovery is sought are specified in Exhibit

A, attached hereto and incorporated by reference.

Township, and the McHenry Road District are valid, and should be sustained;

2. Determine the amounts of illegal and excessive taxes due to be refunded to each Plaintiff by percentage of tax paid, dollar amount or mill rate, whichever is appropriate;

3. Enter judgment against the Defendant the McHenry County Treasurer, also the ex-officio McHenry County Collector, in the amounts found to be due to each taxpayer, together with the required statutory interest pursuant to 35 ILCS 200/23-20;

4. Order that the Defendant, McHenry County Treasurer and Ex-Officio McHenry County Collector, refund each individual Plaintiff together with statutory interest; and

5. To grant such other relief as this Court deems just and appropriate.

### EXHIBIT A

### SUMMARIES OF TAX RATE OBJECTIONS

#### COUNT I – ALGONQUIN TOWNSHIP ROAD DISTRICT FAILURE TO ADOPT A VALID TAX LEVY

1. The Algonquin Township Road District is a municipal entity formed under the Illinois Highway Code, as well as the Illinois Township Code.

2. As an entity with the power to levy and collect *ad volerem* taxes, Algonquin Township Road District is subject to the Illinois Revenue Code, the Illinois Highway Code, the Illinois Township Code, the Property Tax Limitation and Extension Act (PTELL), as well as the common law which has evolved under the aforesaid statutes.

3. Not being home-rule, both Algonquin Township and the Algonquin Road District are subject to Dillon's Rule, which provides that the municipal entities can only do that which is authorized by statute.

4. With respect to taxation, a municipal entity must follow the established statutes precisely, and the Legislature's grant of authority to tax is to be strictly construed against a taxing district.

5. While the Algonquin Township Road District proposes a levy, it is the Township that votes on said levy.

6. In November of 2018, the Township Road District promulgated a levy and submitted the same to the Township.

7. The Township considered the Road District levy at its regularly scheduled meeting on December 12, 2018 and voted against the levy by a 2-1 vote.

8. The Township denied the levy ordinance proposed and submitted by the Road District on December 12, 2018.

9. The Algonquin Township Board has adopted Robert's Rules of Order with respect to its parliamentary proceedings.

10. With regard to a motion, ordinance or resolution which has been voted on and denied,

in order to consider the matter again, a member of the Board voting in the majority must seek to

reconsider the denial, according to Robert's Rules of Order.

11. Moreover, apart from its regularly scheduled meetings, a township board can only hold special meetings with two weeks' notice. 60 ILCS 1-35-5.

12. 60 ILCS 1-35-5 provides:

Special township meetings shall be held when the township board (or at least 15 voters of the township) file in the office of the township clerk a written statement that a special meeting is necessary for the interests of the township. The statement also shall set forth the objects of the meeting, which must be relevant to powers granted to electors under this Code. The special township meeting shall be held no less than 14 nor more than 45 days after the written request is filed in the office of the township clerk. Special township meeting may not begin before 6 p.m.

13. After the December 12, 2018 denial of the Township Road District levy, the Township published notice, on December 20, 2018, of a special meeting purportedly to be held on December 22,

2018.

14. This notice did not, and does not, conform to the aforesaid provision of the Illinois

Township Code.

15. At the December 22, 2018 meeting, the Township purported to adopt and otherwise

approve the Township Road District levy.

16. As a matter of law, the Township failed to approve the Road District levy at both

December meetings.

17. As an initial matter, the December 22, 2018 meeting was invalid under the Illinois Township Code.

18. In addition, the Road District levy had been voted down on December 12, 2018, by the Township at a validly held regular meeting.

19. In the event the Township wanted to reconsider its denial, and then move to adopt the levy submitted by the Township Road District, it needed to do so in conformance with Robert's Rule of Order.

20. At all times, the Township Road District levy ordinance was exactly the same. That is, the proposed ordinance that was denied on December 12, 2018 was exactly the same on December 22, 2018.

21. The only thing that changed was the Board of Trustees' vote on behalf of the Township Board.

22. Here, the Board failed to conform with the law as it pertains to meeting notice, and parliamentary voting procedures.

23. For these reasons, the entire Road District levy ordinance remains invalid as a matter of law, and those taxpayers listed on Exhibit B should be rebated the taxes paid to the Algonquin Township Road District.

24. It remains a precept in Illinois law that a taxing body seeking to levy taxes can only act in accordance with the laws and procedures established by the Illinois General Assembly.

25. As such, the illegal rate of .141705 should be rebated to those taxpayers listed within Exhibit B hereto.

WHEREFORE, Plaintiff Tax Objectors, pray that the Court consider the matters raised herein, find, determine and otherwise adjudicate the entire levies issued by Algonquin Township and the Algonquin Road District are illegal as a matter of law, order that the McHenry County Treasurer issue payments to the Tax Objector Plaintiffs of the entire amount levied upon the Objectors by said districts, and issue whatever further relief this Court deems just and equitable.

#### COUNT II – RILEY SCHOOL DISTRICT 18 EXCESSIVE ACCUMULATION – EDUCATION FUND

26. Riley School District 18 is a school district formed with the Illinois School Code.

27. At the end of its fiscal year on June 30, 2018, the Riley School District had a balance of \$7,351,489 in its Education Fund, according to the District's Comprehensive Audit.

28. However, the Comprehensive Audit is performed on a cash basis, and funds received after June 30, 2017 are not considered towards the balance of \$7,351,489.

29. Subsequent to June 30, 2018, District 18 received at least \$1,700,000 in tax revenue levied from the previous year.

30. The Education levy of \$3,300,000 is approximately 82% of the total levy.

31. The ending balance of \$7,351,489 in addition to \$1,700,000 leaves District 18 with at least \$9,051,489 for its Education Fund.

32. The average annual, three-year cost for the Education Fund was \$2,967,847.67, or 3.27 times the amount of the reserve balance of \$8,460,997 in the District's Education Fund.

33. In Illinois, it is well-settled that funds having over twice the annual average cost state a *prima facie* case of excess accumulation.

34. The 2018 levy rate of 2.768017 is illegal, excessive and void as a matter of law.

WHEREFORE, Plaintiff Tax Protestors, pray that the Court consider the matters raised herein, find, determine and otherwise adjudicate that the Education Fund levy adopted by Riley School District 18 is illegal, void and excessive as a matter of law, Order that the McHenry County Treasurer issue payments to the Tax Protestor Plaintiffs, award statutory interest pursuant to 35 ILCS 200/23-20, et. seq., and issue whatever further relief this Court deems just and appropriate.

#### COUNT III - RILEY SCHOOL DISTRICT 18 – TRANSPORTATION FUND EXCESSIVE ACCUMULATION

35. In 2018, Riley School District issued a levy for its Transportation Fund in the amount of \$8,000, or a rate of .007080.

36. In the three years previous, the average, annual cost for transportation purposes was \$326,849.

37. The balance of the Transportation Fund, as of June 30, 2018, was \$885,811 according to the District's own comprehensive audit.

38. This represents a <u>Miller</u> ratio of 2.61; that is, even without the total 2018 levied funds, District 18 had more than two times the amount necessary to meet its transportation costs for the upcoming fiscal year.

39. As such, the levy rate imposed for its Transportation Fund of .007080 is illegal, excessive and void as a matter of law.

WHEREFORE, Plaintiff Tax Protestors, pray that the Court consider the matters raised herein, find, determine and otherwise adjudicate that the Transportation Fund levy untaken by Riley School District 18 is illegal, void and excessive as a matter of law, Order that the McHenry County Treasurer issue payments to the Tax Protestor Plaintiffs, award statutory interest pursuant to 35 ILCS 200/23-20, et. seq., and issue whatever further relief this Court deems just and appropriate.

#### COUNT IV - RILEY SCHOOL DISTRICT 18 – OPERATIONS AND MAINTENANCE FUND EXCESSIVE ACCUMULATION

40. As of June 30, 2018, District 18 had \$1,344,374 in its Operations & Maintenance Fund ("O & M") Fund, according to its own audit.

41. According to its audits of 2016, 2017, and 2018, the average annual cost for purposes of O & M was \$119,586.

42. For its O & M Fund, as of June 30, 2018, the Riley School District has 6.73 times that which was necessary to meet the needs of the upcoming fiscal year.

43. The amount of money the District has remains excessive, thereby rendering the O & M levy of \$627,000, or the rate of .550000 illegal as a matter of law.

WHEREFORE, Plaintiff Tax Protestors, pray that the Court consider the matters raised herein, find, determine and otherwise adjudicate that the Highway Fund levy untaken by Riley School District 18 is illegal, void and excessive as a matter of law, Order that the McHenry County Treasurer issue payments to the Tax Protestor Plaintiffs, award statutory interest pursuant to 35 ILCS 200/23-20, et. seq., and issue whatever further relief this Court deems just and appropriate.

#### COUNT V - RILEY SCHOOL DISTRICT 18 – LIABILITY INSURANCE FUND EXCESSIVE ACCUMULATION

44. As of June 30, 2018, District 18 had \$128,688 in its Tort Fund, also known as Liability Insurance.

45. This does not include that portion of the 2018 levy not included in the audit.

46. The average annual cost for the District's Tort Fund, according to its last three audits,

was \$49,296.

47. The <u>Miller</u> ratio for the Tort Fund is therefore 2.61.

48. In other words, without even counting that portion of the 2018 levy, District 18 has over three times the amount necessary to pay its Tort Fund costs.

49. As such, the levy rate of .045736 is illegal, excessive and void as a matter of law.

WHEREFORE, Plaintiff Tax Protestors, pray that the Court consider the matters raised herein,

find, determine and otherwise adjudicate that the Highway Fund levy untaken by Riley School District 18

is illegal, void and excessive as a matter of law, Order that the McHenry County Treasurer issue

payments to the Tax Protestor Plaintiffs, award statutory interest pursuant to 35 ILCS 200/23-20, et.

seq., and issue whatever further relief this Court deems just and appropriate.
