Thank you for your call yesterday. I hope that we were able to answer your questions regarding the upcoming resurfacing project on IL Route 128. As discussed, the proposed paving will be an inlay of approximately 2.25 inches from IL 16 to 0.2 miles north of 6<sup>th</sup> Street. As the agreement on file for this portion of IL 128 indicates that maintenance responsibility for radius returns lies with the City (refer to the highlighted section in the attached agreement), we have invited Shelbyville to add the resurfacing of the 6<sup>th</sup> Street asphalt radius return to the upcoming project at the City's cost, conservatively estimated at approximately \$14,000 (the remaining radius returns within this project are concrete). As discussed with Mayor Johnson, the actual cost to the City for this radius return improvement will be the Contractor's bid price, which may be less than our estimate.







### AGREEMENT

This agreement, entered into this <u>K</u> day of <u>March</u>, A.D. 19<u>46</u>, by and between the STATE OF ILLINOIS, acting by and through its DEPARTMENT OF TRANSPORTATION hereinafter called the STATE, and the City of Shelbyville, in Shelby County, of the State of Illinois, hereinafter called the CITY.

#### WITNESSETH

WHEREAS, the STATE in order to facilitate the free flow of traffic and insure safety to the motoring public, is desirous of improving approximately 1.4 kilometers (0.87 mi.) of Cedar Street/Illinois Route 128 (F.A.P. Route 770), known as State Section 114(W-1,RS-2), as follows:

1. <u>47.2 meters (155 ft.) south of 1st Street to 350.5 meters (1,150 ft.) north of</u> 6th Street:

Widening and resurfacing the existing pavement to provide for two (2) 3.6 meter (12 ft.) through lanes and a 3.6 meter (12 ft.) bi-directional left turn lane, reconstructing entrances and side street approaches, constructing curb and gutter and a storm sewer system for highway drainage, replacing a portion of the City's storm sewer system that crosses under Illinois Route 128 at Sixth Street (A.R. Station 23+00), and by performing all other work necessary to complete this portion of the improvement.

- 2. <u>350.5 meters (1,150 ft.) north of 6th Street to 12th Street:</u> Omission from improvement
- 3. <u>12th Street to 190.5 meters (625 ft.) north of 15th Street:</u> Improving drainage by installing new drainage structures along the east ditch, regrading the east ditch, placing riprap around the existing 1.2 meter x 0.8 meters (4 ft. x 2.5 ft.) across road box culvert, and by performing all other work necessary to complete this portion of the improvement.

WHEREAS, the CITY is desirous of said improvement in that same will be of immediate benefit to the CITY's residents and permanent in nature;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

- 1. The STATE agrees to make the surveys, obtain all necessary rights-of-way, prepare plans and specifications, receive bids and award the contract, furnish engineering inspection during construction and cause the improvement to be built in accordance with the plans, specifications and contract.
- 2. The STATE agrees to pay all rights-of-way, construction and engineering costs.
- 3. It is mutually agreed by and between the parties hereto that the estimated cost and cost proration for this improvement is as follows:

- 4. The CITY agrees to adopt, prior to the STATE's advertising for the work to be performed hereunder, or continue to enforce an ordinance requiring that parking be prohibited on Cedar Street/Illinois Route 128 from Main Street (Illinois Route 16) to the north corporate limits of the City, a copy of which is attached hereto as "Exhibit A", and will in the future prohibit parking at such locations on or immediately adjacent to this improvement as may be determined necessary by the STATE from traffic capacity studies.
- 5. The CITY agrees to adopt, prior to the STATE's advertising for the work to be performed hereunder, an appropriate ordinance prohibiting the discharge of sanitary sewage and industrial waste water into any storm sewers constructed as a part of this improvement, a copy of which is attached hereto as "Exhibit B".
- 6. The CITY agrees to provide prior to the STATE's advertising for the work to be performed hereunder approval of the plans and specifications as prepared, by resolution or letter.
- 7. The CITY agrees not to permit driveway entrance openings to be made in the curb as constructed, without the consent of the STATE.

- 8. The CITY shall exercise its franchise right to cause private utilities to be relocated at no expense to the STATE.
- 9. The CITY agrees to cause its utilities located on right of way acquired by the State or installed within the limits of a roadway after the said roadway was taken over for maintenance by the State, to be relocated and/or adjusted at no expense to the State.
- 10. Upon final inspection of the improvement and so long as Cedar Street/Illinois Route 128 is used as a State highway, the STATE agrees to maintain or cause to be maintained, within the CITY's corporate limits, the through traffic lanes, the bi-directional left turn lane, the curb and gutter and shoulders adjacent to those through traffic lanes, and the open ditch cross section within STATE right of way.
- 11. Upon final field inspection of the improvement, the CITY agrees to maintain or cause to be maintained, within the CITY'S corporate limits, those portions of the improvement which are not maintained by the State including the entire right-of-way behind the curb and gutter, sidewalks, intersecting sidestreets and their adjacent curb and gutter, crosswalk and stopline markings, CITY owned utilities including appurtenances thereto, highway lighting including furnishing the electrical energy therefore, and shall maintain the storm sewers and appurtenances by
  - A. Storm sewer for STATE highway drainage only:

Performing those functions necessary to keep the sewer in a serviceable condition including cleaning sewer lines, inlets, manholes and catch basins along with the repair or replacement of inlets, manholes and catch basins, including frames, grates or lids, plus structural failures in the storm sewer of 12 feet or less in length. The maintenance, repair and/or reconstruction of storm sewer constructed as part of this improvement beyond the aforedescribed responsibilities shall be that of the STATE.

B. Storm Sewer for CITY drainage only:

The maintenance, repair and/or reconstruction of storms constructed as part of this improvement shall be the complete responsibility of the CITY.

12. Prior to the STATE advertising for work to be performed hereunder, the disposition of encroachments will be cooperatively determined with representatives from the CITY and the STATE.

The CITY agrees to adopt, prior to the STATE's advertising for the work to be performed hereunder, or continue to enforce, an appropriate ordinance relative to the disposition of encroachments and prohibiting, in the future, any new encroachments within the limits of the improvements, a copy of which is attached as "Exhibit C".

13. This agreement and the convenants contained herein shall be null and void in the event the contract covering the construction work contemplated herein is not awarded within three years subsequent to execution of the agreement.

This agreement shall be binding upon and to the benefit of the parties hereto, their successors and assigns.



#### ORDINANCE NO. 96-2

#### AN ORDINANCE AMENDING THE CITY CODE IN RELATION TO CERTAIN CITY IMPROVEMENTS

WHEREAS, the City Council of the City of Shelbyville has determined that certain changes be made in the City Code regarding the improvements to the Cedar Street/Illinois Route 128 as a part of the City's Agreement with the Illinois Department of Transportation regarding said improvements;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHELBYVILLE, ILLINOIS:

SECTION I: That the City Code of the City of Shelbyville, regarding storm sewer useage, be, and the same is hereby amended by the addition thereto of a paragraph (D) to Section 5 of Chapter 2 of Title 5, as follows:

It shall be unlawful for any person, firm or "(D) corporation to connect or cause to be connected any drain carrying or to carry any toilet, sink, basement, septic tank, cesspool, industrial waste or any fixture or devise discharging polluting substances into any specifically designated storm sewer, including, without otherwise limiting the same, that storm sewer constructed as a part of the improvement of Main Street from Spruce Street (Station 1016+8.75) intersection State Section 12 (W-1, RS-5) to Shelby County Airport Road, (Station 905+63) and as a part of the improvement of Cedar Street/Illinois Route 128 (F.A.P. Route 770) known as State Section 114 (W-1, RS-2) from 115 feet South of North First Street to 1,150 feet North of North Sixth Street."

SECTION II: That the City Code of the City of Shelbyville, regarding prohibited parking, be, and the same is hereby amended by the addition thereto of the following paragraphs to Paragraph 10 of Section 1 of Chapter 3 of Title 8, as follows:

"The east and west side of Cedar Street from the North side of the intersection of Cedar Street with Main Street north to the north right of way line of North Fifteenth Street shall have no parking at any time."

"The north and south side of Main Street from Cedar Street east to the east side of Walnut Street shall have no parking at any time."

"The north and south side of Main Street from the east side of Washington Street on the east side of the Courthouse to the east corporate limits of the City of

Shelbyville shall have no parking at any time."

SECTION III: That the Chief of Police is hereby directed to install and maintain such regulatory signs as required by Section 8-5-10 of the City Code of the City of Shelbyville.

SECTION IV: This ordinance shall be effective from and after ten (10) days of its passage and publication as provided by law and upon posting of the regulatory signs.

#### PENALTY

SECTION:

1=3=1:	Penalty
1-3-2:	License
1-3-3:	Application
1-3-4:	Lizbility of Officers

1-3-1: <u>**PENALTY:**</u> Any person convicted of a violation of any Section of this City Code shall be fined in a sum not to exceed Five Hundred Dollars (\$500.00) for any one offense and the person may be confined in an institution other than a penitentiary for a period not to exceed Six (6) Months.

1-3-2: LICENSE: When a person is convicted of a violation of any Section of this City Code, any license previously issued to him by the City may be revoked by the court or by the Governing body.

1-3-3: <u>APPLICATION:</u> The penalty provided in this Chapter shall be applicable to every Section of this City Code the same as though it were a part of each and every separate Section. Any person convicted of a violation of any Section of this City Code where any duty is prescribed or obligation imposed, or where any act which is of a continuing nature or declared to be unlawful, shall be deemed guilty of a misdemeanor. A separate offense shall be deemed committed upon each day such duty or obligation remains unperformed or such act continues, unless otherwise specifically provided in this City Code.

In all cases where the same offense is made punishable or is created by different clauses or Sections of this City Code the prosecuting officer may elect under which to proceed; but not more than one recovery shall be had against the same person for the same offense; provided, that the revocation of a license or permit shall not be considered a recovery or penalty so as to bar any other penalty being enforced.

The West side of Pine Street from South First Street to the North side of the Medical Center Parking Lot entrance shall have no parking at any time.

(THE ABOVE PARAGRAPH WAS ADDED BY ORDINANCE NO. 91-1 ADOPTED MAY 6, 1991.)

There shall be no parking at anytime on the west, south or east side of the Public Square south of the Courthouse.

The following described parking lots are also limited parking zones as therein described:

The West one-half of the lot at the corner of Broadway and South First Streets.

The lots to the west and northwest of the Courthouse between Main and North First Streets.

The lots to the west and northwest of the Courthouse shall not permit overnight parking.

To the rear of the fire station shall be reserved parking only.

The lot at the intersection of South Broadway and South First Streets shall be reserved parking on the east half, provided that all reserved parking shall be applicable only between the hours of 8:00 a.m. and 6:00 p.m. on every day of the week except Sunday.

8-4-2: <u>METHOD OF PARKING:</u> The commissioner of Public Health and Safety shall cause lines or markings to be painted or placed upon the curb and/or upon the street adjacent to each parking space for the purpose of designating the parking spaces in the limited parking zones. It shall be unlawful and a violation of this Ordinance to park any vehicle across any such line or marking or to park said vehicle in such position that the same shall not be entirely within the area so designated by such line or markings. All vehicles shall be parked parallel or diagonal with the adjacent curb or sidewalk, as parking spaces indicate.

8-4-3: <u>LENGTH OF PARKING AREAS:</u> Where parking space is designated by lines for parallel parking, the space provided for each vehicle shall be approximately twenty (20) feet in length, excepting at the corners and intersections of streets where the space may be increased or decreased slightly to provide additional parking space; and where diagonal parking is indicated .

by lines, the space for each vehicle shall be approximately eleven (11) feet, except at intersections of streets where a slight variation can be provided for; that street intersections and corners where parking is prohibited, or other places in said limited parking zones where parking is prohibited, the curb shall

8-4-5: **PARKING OVERTIME:** It shall be unlawful for any such vehicle to be continuously parked at one location in any limited parking zone or lot as herein described for a period of time in excess of two (2) hours between the hours of 2:00 a.m. and 5:00 p.m.

8-4-6: <u>PENALTY:</u> Any person who shall permit a vehicle to be continuously parked at one location in any limited parking zone for a period of time in excess of two (2) hours shall render the owner thereof liable for a penalty of Three Dollars (\$3.00); the failure of such owner to make such payment within forty-eight (48) hours shall render said owner liable for a penalty of Five Dollars (\$5.00). Failure to pay within seven (7) days shall subject the violator to the penalties as provided in Chapter 3 of Title 1 of the City Code.

7-6-1: <u>DEFINITIONS</u>: Whenever the following words or terms are used in this chapter, they have the meanings herein ascribed to them, unless the content makes such meaning repugnant thereto.

<u>Roadway Right-of-Way</u> is defined as those areas existing or acquired by dedications or by fee simple for highway purposes; also, the areas acquired by temporary easement during the time the easement is in effect.

<u>Project Right-of-Way</u> is defined as those areas within the project right-of-way lines established jointly by the City, State and the Federal Highway Administration which will be free of encroachments except as hereinafter defined.

<u>Encroachment</u> is defined as any building, fence, sign or any other structure or object of any kind (with the exception of utilities and public road signs), which is placed, located or maintained, in, on, under, or over any portion of the project right-of-way or the roadway right-of-way where no project rightof-way line has been established.

<u>Permissible Encroachment</u> is defined as any existing awning, marquee, advertising sign or similar overhanging structure supported from a building immediately adjacent to the limits of the platted street where here is a sidewalk extending to the building line and which does not impair the free and safe flow of traffic on the highway, the permissive retention of overhanging signs is not to be construed as being applicable to those signs supported from poles constructed outside the project right-of-way line and not confined by adjacent buildings.

<u>Construction Easement Area</u> is defined as the area lying between the project right-of-way limits and the platted street limits within which the City, by concurrence in the establishment of the project right-of-way lines, will permit the State to enter and perform all necessary construction operations. **7-6-2: ENCROACHMENTS PROHIBITED:** It shall be unlawful for any persons, firm or corporation to erect or cause to be erected, to retain or cause to be retained, any Encroachment as hereinabove defined, within the limits of the project right-of-way or roadway right-of-way where no project right-of-way lines have been established.

**7-6-3: <u>PENALTIES:</u>** The violation of the provisions of this Ordinance as hereinabove provided shall be punishable by the penalties as provided by Title 1, Chapter 3 of the City Code of the City of Shelbyville, Illinois.

The District has completed its review of the draft Ordinance for the City/State Agreement for the subject section. The following is a list of comments made by the District:

- 1. Section I should be revised as indicated in red on the attached copy of the draft Ordinance.
- 2. Section II should be revised as indicated in red on the attached copy of the draft Ordinance.

The District's revision to this section requires the City to revise its limits of no parking on the north and south side of Main Street to include the area from Long Street to the east line of Walnut Street. This area was omitted from the City's Ordinance No. 90-8 which was passed prior to the improvement of Main Street in 1992. The City committed to prohibit parking in this area, to provide for the three (3) lane roadway that was constructed as part of the Main Street improvement. This area has been the site of an accident involving a collision with a vehicle parked in a thru traffic lane. Although no serious injuries occurred, it is the District's opinion that this is the time to act to prohibit the parking of vehicles in the thru traffic lanes of Main Street. Should the City elect not to revise this portion of Section II, the District requests that it be removed from the draft Ordinance needed for the Cedar Street (IL 128) improvement north of Main Street. We request that the City resolve this issue and pass a separate Ordinance that will include the prohibiting of parking in this specified area. Until an ordinance is passed, the District requests that the City monitor this area of Main Street and enforce, in accordance with Section 5/11-1302 of the "Illinois Vehicle Code", that no parking of vehicles be permitted in the thru traffic lanes in an effort to eliminate future accidents.

#### AN ORDINANCE AMENDING THE CITY CODE IN RELATION TO CERTAIN CITY IMPROVEMENTS

WHEREAS, the City Council of the City of Shelbyville has determined that certain changes be made in the City Code regarding the improvements to the Cedar Street/Illinois Route 128 as a part of the City's Agreement with the Illinois Department of Transportation regarding said improvements;

A meeting was held with representatives of the City of Shelbyville to discuss several issues concerning the upcoming Route 128 project. Those in attendance were:

Lowell Goldman - Mayor Brett Shull - Water Department Dave Carviston - Street Department Bill Wilson - Sewer and Sanitation Department Bob Bruce Ray Moore

The issues discussed were:

1. <u>Drainage at North First St.</u>: We showed the City the plans for drainage and explained that we were using the existing 18" and 12" storm sewer pipes to drain water from approximately North Second St. back to North First St. The City didn't have a problem with this, although they were concerned with getting too much water into their system faster than it is getting there now, causing it to back up. We told them that the <u>same amount of water</u> going into the system now, would be going into the system when construction is completed.

3. <u>Storm Sewer at Sixth St.</u>: We explained to the City our intent to remove and replace the existing 12" storm sewer pipe under Route 128 for a distance of approximately 120'. This pipe is currently plugged or collapsed. We told the City that it was their responsibility to ensure that beyond the point we were replacing, that the pipe was working and that the outlet end was unplugged.


**NOTE:** After the meeting, Bob Bruce and I inspected the down-stream end out the outlet pipe and concluded that the City will have to clean the ditches in order to ensure proper flow.

- 4. <u>Sanitary Sewer under Sixth St.</u>: The City informed us that a 6" Sanitary Sewer is in place, from the REA Building, in the Northwest quadrant, to a sanitary manhole, in the southeast quadrant. They said that REA may want to replace this line while Sixth St. is under construction. This work would be at REA's expense and done with City forces. We told them that we would notify our R.E. of this.
- 5. The City said that someone had told them that the State was putting the storm sewer on the west side of the road on top of their sanitary sewer. We told them that this was an erroneous rumor.
- 6. We informed the City of our proposed 3-30" pipes under 15th Street and the new ditch between 15th Street and 13th Street. They agreed with our proposal.

#### LETTER OF INTENT

This Letter of Intent is agreed to in principle by the City of Shelbyville and the Illinois Department of Transportation for the improvement of Illinois Route 128 from IL 16 to north of North Sixth Street. These items will be the basis for a formal City-State Agreement that will be prepared during final plan preparation.

#### I. MAINTENANCE

- A. State: The State will maintain the through traffic lanes, turn lane, and the curb-and-gutter next to the through lanes.
- B. City: The City will maintain the storm-sewer system, the remaining right-of-way behind the curb, and the street returns.

#### II. PARKING

A. The City will pass a no-parking ordinance for the entire project.

#### III. SEWER

- A. The City will pass an ordinance prohibiting the discharge of sewage or industrial waste water into any existing or proposed storm-sewer.
- IV. ENCROACHMENTS: The City will prohibit future encroachments on the right-of-way. If it is decided any existing encroachments may remain, the City will pass an ordinance issuing a revocable permit for them.
- V. DRIVEWAY PERMITS: All driveway permits will be forwarded to the State for issuing.

### VI. DIVISION OF COST

A. The State will make the surveys, prepare plans and specifications, obtain all right-of-way, receive bids and award the contract, furnish engineering inspection during construction, and cause the improvement to be built in accordance with the plans, specifications, and contract. The State will pay the entire cost of the project, except as noted below:

7-2-1: <u>GENERAL SUPERVISION:</u> All maintenance and repair of public streets, alleys, sidewalks and other public ways shall be under the supervision of the commissioner of streets and public improvements. He shall be charged with the enforcement of all ordinance provisions relating to such public places (except traffic ordinances) and is hereby authorized to enforce such ordinance provisions.

7-2-2: <u>CONSTRUCTION:</u> It shall be unlawful to construct or lay any pavement on any public street, sidewalk, alley or other public way, or to repair the same, without having first secured a permit therefor. Applications for such permits shall be made to the City Clerk, and shall state the location of the intended pavement or repair, the extent thereof, and the person or firm who is to do the actual construction work. No such permits shall be issued except where the work will conform to the ordinances of the City.

7-2-3: <u>BOND:</u> Each applicant shall file a bond in the amount of twice the value of the proposed improvement with surety to be approved by the commissioner of streets and public improvements conditioned to indemnify the City for any loss or damage resulting from the work undertaken or the manner of doing the same.

7-2-4: <u>SPECIFICATIONS:</u> All street and sidewalk pavements shall be made in conformity with specifications laid down or approved from time to time by the City Council.

7-2-5: <u>INJURY TO NEW PAVEMENTS</u>: It shall be unlawful to walk upon or drive any vehicle or animal upon, or injure any newly laid street or sidewalk pavement while the same is guarded by a warning sign, barricade, or to knowingly injury any soft or newly laid pavement.

7-2-6: <u>REPAIRS:</u> All public streets, alley and sidewalk pavements shall be in good repair. Such repair work, whether done by the City or by the abutting owner, shall be under the supervision of the commissioner of streets and public improvements.

7-2-7: <u>DEFECTS:</u> It shall be the duty of every city officer and employee becoming cognizant of any defect in any street, alley or sidewalk, or any obstruction thereof, to repair the same to the commissioner of streets and public improvements as soon as possible.

7-2-8: <u>OBSTRUCTIONS:</u> It shall be unlawful for any person, firm or corporation to cause, create or maintain any obstruction of any street, alley, sidewalk or other public way, except as may be specified by ordinance or by the commissioner of streets and public improvements.

7-2-9: <u>BARRICADES:</u> Any person, firm or corporation laying or repairing any pavement on a street, sidewalk or other public place or making an excavation in the same, shall maintain suitable barricades to prevent injury of any person or vehicle by reason of the work; such barricades shall be protected by a light at nighttime.

Any defect in any such pavement shall be barricaded to prevent injury; and any person, firm or corporation properly maintaining any opening or excavation while the same remains open shall guard the same with proper barricades and lights. 7-2-10: <u>DISTURBING BARRICADES</u>: It shall be unlawful to disturb or interfere with any barricade of lights lawfully placed to protect or mark any new pavement or excavation or opening in any public street, alley or sidewalk.

7-2-11: <u>PRIVATE USE:</u> It shall be unlawful for any person, firm or corporation to use any street, sidewalk or other public place as space for the display of goods or merchandise for sale, except as may be permitted from time to time by the City Council.

7-2-12: <u>ENCROACHMENTS</u>: It shall be unlawful to erect or maintain any building or structure which encroaches upon any public street or property.

7-2-13: <u>DRAINS:</u> It shall be unlawful to obstruct any drain in any public street or property.

7-2-14: **POLES AND WIRES:** It shall be unlawful to erect any poles or wires or maintain any poles or wires over any public place, street, alley or other public way without having first secured permission from the City Council.

7-2-15: <u>GAMES:</u> It shall be unlawful to play any games upon any street, alley or sidewalk or other public place, where such games cause unnecessary noise or interfere with traffic or pedestrians.

7-2-16: <u>OPENINGS</u>: It shall be unlawful to construct or maintain any opening or stairway in any public street or sidewalk or alley without a permit from the City Council. All such lawfully maintained openings shall be guarded by a suitable strong cover or railing, to the approval of the commissioner of streets and public improvements.

7-2-17: <u>PLANTING:</u> It shall be unlawful to plant any tree or bush in any public street or parkway or other public place without having secured a permit therefor. Applications for such permits shall be made to the City Clerk and referred by him to the commissioner of streets and public improvements before issuance. All trees and shrubs so planted shall be placed subject to the direction and the approval of the City Council. No rock gardens, boulders, benches, or fences shall be built or maintained in any parkway, except by the City or with the permission of the City Council.

7-2-18: <u>REMOVAL</u>: It shall be unlawful to remove or cut down any tree or shrub in any such place without having secured a permit therefor. Applications for such permits shall be made to the City Clerk and shall be referred to and approved by the commissioner of streets and public improvements before issuance.

7-2-19: <u>INJURY:</u> It shall be unlawful to injure any tree or shrub planted or growing in any such public place. 7-2-20: <u>ADVERTISEMENTS-NOTICES</u>: It shall be unlawful to attach any sign, advertisement or notice to any tree or shrub in any such public place.

7-2-21: DANGEROUS TREES: Any tree or shrub which overhangs any sidewalk, street or other public place in the City in such a way as to impede or interfere with traffic or travel, or within ten feet of a street or seven feet of a sidewalk level, shall be trimmed by the owner of the premises abutting or of the premises on which such tree or shrub grows so that the obstruction shall cease.

Any tree or limb of a tree which has become likely to fall on or across any public way or place shall be removed by the owner of the premises on which such tree grows or stands.

The commissioner of streets and public improvements may trim any such tree or shrub or remove any such tree or branch thereof so that the obstruction or danger to traffic or passage shall be done away with.

7-2-22: WIRES: It shall be unlawful to attach any wire or rope to any tree or shrub in any public street, parkway or other public place without the permission of the City Council. Any person or company which maintains poles and wires in the streets, alleys or other public places, shall, in the absence of provision in the franchise concerning the subject, keep such wires and poles free from and away from any trees and shrubs in such places as far as may be possible, and keep all such trees and shrubs near such wires and poles properly trimmed, subject to the supervision of the commissioner of streets and public improvements, so that no injury shall be done either to the poles or wires or to the shrubs and trees by their contact.

7-2-23: <u>GAS PIPES:</u> Any person or company maintaining any gas pipe in the City shall keep such pipes free from leaks so that no injury shall be done thereby to any trees or shrubs.

7-2-24: <u>EXCAVATIONS:</u> In making excavations in streets or other public places proper care shall be taken to avoid injury to the roots of any tree or shrub, wherever possible.

7-2-25: <u>DEPOSITS ON STREETS</u>: It shall be unlawful to deposit on any street any material which may be harmful to the pavement thereof, or any waste material, or any glass, or other articles which may do injury to any person, animal or property.

7-2-26: <u>DEPOSITS ON SIDEWALKS</u>: 'It shall be unlawful to deposit on any public sidewalk any material which may be harmful to the pavement thereof, or any waste material, or any glass or other articles which might cause injury to persons, animals or property. Merchandise or other articles may be deposited on sidewalks preparatory to delivery, provided that the usable width of the sidewalk is not thereby reduces to less than four feet; and provided that no such article shall remain on such walk for more than one-half hour.



Building projects must meet applicable building codes and historic buildings must be in conformance with the Secretary of Interior's Standards for Historic Preservation. For more information on building and historic projects, please contact the IHPA Division of Preservation Services (Appendix 3). The requirements of the current Americans with Disabilities Act (ADA) must be met where applicable. For more information on design policies and procedures, please contact the District Local Roads and Streets Enhancement Coordinator (Appendix 2).
- ✓ New or modified bridges, with a clear span greater than 10 feet or with an opening greater than 100 square feet will require a preliminary design report and a hydraulic report if necessary. When a preliminary design report must be submitted for a project that modifies an existing bridge as part of an enhancement project, a bridge condition report (BCR) will be required including a hydraulic report if required. All new and modified bridges will be designed to the applicable sections of the AASHTO Standards Specification for highway bridges or appropriate AASHTO Guide Specification. These reports must be approved by the Bureau of Bridges and Structures before proceeding with PE II.
- ✓ Public involvement requirements will be determined based on the nature of the project.
- ✓ District coordination meetings with the sponsor will be held as necessary.
- ✓ A project report must be prepared for each project. This report will be used to obtain environmental approval from FHWA. It will also be used for IDOT approval of the design concepts for the project. The department must approve the project report.
- ✓ Section 4(f) evaluations may be required for projects using lands from public parks, recreational and wildlife areas and from historic properties. Section 106-4f documentation will be required for projects affecting historic properties. These policies are in the IDOT Bureau of Local Roads and Streets Manual, Chapters 18 and 19.

#### Engineering (PE II)

As the project proceeds through the PE II phase, the following areas must be evaluated. Four to twelve months are typical time periods required to accomplish PE II.

- ✓ After environmental and design approval is received, the local sponsor can begin to prepare the final plans and specifications for the project in accordance with the appropriate design policies and approved project report.
- All permits must be obtained by the local sponsor before advertising the letting for the construction contract (examples include IDNR Office of Water Resources and Corps of Engineers permits). The need for these permits must be identified during PE I.





#### RESOLUTION PROVIDING FOR AN IMPROVISIENT OF MAIN STREET (STATE BOND ISSUE ROUTE 16) IN SHELBYVILLE, SHELBY COUNTY, ILLINOIS

WHEREAS, the City of Shelbyville, hereinafter called the City, and the Division of Highways, Department of Public Works and Buildings of the State of Illinois, hereinafter called the State jointly propose to improve portions of Main Street for a distance of 4010.8 ft., and

WHEREAS, it has been determined that the improvement should consist of:

1. Widening the existing 32 ft. brick pavement to a width of 40 ft. face to face of curbs from Vine Street to Walnut Street with Portland Cement Concrete pavement.

2. Resurfacing the existing brick pavement with Bituminous Concrete Surface Course, Fine Dense-Graded Aggregate Type, 12 inches thick, the existing pavement being 32 ft. wide from Vine Street to Walnut Street, 40 ft. wide from Walnut to Broadway, 54 ft. wide from Broadway to West Washington and 44 ft. wide from West Washington to East Washington Street; together with the construction of curb and gutter, underground drainage facilities and appurtenances and the adjustment of sidewalks, driveways and public or private utilities and other items of work as shown on the plans to be prepared by the Division of Highways and to be designated as Section 12 RS-1, State Bond Issue Route 16, and

WHEREAS, upon completion of the improvement the State will maintain the surface f two traffic lanes, each eleven (11) ft. wide and lying on each side of the centerline.

THEREFORE, BE IT RESOLVED by the City Council of the City of Shelbyville that if the improvement as heretofore described is constructed soley by and at the entire expense of the State, the City hereby:

1. Agrees to participate in the cost of the improvement to the extent of \$15,500.

2. Requests and authorizes the Department of Finance, upon notification from the Department of Public Works and Buildings, to deduct and pay to the Department of Public Works and Buildings, from moneys allotted or to be allotted to the City under the provisions of the Motor Fuel Tax law, the sum of Three Hundred thirtyfive (\$335.00) dollars each month, said payments to begin October 1, 1952 and to continue until the total amount of \$15,500 is paid.

3. Agrees, upon completion of the improvement, to maintain all pavement outside the two traffic lanes, curbs, gutter flags, manholes, catch basins, storm severs and other utilities and appurtenances located within the limits of the street or right of way.

4. Agrees to adopt and put into effect, before award of the contract, an ordinance stating that all parking will be parallel to the curbs on the said Street, and


Alan,

We are planning on starting the construction of the Main Street Streetscape Project in the spring of 2019. This project will require the replacement of the sidewalk located in front of your business entrance.

We have recently been directed by the Illinois Department of Transportation the following:

Where there are recessed entrances off the public right-of way, Local Public Agencies (i.e. the City) <u>must</u> contact each property owner and see if they want to upgrade during the project <u>at their expense</u>. It is important to document the contact and the property owner's responses. While state and federal tax dollars should not be spent off right-of-way on private property, changes made by the project should not preclude the property owner from becoming compliant in the future.

Upgrading would involve removing and replacing the existing concrete entrance to your doorway in order to have a level landing (i.e. less than 2% slope in all directions). This criteria is found in the American Disability Act (ADA). If you want to upgrade your business entrance we will revise the project construction documents to reflect that upgrade.
