**DEFENDANTS' (CYNTHIA BRZANA, CONNIE HALE FORSYTE,
BECKY BECKER AND KIRK ALLEN)
MOTION FOR ATTORNEY FEES**

Now Comes CYNTHIA BRZANA, CONNIE HALE FORSYTE, BECKY BECKER
AND KIRK ALLEN (COLLECTIVELY HEREIN AS “DEFENDANTS”), by and through their
attorney Robert T. Hanlon, with their motion to for attorney fees under the Citizen Participation
Act, 735 ILCS 110/25 and state as follows:

INTRODUCTION:

1) The Citizen Participation Act (“CPA”) commands this court award of attorney
fees when a defendant is successful on a motion to dispose of the judicial claim under the CPA.
In particular, 735 ILCS 110/25 provides:

Sec. 25. Attorney's fees and costs. The court shall award a moving party who
prevails in a motion under this Act reasonable attorney's fees and costs
incurred in connection with the motion.

- 2) On July 31, 2020, This Court granted Defendants’ Motion to Dismiss
Pursuant to the Illinois Citizen Participation Act.
- 3) The Prayer for relief granted by this Court allowed the Defendants their
reasonable attorney fees and leave to file a motion for attorney fees and costs.
- 4) Defendants expended \$231 in filing fees in appearing in this case.
- 5) Defendants also expended \$16,987.25 securing the dismissal under the CPA

- 6) Defendants incorporate the Memorandum of Law filed in support of their motion for Attorney fees under the Citizen Participation Act as if fully set forth herein.

Wherefore, CYNTHIA BRZANA, CONNIE HALE FORSYTE, BECKY BECKER AND KIRK ALLEN ask that this Court to award them and their counsel, Robert T. Hanlon \$16,987.25 in attorney fees and \$231 in costs from Plaintiff John Norton.
