PETITION FOR APPOINTMENT OF SPECIAL ATTORNEY FOR THE STATE PURSUANT TO SECTION 3-9008 (55 ILCS 5/3-9008)

Now come the Petitioners, Mervin Wolfe, Pro Se, and Gregory Shearod, Oliva Jones, Timothy Jones, Tim Olson, Kristina Olson, Alyssa Karras, Joseph Respondi, et. al. pursuant to 55 ILCS 5/3-9008 Petition this Court for the appointment of a special attorney **not** from the Illinois Appellate Prosecutors Office for the State to prosecute certain individuals for felonious actions not barred by any applicable statute of limitations, stating in support thereof:

COUNT I

- The Petitioners have discovered evidence of multiple felonies which were committed and aided and abetted by attorney Jesse Danley and Ronda Parker. These individuals have used their public office for personal gain and to cause harm.
- That Illinois Criminal Code provides Official Misconduct is an act is performed in one's official capacity if it is accomplished by exploitation of his public position. People v. Lynn, 223 Ill.App.3d 688, 691, 166 Ill. Dec. 182, 585 N.E.2d 1204 (1992)
- 3. The Petitioners asserts that a series of actions and omissions by design have

been committed by public officers, Jesse Danley and Ronda Parker, both Coles county employees, in their official capacities, in violation of Illinois law and have individually and jointly:

- (a) Intentionally or recklessly failed to perform a mandatory duty as required by law and knowingly performed a series of acts which they knew, or should have known is forbidden by law to perform; and/or
- (b) have performed a series of acts in excess of their lawful authority with intent to obtain a personal advantage for themselves or others; and
- (c) have solicited and knowingly accepted for the performance of unauthorized acts, a fee or reward which they knew were not authorized by law.
- (d) Mr. Danley, as a public officer and a county employee of a law enforcement agency, has committed misconduct in that Mr. Danley knowingly used and communicated, directly and indirectly, confidential information about the Claimant, acquired in his capacity as the SA, to obstruct, impede, or prevent his own personal liability in a civil matter.
- (e) Mr. Danley, as a public officer and a county employee of a law enforcement agency, has directly communicated information gained from a confidential resource while participating or aiding law enforcement in an ongoing investigation, and disclosed it for personal gain.

Facts In support of Allegations of Abuse of Office for Personal Gain

4. That CCSA Jesse Danley committed or caused to commit a series of acts in excess of his lawful authority: by employing deceit and concealment, knowingly violating the Illinois Criminal Code. The purpose of Mr. Danley's actions were to obtain money, property, and /or free services from the State of Illinois. Mr. Danley has and continues to use the full weight and authority of his appointed State's Attorney's Office to avoid the payment or loss of money

and to secure a business and professional advantage. Mr. Danley has occupied and used his position of responsibility and trust in local government, the legal profession, and the judiciary for personal gain and to cause injury in violation of Illinois Law. Mr. Danley has wrongfully converted county resources for personal gain. The State's Attorney Jesse Danley has from July, 2019 until present using the Coles County State's Attorney's Office and its staff and resources as his personal office in support of the civil litigation In Re: 2019-SC-583, Wolfe vs Danley. (See Attached Exhibits Voice Mail, power of attorney for IDNR), specifically: (FOIA response dated)

- 5. That Ronda Parker has and continues to use the full weight and authority of her employment with the Coles County State's Attorney's Office to secure a business and professional advantage. Ronda Parker has occupied and used her position of responsibility and trust in local government, the legal profession, and the judiciary for personal gain and to cause injury in violation of Illinois Law. Ronda Parker has wrongfully converted county resources for personal gain. Ronda Parker has aided and abetted Jesse Danley use of the Coles County State's Attorney Office from September 2019 until present and its staff and resources as her personal office in support of her court appointed medication practice. (See Attached Order and Email Ronda Parker to IDNR)
 - 6. That the Petitioners are all are residents of the State of Illinois.
- 7. Section 3-9008 (55 ILCS 5/3-9008) allows this Court to appoint some competent attorney to prosecute whenever the States Attorney is "sick or absent, or unable to attend, or is interested".
- 8. In this instance, Coles County States Attorney Jesse Danley has admitted there is a conflict of interest with Petitioner Mervin Wolfe and attempted to refer the matter to the Illinois Appellate Prosecutors Office, twice. See In re Mortimer, 44 Ill.App. 249, 358 N.E. 2d 92 (1 Dist. 1976). The referral by States Attorney Jesse Danley infers the conflict of interest with the Petitioner. In addition, Mr. Danley is the <u>target</u> of the

criminal allegations by the Petitioners.

- 9. Insofar as Section 3-9008 contemplates an appointment limited to causes or proceedings in which the States Attorney is disqualified (Aiken v. County of Will, 321 Ill.App.171, 52 N.E. 2d 607 (2 Dist. 1943)), Petitioners propose that the appointment be for the prosecution of theft of government services, mail fraud, wire fraud, conspiracy to defraud by mail, obstruction of justice and official misconduct, as warranted, against Jesse Danley and Ronda Parker, as a result of further investigation, this Court may reconsider the prosecutor's scope of authority. In re Appointment of Special Prosecutor, 388 Ill.App. 3d 220, 902 N.E. 2d 730 (3 Dist. 2009).
- 10. The appointment sought may be at any stage of a case, including the period prior to formal charging (Baxter v. Peterlin, 156 Ill.App. 3d 564, 509 N.E. 2d 156 (3 Dist. 1987)).
- 11. Petitioners, as private citizens and in their position as tax payers and citizens harmed by the actions they attribute to the suspects identified herein, have standing to petition the court to appoint a special attorney. Baxter v. Peterlin, 156 Ill.App. 3d 564, 509 N.E. 2d 156 (3 Dist. 1987).
- 12. Petitioner(s) have turned the matter over to law enforcement and the matters are currently being handled by the Illinois State Police.
- 13. Although not required, a copy of this Petition is being served upon States Attorney Jesse Danley, as States Attorney and agent for the County of Coles. No formal responsive pleading is required.

WHEREFORE, Petitioners pray that this Court appoint a Special Attorney For The State pursuant to Section 3-9008 for the purposes set forth herein.

- 1. The Petitioners have discovered evidence of multiple felonies which were committed by ASA Brady Allen and aided and abetted by SA Jesse Danley. These individuals have used their public office for personal gain and to cause irreparable harm to an unknown number of female defendants who have been and are being sexually exploited.
- 2. That Illinois Criminal Code provides Official Misconduct is an act is performed in one's official capacity if it is accomplished by exploitation of his public position. People v. Lynn, 223 Ill.App.3d 688, 691, 166 Ill. Dec. 182, 585 N.E.2d 1204 (1992)
- 3. The Petitioners asserts that a series of actions and omissions by design have been committed by public officers, ASA Brady Allen and aided and abetted by Coles County States Attorney Jesse Danley, both Coles county employees, in their official capacities, in violation of Illinois law and have individually and jointly:
 - (a) Intentionally or recklessly failed to perform a mandatory duty as required by law and knowingly performed a series of acts which they knew, or should have known is forbidden by law to perform; and/or
 - (b) have performed a series of acts in excess of their lawful authority with intent to obtain a personal advantage for themselves or others; and
 - (c) have solicited and knowingly accepted for the performance of unauthorized acts, a fee or reward which they knew were not authorized by law.
 - (d) ASA Allen, as a public officer and a county employee of a law enforcement agency, has committed misconduct in that Mr. Allen knowingly used and communicated, directly and indirectly, confidential information about the female defendants, acquired in his capacity as the ASA, to obstruct, impede, or prevent investigations for his own personal sexual gratification.
 - (e) ASA Allen, as a public officer and a county employee of a law

enforcement agency has directly communicated information gained from a confidential resources while participating or aiding law enforcement in an ongoing investigation, and disclosed it for personal gain and for the sexual exploitation of young female defendants.

Facts In support of Allegations of Abuse of Office for Sexual Gain

- 4. That the Petitioner's has recently received communications produced by Assistant States Attorney Brady Allen, those communications reasonably cast doubt on the ASA Bradley Allen and CCSA Danley and the impartiality on the pending matters involving any criminal case involving female defendants and this pair of attorneys.
- 5. The Petitioner's alleges that undisclosed relationship(s) exist in People vs Kara Chumbley and People vs. Brianna Lee, for which no disclosure were made and waivers were provided. The Petitioner's alleges that other undisclosed relationships and agreements between the CCSA Danley and ASA Allen exist that is unethical and directly impacting the female defendants right to an unbiased and non-conflicted justice system.

 (ASA Allen was attempting to orchestrate a sexual threesome between himself and defendants Kara Chumbley and Brianna Lee via Snap Chat during business hours)
- 6. That the Coles County States Attorney's Office was the "investigative" body in relation to the charges filed against these two females in their criminal matter(s). Those charges were filed by prosecutor/investigator ASA Brady Allen against the defendant(s) and approved by CCSA Danley. The promised manipulation of those criminal charges by ASA Allen later formed the basis of the ongoing sexual exploitation of the defendant(s) by CCSA Danley and ASA Allen.
- 7.. On or about January, 2019 forward the Coles County States Attorney Jesse
 Danley, (Hereinafter CCSA Danley) and Assistant States Attorney Brady Allen
 (Hereinafter ASA Allen) made the following "Accord" as to the Defendant's being
 sexually exploited by ASA Allen. Upon entering office in January, 2019 appointed CCSA

Danley implemented a policy relating to the "conflict of interest" between female defendants and dating the CCSA prosecutor(s). ASA Brady Allen has stated the activity was allowed by CCSA Danley, further that if any of those relationships with the female defendants became "serious" ASA Allen was to notify CCSA Danley who would then authorize the appointment of a special prosecutor in there cases.

- 8. That on information and belief CCSA Danley was at all times aware of the relationship(s) between Assistant State's Attorney Brady Allen and the female defendants. CCSA Danley had determined it was not a conflict of interest and no waivers from the State were required nor felt it necessary to advise the female defendants unless CCSA Danley and ASA Allen "felt" the relationship(s) were "serious".
- 9. That on information and belief CCSA Jesse Danley and ASA Allen believed that dating female defendant(s) was not a per se conflict or any conflict of interest, a simple signed waiver by the female defendants is all that would have been necessary to cure such a conflict and such a waiver would have been sought if the relationship became "serious".
- 10. That on information and belief the dating relationship(s) with female defendants was a well-known fact among the CCSA Danley and the other assistants and staff attorneys.
- 11. That on information and belief that conflict of ASA Brady Allen dating defendants was not ignored...but rather was determined to be a non-issue by the CCSA Danley and ASA Allen unless the CCSAO determined the relationship was "serious".
- 12. That on information and belief CCSA Danley knew that ASA Allen was sexually exploiting female defendants at the time ASA Allen was handling their cases as prosecutor.
- 13. That Coles County State's Attorney Jesse Danley admits the "rule puts the

responsibility again on the lawyer to determine if such a conflict exists" and by way of affirmative matter asserts each lawyer determined there is no concurrent conflict of interest" in dating the female defendants.

- 14. That on information and belief Coles County State's Attorney Jesse Danley will deny any conflict, will deny any wrongdoing or manipulation by the Coles County State's Attorney Office and Assistant State's Attorney Allen in these case(s).
- 15. That CCSA Danley and ASA Allen on behalf of Coles County States Attorney's Office have made representations and/or allegations to the defendant(s) that CCSA Danley has previously waived the conflict of interest created by ASA Brady Allen dating the female defendants.
- 16. That CCSA Danley and ASA Allen have made representations and allegations to the Defendant that CCSA Danley has expressed view(s) and has already ruled on the legal or factual issues involved in this pending criminal case(s) and on those issues are still pending in this case(s) as to ASA Allen dating these defendants.
- 17. That on information and belief ASA Allen was using Tinder a dating app and Snap Chat and Facebook and his I phone during the day when ASA Allen was working at CCSAO. The female defendant(s) recognized ASA Brady as there prosecutor.
- 18. The female defendant(s) raised the concern over the conflict ASA Bradys' job posed, the defendant was told that it wasn't a conflict, yet. The defendant was told that a policy was in place if an when it became serious.
- 19. That ASA Brady Allen began to repeatedly ask for pornographic photos (including their faces) of the female defendants while simultaneous filing new charges against them.
- 20. On information and belief ASA Allen promised favorable treatment of their

criminal cases in exchange for sex acts with him or other female defendants.

21. The Defendant believes that a reasonable interpretation that CCSA Danley policy and ASA Allen statements about his "trying to be playful" by exploiting the female defendant. On March 4th, 2020 through the March 8th, 2020 ASA Allen went on a sexually fueled social media blitz of sex based content direct toward the defendant.

22. ASA Allen told the Defendant:

"Then you need to visit me and we can discuss your situation while your ride my cock" (smiley emoji) Or

I can give you advice while your mouth is full" (Emoji)

Hows that for a plan? What time do you get off? (See Exhibit A)

Do you not trust me or something? (See Exhibit D)

"I did try and take you out a few time to see if we were connected enough" (See Exhibit E)

" Just to be honest with yourself. You wouldn't want to date a guy who is into the stuff I'm into. " (See Exhibit E)

"I've not tried to hide that I've been interested in getting with either of you since I'm no longer on your cases. She just didn't seem to lose interest like you seemed to around April or whenever it was". (See Exhibit F) (Compare ASA Allen statements to the criminal dockets of each of these girls.)

"I just like a slut for someone I would date. " (See Exhibit F) (Compare ASA Allen statements to the criminal dockets of each of these female defendants.)

Then let's act like friends. Instead of doing stuff like kicking me off of snapchat and such. Im like us being able to talk casually" (See Exhibit G)

- 23. The Petitioners believe that a reasonable interpretation of ASA Allen's statements to the female defendant that CCSA Danley or his office cannot be impartial in decisions in this matter of the conflict of interest with any female defendant and ASA Allen and the CCSAO.
- 24. That on information and belief that based upon ex-parte conversations and assurances from CCSA Danley, ASA Allen told the female defendants he had permission to date female defendants appearing opposite him. CCSA Danley's blessing is nexus of the institutionalized sexual exploitation of the female defendants and is the the genesis of the current allegations of sexual exploitation driven by CCSA Danley 'hands on " policy.
- 25. That CCSA Danley recently disclosed that he meets with each ASA attorney individually for the purpose of reaching an unwritten, undocumented, undated, administrative order regarding the waiver of the conflicts between ASA's and the female defendants in all case in which they appeared opposite and adverse.
- 26. The Petitioners have attached a small sample of the available communications from ASA Brady Allen to this female defendant. (See attached Exhibits A to I)
- 27. The ASA Allen has from Spring 2019 until present has been using the Coles County State's Attorney's Office staff and resources to select and then sexually exploit young women for personal sexual favors or to acquire pornographic material. (See Attached Exibits A through I)
- 28. That ASA Brady Allen committed or caused to commit a series of acts in excess of his lawful authority: by employing deceit and concealment to sexually exploit female defendants for the purpose of personal sexual gratification and to procure pronographic

material.

- 29. That ASA's Brady Allen actions were designed to obtain sexual acts and pornographic material from female defendants while acting on behalf of the State of Illinois. Mr. Allen has and continues to use the full weight and authority of his State's Attorney's Office position to secure a professional/personal sexual advantage(s) over these female defendants.
- 30. That ASA Allen has occupied and used his position of responsibility and trust in local government, the legal profession, and the judiciary for personal sexual gain and to cause irreparable injury all in violation of Illinois Law.
- 31. That ASA Allen has wrongfully used and converted county resources for personal gain by using the Coles County States Attorney Office, phones, files, computers and other resources to identify and communicate with the female defendants/victims during and after buisness hours, even during the judicial procedeing's) themselves. (See Attached Affidavits Kara Chumbley and Mcinzie).
- 32. That from Spring 2019 until present Brady Allen acting as Assistant Coles County State's Attorney's aquired confidential information and knowledge of female defendants while working in his offical capacity as ASA. ASA Brady then used the information gained by his employment as law enforcement officer to identify and target specific young women who the ASA Brady found sexually attractive.
- 33. That from Spring 2019 until present in addition to the sexual exploitation component, Assitant States Attorney Brady Allen also began to give legal advice to the female defendants (independently of defense counsel) about their pending criminal case(s) which ASA Brady had filed against them. ASA Brady used "Snap Chat" to prevent and obscure the record of the explict sexual contact and instructed the female defendants not to call, not to text him. The ASA Brady's use of social media to make

contact with the female defendants was just one in a series of the actions of a sexual preditor with a badge. (See attached Exibit)

- 34. That during the pendency of the female defendants criminal cases ASA Brady would file adverse criminal pleadings and then instruct the defendants to take the plea deal the State of Illinois had offered.
- 35. That ASA Brady repeatedly offered to use his position as ASA Coles County State's Attorney's Office and his relationship with the CCSA Jesse Danley to modify or elimates pending and future criminal charges in exhange for preforming any number of the sexual acts that ASA Brady had previously requested of the defendants, a service not offered to the general public.
- 36. That on September 2019, forward ASA Brady Allen repeatedly used the Coles County State's Attorney's Office to contact female defendant(s) and victim(s) for the purposes of consulting with them in his official capacity as Coles County State's Attorney. This official behavior was designed to obscure his real motives in reaching out to the women.
- 37. During December, 2019 and prior thereto, Petitioner(s) presented evidence of multiple felonies to Coles County Board for investigation for possible prosecutions. It was ignored. As a result of the neglect by the Coles County Board these and other female defendants have been and continue to be exploited.
- 38. That the Petitioners submit the following factual evidence and exhibits in support of this Petition. (Exhibits
- 39. That Section 3-9008 (55 ILCS 5/3-9008) allows this Court to appoint some competent attorney to prosecute whenever the States Attorney is "sick or absent, or unable to attend, or is interested". Insofar as Section 3-9008 contemplates an appointment

limited to causes or proceedings in which the States Attorney is disqualified (Aiken v. County of Will, 321 Ill.App.171, 52 N.E. 2d 607 (2 Dist. 1943))

- 40. 



Consistent with our conversation this date, below is a synopsis of the legal question I posed: In April 2013 Jesse Danley, now state's attorney of Coles County, sold a Jon Boat to Mervin Wolfe. Jesse signed the title over the same date as the boat being picked up. Mr. Wolfe never had the transferred title registered with DNR. Three weeks ago Mr. Wolfe filed a small claims complaint against Jesse Danley claiming he refused to transfer the title. I have all the craig's list information from 2013 and the emails of the sale and also a 2018 email from Mr. Wolfe stating he lost the title in 2018.

Question: Jesse Danley wants Mr. Wolfe to have a proper title for the boat but he is unwilling to sign paperwork that would make it appear as if the sale took place today. Consistent with our conversation this date, below is a synopsis of the legal question I posed:

In April 2013 Jesse Danley, now state's attorney of Coles County, sold a Jon Boat to Mervin Wolfe. Jesse signed the title over the same date as the boat being picked up. Mr. Wolfe never had the transferred title registered with DNR. Three weeks ago Mr. Wolfe filed a small claims complaint against Jesse Danley claiming he refused to transfer the title. I have all the craig's list information from 2013 and the emails of the sale and also a 2018 email from Mr. Wolfe stating he lost the title in 2018.

Question: Jesse Danley wants Mr. Wolfe to have a proper title for the boat but he is unwilling to sign paperwork that would make it appear as if the sale took place today. We need it to show that the sale was, in fact in April of 2013. We are unwilling to surrender the position that the small claims suit is past the 5 year statute of limitations for civil cases and 4 year statute of limitations as to commerce. Is there a way for the title of the Jon boat to be given to Mr. Wolfe? He did buy it and it was properly signed over to him.

MOTION TO STRIKE PARAGRAPH 18 OF DEFENDANTS MOTION TO DISMISS

NOW COMES MERVIN WOLFE, Plaintiff, and moves this Honorable Court to Strike portions of the Motion to Dismiss filed herein specifically paragraph19 and in support of this Motion states as follows:

- 1. That Defendant Jesse Danley has placed into the court record the following verified factual statement contained within paragraph 18 of the Motion To Dismiss as follows.
 - 18. That Plaintiff's filing of the underlying Complaint is filed in retaliation to the State's Attorney of Coles County filing battery charges against him in Coles County cause 2019-CM-297 wherein Plaintiff is recorded on video grabbing an elderly woman and pushing her to the ground, bruising her eye. Plaintiff filed his Entry of Appearance in his criminal case 2019-CM-297 the same date as filing his Complaint in this cause on July 30, 2019.
- 2. That the Defendants knowledge of the factual statements in paragraph 18 were acquired solely though his official capacity as Coles County States Attorney. Further this information was taken from evidence currently being held by the Sheriff's office, based on a case which Coles County States Attorney Jesse Danley dismissed People vs Nancy Barber.
- 3. The Defendants use and dissemination of the privileged information placed into paragraph 18 is strictly prohibited by the Illinois Rules of Professional Conduct 3.6 (a); 3.6 (b); 3.6 (b) 1; 3.6(b)2; 3.6 (b) 3; 3.6 (b) 4; 3.6(b)5; 3.6(b) 6 and 3.6 e.
- 4. That the Defendant knew that Illinois Rules of Professional Conduct Rule 3.6 were in effect as follows:

RULE 3.6. TRIAL PUBLICITY (a) A lawyer who is participating or has participated

Notwithstanding paragraph (a), a lawyer may make a statement that a reasonable lawyer would believe is required to protect a client from the substantial undue prejudicial effect of recent publicity not initiated by the lawyer or the lawyer's client. A statement made pursuant to this paragraph shall be limited to such information as is necessary to mitigate the recent adverse publicity. (e) No lawyer in a firm, or government agency, or otherwise associated with a lawyer subject to paragraph (a) shall make a statement prohibited by paragraph (a). CREDIT(S) Adopted Feb. 8, 1990, eff. Aug. 1, 1990. Amended Oct. 22, 1999, eff. March 16, 2000. HISTORICAL NOTES Rule 3.6 of the Rules of Professional Conduct was originally amended October 22, 1999, effective December 1, 1999; however, the Supreme Court of Illinois stayed the effect and enforcement of this rule until further order of the Court. The Supreme Court announced March 16, 2000, that the November order "staying the force and effect" of the October order "is lifted," and that the amended rules "are effective immediately.

- 5. The Defendants use and dissemination of the privileged information in paragraph 18 is strictly prohibited by the Illinois Rules of Professional Conduct 3.8 (a); 3.8(d): 3.8(f).
- 6. That the Defendant knew that Illinois Rules of Professional Conduct Rule 3.8 were in effect at the time of the filing of paragraph 18.

RULE 3.8: SPECIAL RESPONSIBILITIES OF A PROSECUTOR The duty of a public prosecutor is to seek justice, not merely to convict. The prosecutor in a criminal case shall: (a) refrain from prosecuting a charge that the prosecutor knows is not supported by probable cause; (b) make reasonable efforts to assure that the accused has been advised of the right to, and the procedure for obtaining, counsel and has been given reasonable opportunity to obtain counsel; (c) not seek to obtain from an unrepresented accused a waiver of important pretrial rights, such as the right to a preliminary hearing; (d) make timely disclosure to the defense of all evidence or information known to the prosecutor that tends to negate the guilt of the accused or mitigates the offense, and, in connection with sentencing, disclose to the defense and to the tribunal all unprivileged mitigating information known to the prosecutor, except when the prosecutor is relieved of this responsibility by a protective order of

in the investigation or litigation of a matter shall not make an extrajudicial statement that a reasonable person would expect to be disseminated by means of public communication if the lawyer knows or reasonably should know that it would pose a serious and imminent threat to the fairness of an adjudicative proceeding. (b) There are certain subjects which would pose a serious and imminent threat to the fairness of a proceeding, particularly when they refer to a civil matter triable to a jury, or a criminal matter. These subjects relate to: (1) the character, credibility, reputation or criminal record of a party, suspect in a criminal investigation or witness, or the identity of a witness, or the expected testimony of a party or witness; (2) in a criminal case, the possibility of a plea of guilty to the offense or the existence or contents of any confession, admission, or statement given by a defendant or suspect or that person's failure to make a statement; (3) the performance or results of any examination or test or the failure of a person to submit to an examination or test, or the nature of physical evidence expected to be presented; (4) any opinion as to the guilt or innocence of a defendant or suspect in a criminal case; (5) information that the lawyer knows or reasonably should know is likely to be inadmissible as evidence in a trial; or (6) the fact that a defendant has been charged with a crime, unless there is included therein a statement explaining that the charge is merely an accusation and that the defendant is presumed innocent unless proven guilty. (c) Notwithstanding paragraph (a), a lawyer may state: (1) the claim, offense or defense involved and, except when prohibited by law, the identity of the persons involved; (2) information contained in a public record; (3) that an investigation of a matter is in progress; (4) the scheduling or result of any step in litigation; (5) a request for assistance in obtaining evidence and information necessary thereto; (6) a warning of danger concerning the behavior of a person involved, when there is reason to believe that there exists the likelihood of substantial harm to an individual or to the public interest; and (7) in a criminal case, in addition to subparagraphs (1) through (6): (i) the identity, residence, occupation, and family status of the accused, (ii) if the accused has not been apprehended, information necessary to aid in apprehension of that person, (iii) the fact, time, and place of arrest, and (iv) the identity of investigating and arresting officers or agencies and the length of the investigation. (d)

the tribunal; (e) not subpoena a lawyer in a grand jury or other criminal proceeding to present evidence about a past or present client unless the prosecutor reasonably believes: (1) the information sought is not protected from disclosure by any applicable privilege; (2) the evidence sought is essential to the successful completion of an ongoing investigation or prosecution; and (3) there is no other feasible alternative to obtain the information; (f) except for statements that are necessary to inform the public of the nature and extent of the prosecutor's action and that serve a legitimate law enforcement purpose, refrain from making extrajudicial comments that pose a serious and imminent threat of heightening public -2- condemnation of the accused and exercise reasonable care to prevent investigators, law enforcement personnel, employees or other persons assisting or associated with the prosecutor in a criminal case from making an extrajudicial statement that the prosecutor would be prohibited from making under Rule 3.6 or this Rule. (g) When a prosecutor knows of new, credible and material evidence creating a reasonable likelihood that a convicted defendant did not commit an offense of which the defendant was convicted, the prosecutor shall: (1) promptly disclose that evidence to an appropriate court or authority, and (2) if the conviction was obtained in the prosecutor's jurisdiction, (i) promptly disclose that evidence to the defendant unless a court authorizes delay, and (ii) undertake further reasonable investigation, or make reasonable efforts to cause an investigation, to determine whether the defendant was convicted of an offense that the defendant did not commit. (h) When a prosecutor knows of clear and convincing evidence establishing that a defendant in the prosecutor's jurisdiction was convicted of an offense that the defendant did not commit, the prosecutor shall seek to remedy the conviction. (i) A prosecutor's judgment, made in good faith, that evidence does not rise to the standards stated in paragraphs (g) or (h), though subsequently determined to have been erroneous, does not constitute a violation of this rule.

- 7. The use and publication of this privileged information gained in the Defendants official capacity as Coles County States Attorney is a violation of IRPC 3.6 and IRPC 3.8. This is an act of Official Misconduct done for personal gain.
- 8. That the Defendant knew at the time of placing the factual statements of paragraph 18 into the record, that the statement was false, known to be false at the time the Defendant placed them into the record.

- 9. That paragraph 18 was by design to be factually incorrect and intentionally misleading. The Defendants unlawful use of the protected information was done with the intent to injure the Plaintiff and for personal; financial gain.
- 10. That the factual statements contained paragraph 18 are irrelevant, and unnecessarily prejudicial and violations of IRPC 3.6 and IRPC 3.8 as well as a criminal act of Official Misconduct.
- 11. The Defendant seeks to interject his own persecution fantasies into this matter involving the failure of the Defendant to comply with the terms and conditions of the original sale and subsequent failure of Defendant to act on transfer of the boat.

MOTION TO STRIKE COUNT I OF DEFENDANTS MOTION TO DISMISS PURSUANT TO ILLINOIS SUPREME COURT RULE 287(b)

NOW COMES MERVIN WOLFE, Plaintiff, and moves this Honorable Court to Strike the Motion to Dismiss Count One pursuant to Illinois Supreme Court Rule 287 (b) and in support states as follows:

- 1. The Defendant Jesse Danley has placed into the court record a "Motion to Dismiss the Small Claims Case filed by Plaintiff in this matter.
- 2. The rules relating to small claims actions are set forth in Rules 281 through 289 of the Rules of the Illinois Supreme Court. Copies of these Rules are available on the Internet at http://www.state.il.us/court/SupremeCourt/Rules/. These Rules are designed to enable an individual to collect a debt or settle any small legal controversy involving money without having to go through a long, more expensive legal process as is associated with more substantial legal claims.
- 3. Illinois Supreme Court Rules define Small Clams as follows:

Rule 281. Definition of Small Claim

For the purpose of the application of Rules 281 through 288, a small claim is a civil action based on either tort or contract for money not in excess of \$10,000, exclusive of interest and costs, or for the collection of taxes not in excess of that amount.

4. Illinois Supreme Court Rule 287 limits the use of 735 ILCS 2-615 Motions states as follows:

Rule 287. Depositions, Discovery and Motions

(a) No depositions shall be taken or interrogatories or other discovery proceeding or requests to admit be used prior to trial in small claims except by leave of court.

- (b) Motions. Except as provided in sections 2--619 and 2--1001 of the Code of Civil Procedure, no motion shall be filed in small claims cases, without prior leave of court.
- 5. That the Defendant did not seek leave of Court prior to filing his Motion to Dismiss. Count 1 pursuant to 735 ILCS 5/2-615.

Wherefore the Plaintiff Mervin Wolfe moves the honorable court to strike Count One filed herein in that it violates Illinois Supreme Court Rule 287(b) prohibiting 2-615 Motions in Small Claims matters.

MOTION TO DISMISS PURSUANT TO 735 ILCS 5/2-615 AND 735 ILCS 5/2-619 AND FOR SANCTIONS

NOW COMES Defendant, JESSE DANLEY, Pro Se, and Answers the Complaint with Motion to Dismiss and moves this Honorable Court for an order dismissing this cause of action with prejudice pursuant to 735 ILCS 5/2-615 and 735 ILCS 5/2-619 and for an award of sanctions pursuant to Illinois Supreme Court Rule 137, and in support thereof Defendant states as follows:

I. ANSWER

- 1. Defendant admits the allegations contained in paragraph 1 of said Complaint and by way of affirmative matter states the advertisement was placed on Craigslist in April 2013.
- 2. Defendant admits the allegations contained in paragraph 2 of said Complaint and by way of affirmative matter states Plaintiff responded to the advertisement on Thursday, April 11, 2013. Attached hereto marked as Exhibit A and incorporated herein is a copy of the email response of Plaintiff to the advertisement.
- 3. Defendant admits the allegations contained in paragraph 3 of said Complaint that the Plaintiff and Defendant entered into a verbal agreement on the sale of the watercraft.
- 4. Defendant admits the allegations contained in paragraph 4 of said Complaint and affirmatively asserts the cash payment from Plaintiff to Defendant took place simultaneously with the delivery of the boat and the properly assigned certificate of title from Defendant to Plaintiff in April, 2013. Attached hereto marked as Exhibit B and incorporated herein is the Affidavit of Jesse Danley.

- 5. Defendant admits the allegations contained in paragraph 5 of said Complaint that Defendant did not provide the Plaintiff with a bill of sale and affirmatively asserts that the delivery of the boat simultaneous with the transfer of certificate of title from Defendant to Plaintiff effectuated the sale of the boat and by way of further affirmative matter asserts the parties verbally agreed a bill of sale was not necessary. Exhibit A attached to Plaintiff's Complaint admits he lost the certificate of title that had been tendered upon the sale. Plaintiff's Complaint and attached exhibits confirm the sale, the receipt of the boat, receipt of certificate of title, and admits that he lost the certificate of title.
- 6. Defendant admits the allegations contained in paragraph 6 of said Complaint and affirmatively asserts that Plaintiff presents evidence of an email dated March 8, 2018, to the work address of Defendant. Defendant affirmatively asserts he has no recollection of viewing said email and further affirmatively asserts that all transactions and emails relating to the boat and advertisement on Craigslist were associated with Defendant's personal email account.
- 7. Defendant admits the allegations contained in paragraph 7 of said Complaint and affirmatively asserts the parties verbally agreed transfer of certificate of title was sufficient to effectuate the sale and no bill of sale was necessary. By way of further affirmative matter Defendant asserts he did not view any email received at his work email requesting a bill of sale and this law suit is the first Defendant has learned Plaintiff is seeking a bill of sale.
- 8. Defendant can neither admit nor deny the allegations contained in paragraph 8 of said Complaint that Plaintiff is unable to register/title the watercraft, but by way of affirmative matter states that the certificate of title was properly assigned from Defendant to Plaintiff in April, 2013, and Plaintiff had 15 days in which to register said properly assigned certificate of title with the Illinois Department of Natural Resources.

II. MOTION TO DISMISS PURSUANT TO 735 ILCS 5/2-615 Failure to State a Cause of Action

9. Plaintiff's Complaint fails to state a cause of action upon which relief can be granted.

The Complaint does not state a claim for relief and on its face fails to show Defendant owed

Plaintiff a duty that he did not fulfill. The Complaint should be dismissed with prejudice. The well-pleaded factual allegations do not allege that Defendant has breached any contract but clearly evidence the sale of the boat was completed, indicates Plaintiff failed to register the Title with the Illinois Department of Natural Resources, and Plaintiff lost said certificate of title due to his own negligence. (See Exhibit A and Exhibit B attached to Plaintiff's Complaint).

- 10. Plaintiff's Complaint is barred by the statute of limitations. Paragraph 3 of Plaintiff's complaint admits to the oral contract between Plaintiff and Defendant. The oral contract was effectuated April 2013. More than 6 years has passed since the sale of the boat. Plaintiff's suit is barred pursuant to the 5 year statute of limitations of the Civil Code (735 ILCS 5/13-205) and the 4 year statute of limitations of the Commercial Code (810 ILCS 5/2-725).
- 11. That it is just and appropriate this matter be dismissed pursuant to 735 ILCS 5/2-615 for failure to state a cause of action and as insufficient as a matter of law.

III. MOTION TO DISMISS PURSUANT TO 735 ILCS 5/2-619 Barred by Statute of Limitations

- 12. That Plaintiff's Complaint is barred by the Statute of Limitations pursuant to 735 ILCS 5/2-619 (a)(5). (See 735 ILCS 5/2-619.(a)(5) and 810 ILCS 5/2-725(1).
- 13. That Plaintiff responded to Defendant's Craigslist advertisement on the 11th day of April, 2013. (See attached Exhibit A). The sale of the boat was effectuated April 2013 by the simultaneous delivery of the boat and properly assigned Certificate of Title from Defendant and the payment from Plaintiff. See Affidavit of Jesse Danley attached as Exhibit B. (Also see Paragraphs 3 and 4 of Plaintiff's Complaint and Exhibit A attached thereto).
- 14. That Plaintiff's Complaint, Exhibit A and Exhibit B attached to his Complaint admit that the sale of the boat was completed, indicates Plaintiff failed to register the title with the Illinois Department of Natural Resources, and Plaintiff lost said certificate of title due to his own negligence.
- 15. That paragraph 3 of Plaintiff's Complaint admits to the oral contract between Plaintiff and Defendant. The oral contract was effectuated April 2013 by the delivery of the boat

with properly assigned Certificate of Title from Defendant to Plaintiff and the exchange of payment.

- 16. That more than 6 years has passed since the sale of the boat. Plaintiff's suit is barred by the Statute of Limitations pursuant to the 5 year statute of limitations of the Civil Code (735 ILCS 5/13-205) and the 4 year statute of limitations of the Commercial Code (810 ILCS 5/2-725).
- 17. That it is just and appropriate this matter be dismissed pursuant to 735 ILCS 5/2-619 for failure to commence within the time limited by law. (735 ICS 5/2-619(a)(5)).

IV. MOTION FOR SANCTIONS PURSUANT TO ILCS S. CT. RULE 137

- 18. That Plaintiff's filing of the underlying Complaint is filed in retaliation to the State's Attorney of Coles County filing battery charges against him in Coles County cause 19-CM-297 wherein Plaintiff is recorded on video grabbing an elderly woman and pushing her to the ground, bruising her eye. Plaintiff filed his Entry of Appearance in his criminal case 19-CM-297 the same date as filing his Complaint in this cause on July 30, 2019.
- 19. That the Complaint is improper and was filed in bad-faith solely to harass, to cause unnecessary litigation and is frivolously interposed to delay and create conflict in his criminal case, filed to harass the State's Attorney, and cause needless time and expense to Defendant.
- 20. That Plaintiff is an attorney licensed to practice law in the State of Illinois. He knew or should have known this cause is barred by the Statute of Limitations and that his Complaint fails to state any cause of action upon which relief could be granted.
 - 21. That Illinois Supreme Court Rules provides for sanctions:

"Illinois Supreme Court Rule 137(a) (eff. Jan. 1, 2018) provides as follows:

Every pleading, motion and other document of a party represented by an attorney shall be signed by at least one attorney of record in his individual name, whose address shall be stated. * * * The signature of an attorney or party constitutes a certificate by him that he has read the pleading, motion or other document; that to the best of his knowledge, information, and belief formed after reasonable inquiry it is well grounded in fact and is warranted by existing law or a good-faith argument for the extension, modification, or reversal of existing law, and that it is not interposed for any improper purpose, such as to harass or to cause unnecessary delay or needless increase in the cost of litigation. * * * If a pleading, motion, or other document is signed in violation of this rule, the court, upon motion or upon its own initiative, may impose upon the **220 *1279 person who

signed it, a represented party, or both, an appropriate sanction, which may include an order to pay to the other party or parties the amount of reasonable expenses incurred because of the filing of the pleading, motion or other document, including a reasonable attorney fee." *Enbridge Pipeline (Illinois), LLC v. Hoke*, 2019 IL App (4th) 150544-B, ¶ 27, 123 N.E.3d 1271, 1278-79

22. That it is just and appropriate Plaintiff be sanctioned pursuant to Rule 137.

WHEREFORE, Defendant, JESSE DANLEY, prays this Honorable Court dismiss this cause with prejudice pursuant to Section 5/2-615 as insufficient and for failure to state a cause of action and/or pursuant to Section 5/2-619 as barred by the Statute of Limitations, prays for an award of sanctions and for such other, further, and different relief as this Court deems just and appropriate

School rules to limit timeouts, restraints

SPRINGFIELD - The lllinois State Board of Education has submitted its proposed rules for how schools can restrain students who exhibit dangerous behavior.

The rules filed Tuesday seek to protect children and faculty from outbursts. They will ban supine re-but ban the use of prone straints except in emerrestraints except as a last resort and the practice of locking such students in timeout rooms all by themselves.

The rules were drafted in response to a report last month by the Chicago Tribune and ProPublica that found that public schools were misusing timeout rooms.

The public will have opportunities to provide reedback on the proposal, which would not be finalized until spring 2020. Public comment is open now until Feb. 4.

The state board put emergency rules in place on Nov. 20 banning isolated seclusion. That emergency ban will expire on April 17. Illinois is the fifth state in the nation with such a ban.

Under the ban, a student presenting dangerous behavior may only be in an unlocked space, with reasonable access to food, medication and toilet faadult present in the room. code 62777.

That adult must assess every 15 minutes whether the student has stopped the dangerous behavior.

The proposed rules do not pertain to student-initiated breaks, sensory breaks, brief removals to the hallway or to in-school suspension and detention. straints except in emer-gency situations when less restrictive interventions have not succeeded in stopping the imminent danger to students or staff, and will require that a trained adult who is not involved in the physical restraint of the student observe the student during the entire period of supine testrain).

The rules will also require an additional layer of review by a psychologist, so-cial worker, nurse or behavior specialist if the student is restrained in at least two separate instances within a 30-school-day period.

The restraints must not impair a student's ability to breathe or communicate or be used with students who have medical or psychological limitations that would contraindicale their use.

Consistent with our conversation this date, below is a synopsis of the legal question I posed:

In April 2013 Jesse Danley, now state's attorney of Coles County, sold a Jon Boat to Mervin Wolfe. Jesse signed the title over the same date as the boat being picked up. Mr. Wolfe never had the transferred title registered with DNR. Three weeks ago Mr. Wolfe filed a small claims complaint against Jesse Danley claiming he refused to transfer the title. I have all the craig's list information from 2013 and the emails of the sale and also a 2018 email from Mr. Wolfe stating he lost the title in 2018.

Question: Jesse Danley wants Mr. Wolfe to have a proper title for the boat but he is unwilling to sign paperwork that would make it appear as if the sale took place today. We need it to show that the sale was, in fact in April of 2013. We are unwilling to surrender the position that the small claims suit is past the 5 year statute of limitations for civil cases and 4 year statute of limitations as to commerce. Is there a way for the title of the Jon boat to be given to Mr. Wolfe? He did buy it and it was properly signed over to him.

If that case moved forward, I would file a motion to suppress.



# PENALTIES FOR CRIMES IN ILLINOIS

- Estrement Tests. This court may impose an extended term in flow of the usual term on
  a person convicted of any of a number of erlines, or of orlines committed in types of
  circumstances, that are listed in 730 II/CS 5/5/5-3-2(b) to (d). An extended term can also
  be imposed on a person who committed a murder with ", ... wonton cruckly" or committed
  any felony with an argravating factor described in libit 5 below present.
- 2. Properties: Except for the most serious critics, an offender can be sentenced to a term of probation in lice of prison. Maximum probation terms for each class of crime are listed in the column marked with this footnote. Among numerous other statutory conditions, a person on probation is forbidden to possess a litearm or other dangerous weapon, or to leave the state without permission, and must pay a \$50 monthly probation fee and any fees for court-ordered treatment if able. Courts may add other conditions. Note 10 below describes situations in which probation is not allowed as an afternative to prison.
- 3. MASEA TORY SUPERVISED RECEASE (MSR), This is a period of parole that automatically follows in prison term for a Telony. A person convicted of a repeat sex crime involving force or threat of force, against a victim under 18; must serve 4 or 5 years of MSR, with the first 2 being in electronic home electron. The Prisoner Review Board can discharge from MSR a person whom it considers likely to obey the criminal laws.
- 4. Fixes: Whenever a fine is imposed, except for a nonmoving traffic offense or a pedestrian offense, there is added to it a penalty of \$5 for each \$40 or fraction of \$40. Thus the amounts shown must be increased by one eighth to approximate muximum hase fines. In addition, surcharges on these are required for several specific kinds of crimes, listed principally in 730 (LCS 5/5-9-1.4 to 5/5-9-1.12).
