I am an investigative reporter for the Edgar County Watchdogs, Inc., located in Illinois.

We are a local government accountability organization, focusing primarily on local governmental activities throughout Illinois.

I have noticed that one of your employees has been sending public records requests, using her bkurowski@jht.com email address to DuPage Township, located in Bolingbrook, Illinois.

Her requests include her title as “Senior Instructional Designer,” the JHT, Inc. contact information, and the “JHT CONFIDENTIALITY NOTICE” at the bottom of her emails.

Some of the more recent emails from Bonnie Kurowski using her @jht.com email account were sent on:

She also posts as Moderator on a Facebook page she created, entitled “Citizens for a better Bolingbrook” [<https://www.facebook.com/groups/321004285662701/>] with posts and commentary which indicate, to me as a reporter, an attempt at influencing the upcoming election in the Spring of 2021 for local Township officials.

This creates the appearance that JHT, Inc. is becoming involved in a local Township election in a large county located in Northern Illinois.

If this is the case, would you mind stating why a Florida Corporation is interested in a Township in northern Illinois, and what it is they are trying to accomplish with their employee gathering public records and writing posts in a Facebook page she created and moderates, while using your corporate email address and contact information in her emails to the Township.

If JHT, Inc. has no interest in DuPage Township politics, please advise us of that position also.
