Agent Colbrook:

Thank you for your final report on the above-referenced investigation received September 15, 2020. My office has completed review of the investigation and determined there is insufficient evidence to prove a criminal offense beyond a reasonable doubt. Accordingly, we will not file a criminal charge at this time based upon the reports submitted and reviewed.

The relevant provision of the Illinois Fire Protection District Act ("FPDA") does not specify a mental state necessary to establish criminal liability for any violation. 70 ILCS 705/4. In cases related to statutes which impose felony liability, but do not specify a requisite mental state, the Illinois Supreme Court has required proof beyond a reasonable doubt that the alleged violation was undertaken with "criminal knowledge, in other words, knowledge plus criminal purpose." *See People v. Tolliver*, 147 Ill.2d 397, 403 (1992); *People v. Wright*, 194 Ill.2d 1, 28-29 (2000). Put another way, absent evidence of theft, an intent to defraud or deprive an owner of property by means of deception, or other criminal purpose, the State could not likely sustain a criminal charge under the facts reflected in the investigation submitted to my office. *See e.g., Tolliver*, 147 Ill.2d at 403. While there are no Illinois Appellate or Supreme Court decisions interpreting this issue in the context of the FPDA, the absence of a specified mental state or express statutory language creating an absolute liability offense is common between the FPDA and other statutes specifically addressed in the above cases. A Court would likely apply the same analysis and require a showing of "knowledge plus criminal purpose" in a case arising from the conduct documented in the above-referenced investigation.

The Illinois State Police investigation concluded that the alleged conduct did not appear to have been "undertaken with any criminal purpose, intended to defraud or intended to exercise unauthorized control over property..." This conclusion would preclude a successful criminal

prosecution for violation of the Illinois Fire Protection District Act under the foregoing Illinois Supreme Court decisions.

On Wednesday, July 08, 2020 at 9:58 am., Special Agent Zach Colbrook #6622 and I, Special Agent Alex Colbrook #6621 interviewed John E. Archer (M/ and the in a conference room at the Illinois State Police Central Headquarters. I had previously made contact with Archer via phone and he agreed to come in and speak with us. Archer agreed to do an audio recorded interview. I advised Archer he could leave at any time. The following is a not verbatim summary of the interview.


- Archer has worked for the Rochester Fire Protection District for the past 9 years.
- Archer was appointed to Chief in May of 2018.
- He was the Assistant Chief at the Pawnee fire department prior to working at Rochester.
- He was also the Deputy Chief for the Sangamon County Rescue Squad for 17 years.
- Archer owns the company, AEC fire and rescue.
- AEC has been around since 1941.
- Archer has owned AEC since 1991.
- Archer's father, John L. Archer, owned the company prior to 1991.
- AEC consists of 14 full time employees and 6 or 7 part time sales representatives throughout the state of Illinois.
- Archer believes Rochester Fire Protection District has been doing business with AEC for approximately 40 years.
- Archer has 75% stock in AEC and his son, John M. Archer has 25% stock in AEC.
- When Archer took over as the Fire Chief in Rochester there was no change in the business done with AEC.
- Shortly after taking over as Chief, Archer separated himself from purchasing decisions by putting Captain Kirk Polley and Captain Matt Sunderland in charge of purchasing equipment.

- Archer advised all the board members and members of the district would vouch for his integrity.
- The board had no issue with the spending between the fire district and AEC until a trustee (Marty Fairchild) brought it up recently.
- When the issue was brought up the board went to James Sinclair, the attorney for the fire protection district.
- In March 2020, Sinclair reviewed all the spending and dollar amounts for the past two years.
- Sinclair recommended they say it was an oversight and stop business with AEC moving forward.
- Captain Polley and Captain Sunderland are responsible for getting competitive pricing.
- Anything purchases over \$20,000 they are required to get bids.
- For smaller purchases the captains typically call around to a few places to find a good price.
- Archer would tell the captains if there was a need for the department to purchase an item.
- The captains would then shop around to find the item.
- The captains do not exclusively make purchases at AEC.
  - For example, they have made purchases at the fire store in Pennsylvania.
- They do use AEC frequently because they are the best and only local option for most fire equipment.
- There are no other local fire equipment stores.
- The nearest fire equipment stores are in Peoria, St. Louis and Chicago.
- Archer is not aware that anyone objected to him being appointed chief.
- Throughout the process of being appointed chief nobody told him he should not be chief because it was a conflict of interest with him owning AEC.
- Archer is aware of the Fire Protection District Act but is not aware of the financial thresholds dealing with conflicts of interest.
- I explained to Archer, according to the Fire Protection District Act, the department should not have a contract of over \$1,000 and should not exceed \$2,000 per fiscal year.
- Archer guaranteed that they had exceeded this amount.
- He believes the department has spent \$25,000 with AEC since 2018.
- No one had mentioned this was in violation of the Fire Protection District Act until Trustee Martin Fairchild brought it up in a board meeting a few months ago.
- There has been a lot of conflict with Fairchild everywhere he has gone.
- Archer doesn't know if Fairchild has a personal problem with him.

- Fairchild feels left out of the projects sometimes.
- Fairchild and his wife try to create conflict at every board meeting.
- Fairchild's wife had to be removed from a board meeting recently.
- Fairchild has never spoke to Archer about these allegations outside of a meeting.
- The district recently bought a fire truck from a different vendor.
- Fairchild thought they bought it illegally, but the attorney reviewed the purchase and said everything was legal.
- Fairchild reached out to the Edgar County watchdogs and invited them to board meetings.
- Board meetings became a circus after this.
- The board reviews the fire protection district's invoices every month at the meeting.
- The secretary, Denise Garceau, turns the invoices into the board.
- The board signs off on the invoices and then sends them back to Denise.
- Archer does not see every invoice before they go to Denise.
- Archer doesn't review the spending on a monthly basis because some months nothing is purchased.
- Denise typically shows him an invoice if it is large and she doesn't know what it is for.
- The board allows them to spend up to \$5,000 without approval.
- The board treasurer reads a monthly report on spending to the board but it does not break down how much is spent with each company.
- Archer does not believe anyone on the board knew Archer was in violation of the Fire Protection District Act prior to March 2020 because no one on the board ever brought it up to him.
- Archer can not think of a time a purchase did not get approved by the board because they always have a justification for the spending.
- Besides the purchase of the new fire truck, Martin Fairchild has not disputed any purchases.
- Archer collects a Salary of approximately \$1,255 per week.
- He does not make a commission on sales.
- AEC has provided tons of no cost services to the department.
- Martin Fairchild has signed off on the invoices for years prior to Archers appointment to chief and since Archer became chief.
- Archer believes Fairchild has an agenda because Fairchild was not asked to be on the committee to purchase a new firetruck.



- Archer believes Fairchild feels insulted that the board is not valuing his input.
- Archer stated the prices AEC is selling equipment to the Rochester Fire Protection District are better than prices they could get anywhere else.
- They have always given fair prices and there is no price gouging.
- When the Captains would call AEC for a price, they were not directly dealing with Archer the would get the price from whichever salesman was at the showroom.
- Previous fire chiefs did not put their captains in charge of spending.
  - o This was something Archer did to avoid a conflict of interest.
- AEC deals with all 21 fire departments in Sangamon County on various levels.
- Archer guarantees there is no one else on the board that shares Fairchild's viewpoint on this situation.
- There are several area fire departments that spend more money with AEC than Rochester.
- Rochester spends in the lower 25% compared to other local fire departments.
- The Rochester Fire Protection District is going to have to spend a lot more money now that they are not doing business with AEC.

- Riggs has been the president of the board of trustees for the Rochester Fire Protection District for the past three years.
- The other board members are Dennis Leonard, John Fox, Marty Fairchild and Gary McBride.
- Riggs has always known that Rochester Fire Chief John Archer was involved with AEC fire equipment company.
- Riggs believes all board members knew that John Archer was the owner of AEC when Archer was appointed to Fire Chief in March of 2018.
- No one brought up that there would be a conflict of interest if Archer was appointed chief.
- Marty Fairchild did not want the Archer to become chief.
- Fairchild made personal contact with all of the other candidates besides Archer to try and help them out with the interview process.
- Riggs didn't know why Fairchild didn't want Archer to be chief.
- There was a verbal vote to approve Archer as chief.
- Riggs thought everyone voted in favor of Archer.
- At the following board meeting, Fairchild advised he voted against the appointment of Archer.
- Riggs did not recall Fairchild bringing up a conflict of interest at the time Archer was approved.
- The first time Fairchild brought up the conflict of interest was at the board meeting on March 11, 2020.

- Fairchild said he would not vote to approve anymore invoices until this was corrected.
- The purchases for the fire department are mostly made through the two captains.
- Big purchases go through the board.
- The captains get competitive bids before making purchases.
- This process started when Archer became chief.
- The board reviews the invoices from the fire department every month.
- To Riggs' knowledge no one brought up a concern about the fire department's spending with AEC prior to the March 2020 meeting.
- There were never any spending items with AEC that came up for vote that Fairchild voted against.
- Riggs cannot think of any spending that has been denied.
  - Sometimes they will ask the department to go back and get more bids.
  - They typically get three bids
- The captains do not buy items exclusively through AEC.
- AEC has loaned them equipment and provided outstanding service.
- Most of the everyday equipment is from AEC.
- AEC usually has the best price.
- The new firetruck was purchased through a third-party organization.
- The board members were not involved in selecting the firetruck
- The captains formed a committee with members of the fire department.
  - There were no board members on the committee
- Fairchild did not want to buy a firetruck at all.
- Fairchild wanted an off-road vehicle for combine fires.
- Fairchild is a farmer and this would benefit him.
- Riggs was familiar with the Fire Protection District Act but did not know the wording for the certain dollar amounts until recently.
- No one ever brought up that they were over the \$2,000 yearly limit with AEC.
- All board members have been through a 12-hour training that covers the Fire Protection District Act.
- Riggs never felt like it was a conflict of interest that Archer owned AEC.

- Attorney James Sinclair made Riggs aware that they had been violating the Fire Protection District Act.
- At the May 13, 2020 meeting, Riggs advised the board that they would not be making purchases with AEC moving forward.

I. Call to order

President Riggs called to order the special meeting of the Rochester Fire Protection District at 6:00 p.m. on May 16, 2018 at the Rochester Firehouse.

#### II. Roll call

Trustee Fox conducted a roll call. The following persons were present: President Riggs, Trustee Fairchild, Trustee Fox, Trustee Cravens and Trustee Leonard. Also present was Deputy Chief John Archer and four members of the public.

#### III. Closed Session

Trustee Fox made a motion to go into Executive Session 5 ILCS120/2 c1. Second by Trustee Cravens. Unanimously approved.

## IX. <u>Return from Closed Session</u>

The special meeting opened at 6:42 pm. Trustee Fox took roll call: Trustee Leonard, Trustee Fox, Trustee Fairchild, Trustee Cravens and President Riggs were present.

Trustee Cravens made a motion to appoint John Archer as Chief of the Rochester Fire Protection District at a salary of \$27,300.00 effective immediately, second by Trustee Fox. Unanimously approved.

## X. Public Comment

A citizen questioned the Boards' appointment of our new Fire Chief making reference to the quality of the resumes that were submitted for the position. When questioned as to how she had access to the confidential materials, the citizen inquired "would there be a problem" and replied that she "did not know" how she had obtained the information and would not confirm or deny that she had indeed read the materials.

As a point of clarification, it should be noted that the appointment was unanimous with ALL Trustees voting in favor.



(c) In addition to contracts entered into under the <u>Governmental Joint Purchasing Act</u>, a board of trustees may enter into contracts <u>for supplies, materials, or work</u> involving an expenditure in excess of \$20,000 through participation in a joint governmental or nongovernmental purchasing program that requires as part of its selection procedure a competitive solicitation and procurement process. (Source: P.A. 101-139, eff. 7-26-19.)

They are given permission to enter contracts for supplies, materials, or work through participating in a Joint Government or nongovernmental purchasing program. A fire Truck is not supplies, materials, or work.

They have LIMTED power granted under the Government Joint purchasing act.

Sec. 2. Joint purchasing authority.

(a) Any governmental unit, except a governmental unit subject to the jurisdiction of a chief procurement officer established in Section 10-20 of the Illinois Procurement Code, <u>may purchase personal property, supplies and services jointly with one or more other governmental units.</u> All such joint purchases shall be by competitive

solicitation as provided in Section 4, except as otherwise provided in this Act. The provisions of any other acts under which a governmental unit operates which refer to purchases and procedures in connection therewith shall be superseded by the provisions of this Act when the governmental units are exercising the joint powers created by this Act.

# They have the power to purchase personal property, which a fire truck is, HOWEVER, it requires it to be a *JOINT purchase with one or more other governmental units*. That is NOT what happened as I understand it.

I believe they violated the law by making a purchase of real property without bidding. There purchase was NOT a JOINT purchases.

I need a LOT more details.

If the Chief or Trustee is the one connected to this purchase they have even more problems. (70 ILCS 705/4) (from Ch. 127 1/2, par. 24)

Sec. 4. Trustees; conflict of interest; violations.

(a) A board of trustees consisting of 3 members for the government and control of the affairs and business of a fire protection district incorporated under this Act shall be created in the following manner:

(1) If the district lies wholly within a single township but does not also lie wholly within a municipality, the board of trustees of that township shall appoint the trustees for the district but no township official who is eligible to vote on the appointment shall be eligible for such appointment.

(2) If the district is wholly contained within a municipality, the governing body of the municipality shall appoint the trustees for the district.

(3) If the district is wholly contained within a single county but does not lie wholly within a single township or a single municipality, the trustees for the district shall be appointed by the presiding officer of the county board with the advice and consent of the county board; except that in counties with a population in excess of 3,000,000, 2 trustees for the district shall be appointed by the board of trustees of the township that has the greatest population within the district as determined by the last preceding federal census. That board of trustees shall also appoint the remaining trustee if no other township comprises at least 10% of the population of the district. If only one other township comprises at least 10% of the population of the district, then the board of trustees of that district shall appoint the remaining trustee. If 2 or more other townships each comprise at least 10% of the population of the district, then the board so for trustees of those townships shall jointly appoint the remaining trustee. No township official who is eligible to vote on the appointment shall be eligible for the appointment.

(4) If the district is located in more than one county, the number of trustees who are residents of a county shall be in proportion, as nearly as practicable, to the number of residents of the district who reside in that county in relation to the total population of the district.

(A) In counties with a population of 3,000,000 or more, the trustees shall be appointed as provided in paragraphs (1), (2), and (3) of subsection (a) of this Section. For purposes of this item (A) and in item (B), "district" means that portion of the total fire protection district lying within a county with a population in excess of 3,000,000.

(B) In counties with a population of less than 3,000,000, the trustees for the district shall be appointed by the presiding officer of the county board with the advice and consent of the county board.

Upon the expiration of the term of a trustee who is in office on October 1, 1975, the successor shall be a resident of whichever county is entitled to such representation in order to bring about the proportional representation required herein, and he shall be appointed by the county board of that county, or in the case of a home rule county as defined by Article VII, Section 6 of the

Constitution of 1970, the chief executive officer of that county, with the advice and consent of the county board.

Thereafter, each trustee shall be succeeded by a resident of the same county who shall be appointed by the same appointing authority; however, the provisions of the preceding paragraph shall apply to the appointment of the successor to each trustee who is in office at the time of the publication of each decennial Federal census of population.

Within 60 days after the adoption of this Act as provided in Section 1, or within 60 days after the adoption of an ordinance pursuant to subsection (c) of Section 4.01, the appropriate appointing authority shall appoint 3 trustees who are electors in the district, not more than one of whom shall be from any one city or village or incorporated town in a district unless such city or village or incorporated town has more than 50% of the population in the district according to last preceding Federal census. Such trustees shall hold their offices thenceforward and for one, 2 and 3 years from the first Monday of May next after their appointment and until their successors have been selected and qualified and thereafter, unless the district has determined to elect trustees as provided in Section 4a, on or before the second Monday in April of each year the appointing authority shall appoint one trustee whose term shall be for 3 years commencing on the first Monday in May next after they are respectively appointed. The length of term of the first trustees shall be determined by lot at their first meeting.

Each trustee shall, before entering on the duties of his office, enter into bond with security to be approved by the appointing authority in such sum as the authority may determine.

A majority of the board of trustees shall constitute a quorum, but a smaller number may adjourn from day to day. <u>No trustee or employee of such district shall be directly or indirectly</u> <u>interested financially in any contract work or business or the sale of any article, the expense.</u> <u>price or consideration of which is paid by the district; nor in the purchase of any real estate or</u> <u>other property</u>, belonging to the district, or which shall be sold for taxes or assessments or by virtue of legal process at the suit of the district. Nothing in this Section prohibits the appointment or selection of any person or trustee or employee whose only interest in the district is as an owner of real estate in such fire protection district or of contributing to the payment of taxes levied by the district. The trustees shall have the power to provide and adopt a corporate seal for the district.

(b) However, <u>any trustee may provide materials, merchandise, property, services or labor, if:</u> A. the contract is with a person, firm, partnership, association, corporation or cooperative

association in which such interested trustee has less than a 7 1/2% share in the ownership; and B. such interested trustee publicly discloses the nature and extent of his interest prior to or during deliberations concerning the proposed award of the contract; and

C. such interested trustee abstains from voting on the award of the contract, though he shall be considered present for the purposes of establishing a quorum; and

D. such contract is approved by a majority vote of those trustees presently holding office; and

E. the contract is awarded after sealed bids to the lowest responsible bidder if the amount of the contract exceeds \$1500, but the contract may be awarded without bidding if the amount is less than \$1500; and

F. the award of the contract would not cause the aggregate amount of all such contracts so awarded to the same person, firm, association, partnership, corporation, or cooperative association in the same fiscal year to exceed \$25,000.

(c) In addition to the above exemption, any trustee or employee may provide materials, merchandise, property, services or labor if:

A. the award of the contract is approved by a majority vote of the board of trustees of the fire protection district provided that any such interested member shall abstain from voting; and B. the amount of the contract does not exceed \$1000;

C. the award of the contract would not cause the aggregate amount of all such contracts so awarded to the same person, firm, association, partnership, corporation, or cooperative association in the same fiscal year to exceed \$2000; and

D. such interested member publicly discloses the

nature and extent of his interest prior to or during deliberations concerning the proposed award of the contract; and

E. such interested member abstains from voting on the award of the contract, though he shall be considered present for the purposes of establishing a quorum.

(d) A contract for the procurement of public utility services by a district with a public utility company is not barred by this Section by one or more members of the board of trustees being an officer or employee of the public utility company or holding an ownership interest if no more than 7 1/2% in the public utility company, or holding an ownership interest of any size if the fire protection district has a population of less than 7,500 and the public utility's rates are approved by the Illinois Commerce Commission. An elected or appointed member of the board of trustees having such an interest shall be deemed not to have a prohibited interest under this Section.

(e) Any officer or employee who violates this Section is guilty of a Class 4 felony and in addition thereto any office held by such person so convicted shall become vacant and shall be so declared as part of the judgment of the court.

(f) Nothing contained in this Section, including the restrictions set forth in subsections (b), (c) and (d), shall preclude a contract of deposit of monies, loans or other financial services by a fire protection district with a local bank or local savings and loan association, regardless of whether a member or members of the board of trustees of the fire protection district are interested in such bank or savings and loan association as an officer or employee or as a holder of less than 7 1/2%of the total ownership interest. A member or members holding such an interest in such a contract shall not be deemed to be holding a prohibited interest for purposes of this Act. Such interested member or members of the board of trustees must publicly state the nature and extent of their interest during deliberations concerning the proposed award of such a contract, but shall not participate in any further deliberations concerning the proposed award. Such interested member or members shall not vote on such a proposed award. Any member or members abstaining from participation in deliberations and voting under this Section may be considered present for purposes of establishing a quorum. Award of such a contract shall require approval by a majority vote of those members presently holding office. Consideration and award of any such contract in which a member or members are interested may only be made at a regularly scheduled public meeting of the board of trustees of the fire protection district.

(g) Beginning on the effective date of this amendatory Act of 1990 and ending 3 years after the effective date of this amendatory Act of 1990, in the case of a fire protection district board of trustees in a county with a population of more than 400,000 but less than 450,000, according to the 1980 general census, created under subsection (a), paragraph (3) of this Section a petition for the redress of a trustee, charging the trustee with palpable omission of duty or nonfeasance in office, signed by not less than 5% of the electors of the district may be presented to the township supervisor or the presiding officer of the county board, as appropriate. Upon receipt of the petition, the township supervisor or presiding officer of the county board, as appropriate, shall preside over a hearing on the matter of the requested redress. The hearing shall be held not less than 14 nor more than 30 days after receipt of the petition. In the case of a fire protection district trustee appointed by the presiding officer of the county board, the presiding officer shall appoint at least 4 but not more than 8 members of the county board, a majority of whom shall reside in a county board district in which the fire protection district is wholly or partially located, to serve as the hearing panel. In the case of a fire protection district trustee appointed by the board of town trustees, the township supervisor and 2 other town trustees appointed by the supervisor shall serve as the hearing panel. Within 30 days after the hearing, the panel shall issue a statement of

its findings concerning the charges against the trustee, based upon the evidence presented at the hearing, and may make to the fire protection district any recommendations deemed appropriate.

(h) Any elected or appointed trustee of a fire protection district shall be entitled to absent himself or herself from any services or employment in which the trustee is then engaged or employed on the day and time of a meeting of the board of trustees of the fire protection district for the period of time during which the meeting is held and during any necessary time required to travel to and from the meeting. Any trustee availing himself or herself of this provision shall not be penalized in any manner by his or her employer as a result of an absence authorized by this subsection; however, the employer shall not be required to compensate the trustee for the time during which the trustee is absent. No employer shall refuse to grant to a trustee of a fire protection district the privilege granted by this subsection, nor shall any employer penalize or otherwise discriminate against any trustee who avails himself or herself of the provisions of this subsection, except as otherwise provided herein. No employer may directly or indirectly violate the provisions of this subsection. A "meeting" for purposes of this subsection shall have the same meaning as that provided under Section 1.02 of the Open Meetings Act.

(i) Under either of the following circumstances, a trustee may hold a position on the board of a not-for-profit corporation that is interested in a contract, work, or business of the fire protection district:

(1) If the trustee is appointed by the governing body of the fire protection district to represent the interests of the district on a not-for-profit corporation's board, then the trustee may actively vote on matters involving either that board or the fire protection district, at any time, so long as the membership on the not-for-profit board is not a paid position, except that the trustee may be reimbursed by the not-for-profit board for expenses incurred as the result of membership on the not-for-profit board.

(2) If the trustee is not appointed to the board of a not-for-profit corporation by the governing body of the fire protection district, then the trustee may continue to serve; however, the trustee shall abstain from voting on any proposition before the governing body of the fire protection district directly involving the not-for-profit corporation and, for those matters, shall not be counted as present for the purposes of a quorum of the governing body of the fire protection district.

I cannot tell you if anything was published regarding the purchase of the truck, however, under the amendment made to Section 11k to allow procurement by districts through a joint purchasing program, a notice would not be required.

The purpose of the notice in Section 11k is to disseminate the solicitation for competitive bids to potential vendors. It is not for the purpose of notifying the public that the district is making a procurement. In using a joint purchasing program, the competitive solicitation process occurs through the operation of the program in obtaining competitive proposals from multiple vendors which are then made available to purchasers.

Notification to the public of how the district authorizes the expenditure of public monies occurs by the adoption, filing, and publication of the budget annually. The budget includes the appropriation which is the authorization and notification.



#### Marty:

I expect that the reason it did not come up is that the question became moot when a brand other than that offered by AEC was selected. Bill's concern, rightly, was that a purchase through AEC could be contrary to Section 4 of the Fire Protection District Act or if using HGAC for the purchase would obviate that issue. I simply outlined the limitations of Section 4, and suggested that if a purchase was made through AEC directly or via a purchasing group, it would be the chief's responsibility to show that Section 4 would not be violated.

I also pointed out that the public "optics" of a purchase from AEC could be an issue even if there were no problem under Section 4.

The following is my email to Bill on the question before the decision was made to purchase the Sutphen vehicle:

#### "Bill:

I believe the legal test would be governed by Section 4 of the Illinois Fire Protection District Act (70 ILCS 705/4) and it would be whether the Chief (who would be considered an employee of the District for purposes of Section 4) would be "directly or indirectly interested financially in...the sale of any article, the expense, price or consideration of which is paid by the district" in the purchase of the Ferrara truck through the purchasing program. That is something which, in turn, would depend on how the particular purchasing program the district uses is structured between the manufacturers in the program and their dealers in a particular area. If, when a program purchase is made by a buyer, the dealer who serves the buyer's geographic area receives no part of the purchase price (directly or indirectly) and only the manufacturer is paid and receives the full benefit of the transaction with the dealer taking nothing, the purchase might not be prohibited by Section 4. But if there is any financial benefit at all which goes back to the dealer (even though the sale was made via the program). Section 4 would prohibit it. It would be the Chief's responsibility to show, to the satisfaction of the District, that Section 4 is not violated. For its part, the Board would want to have clear proof that there is no violation of Section 4 by the transaction. (A violation, by the way, is a Class 4 Felony and would also result in a forfeiture of the Chief's position.)

Beyond the legal issues noted above, however, the District does need to consider the "optics" of a purchase of a truck brand for which the Chief's company serves as a dealer. Even if Section 4 is not violated, social media may make this look like an inappropriate transaction in which the District favored the Chief and no matter what is said to refute this, the damage will be done. In today's world, these kinds of transactions, even if legal, can create significant problems.

To Whom It May Concern,

At the May 16, 2018, Special Meeting of the Rochester Fire Board, John Archer was appointed Fire Chief of the Rochester Fire Department. A simple voice vote was employed whereby a simultaneous affirmative response was given by four of five Board members. I gave no response and was NOT given the opportunity to give a no vote.

In the Executive Session that preceded the Open Session, the Board had a frank discussion about the several candidates interviewed for the position of Chief. My concerns for John Archer revolved around his position as President of A.E.C. Fire and Equipment Company and that there would be a serious conflict of interest should he be appointed as the Fire Chief. None of the other Board members shared my concerns.

John Fox and Dennis Leonard told me that I was off base and that my thinking was flawed. John Fox's comment: "How dare you talk about John that way. And furthermore, John would never put himself, his company or the Fire District in that position."

At the June 13, 2018, regular monthly meeting of the Rochester Fire Board, I took the opportunity to correct the Special Meeting Minutes of May 16, 2018. A copy of those minutes are attached.

After John Archer was appointed Chief, he and his company began conducting business with the District. To my knowledge, John Archer has completed and filed at least two Statements of Economic Interest with the County Clerk. Because of that and pressure from the other Board members assuring me that all was good, I continued on with the business of the District with the feeling of John Archer as the Chief just did not feel right.

After talking with the Edgar County Watchdogs, I reviewed the Fire Protection District Act and found that there is indeed the distinct possibility of a conflict with Chief John Archer and the District.

At the February 12, 2020, monthly Fire Board meeting, I asked Chief Archer to clarify his A.E.C.



- John Archer is the named agent of record for A.E.C. Fire Equipment Company (See Exhibit 2 – Secretary of State corporate record)
- A.E.C Fire Equipment company has issued invoices to the Rochester FPD for many years, of which the last three years appears to total over \$40,000.00 in billing. (See Exhibit 3 – invoices)
- John Archer was appointed as Fire Chief May 16, 2018. (See Exhibit 4)
- A written background summary is being provided (See Exhibit 5)

#### Fire Protection District Act

(70 ILCS 705/4) (from Ch. 127 1/2, par. 24)
 Sec. 4. Trustees; conflict of interest; violations

(c) In addition to the above exemption, <u>any</u> trustee <u>or employee</u> may provide materials, merchandise, property, services or labor if:

(e) Any officer or employee who violates this Section is guilty of a Class 4 felony and in addition thereto any office held by such person so convicted shall become vacant and shall be so declared as part of the judgment of the court.

Invoices reflect numerous billings that exceed \$1000.00 and clearly the aggregate of such billing far exceeds the allowable limit of \$2,000.00

All indications point to John Archer violating the conflict of interest provisions found in the Fire Protection District Act and such a violation is considered to be a class 4 felony.

Based on the clearly established probable cause, I am filing this as a **formal criminal complaint** and pray the appropriate authorities investigate this matter and forward their findings to the State's Attorney to make a charging decision.

On Tuesday, July 21, 2020 at 8:57 am., Special Agent Zach Colbrook #6622 and I Special Agent Alex Colbrook #6621 interviewed Matthew J. Sunderland () in a conference room at the Illinois State Police Central Headquarters. Sunderland agreed to do an audio recorded interview. the following is a not verbatim summary of the interview.

- Sunderland works full time for the Illinois Department of Transportation and has been with them for 21 years.
- Sunderland has also been a volunteer with the Rochester Fire Protection District for the past 10 years.
- Sunderland receives a \$5,000 dollar per year salary because he is a captain with the fire department.
- He also gets a stipend for each call that he responds too.
- He has been a captain since early 2018.
- Sunderland works on the personnel side.
  - He does paper work for new members.
  - He does member evaluations.
  - He oversees the junior fire fighter program.
  - He files the run sheets and does weekly rig checks.
- When Chief Archer was named chief, he approached Sunderland and told him that he needed purchases to for the department to go through someone else due to a potential conflict of interest.
- Chief Archer put Matt Sunderland and Kirk Polley in charge of most purchases.
- Sunderland mostly purchased small amounts of 2 cycle and 4 cycle fuel from AEC.
- He would also purchase gloves for new members from AEC.
- AEC is the only local fire equipment dealer so it was most practical to call them for small purchases.

- Most purchases he made were under \$100.
- They buy a full set of gear that costs thousands of dollars maybe three times a year.
- Sunderland would also ask other members to research products and prices online.
- If AEC was cheaper they would go with them.
- They did not keep quotes they had found from other companies. It was mostly just comparing other prices online.
- Sunderland didn't compare prices when buying the fuel because AEC had it locally and it was something they needed right away.
- The fuel is for small equipment like chainsaws.
- Sunderland doesn't know if there is another vendor who has this fuel locally.
- When Sunderland took over making purchases the department had been dealing with AEC for years.
- It made sense for Sunderland to continue to purchase from AEC because that is what past chiefs had done.
- Sunderland did not think there would be any issues if he mad purchases with AEC.
- Sunderland has not bought anything outside of AEC but he knows there are chainsaws and vent saws that were purchased from other companies.
- Sunderland is in charge of the supply cabinet and would make purchases when he thought it was needed.
- If he grabbed the last can of fuel he would call AEC and ask for five more 2 cycle fuel cans.
- Sunderland would occasionally ask fellow member Chance Torchia to research products and prices
- Chief Archer has never told Sunderland that he has to purchase anything through AEC
- Chief Archer has never offered Sunderland money or any sort of kickback to make purchases with AEC.
- After the department makes purchases the invoices go to Denise Garceau, the secretary.
- Board Trustee Marty Fairchild brought up in a board meeting that a crime had been committed.
- Marty said that it was illegal to be making purchases with AEC because a conflict of interest.
- Either President Bill Riggs or board member Dennis Leonard replied they would have the Attorney look into it but they did not believe a crime had been committed.
- The lawyer told the board that he didn't think they were knowingly doing something wrong but, it was wrong and they should no longer make purchases with AEC.

On Tuesday, July 21, 2020 at 9:38 am., Special Agent Zach Colbrook #6622 and I, Special Agent Alex Colbrook #6621 interviewed Kirk A. Polley (M/ in a conference room in the Illinois State Police Central Headquarters. Polley agreed to do an audio recorded interview. The following is a not verbatim summary of the interview.

- Polley has worked for Sangamon County 9-1-1 since 2006.
- Polley has been a member of the Rochester Fire Protection District since 2011.
- Polley has been a captain since 2018.
- Polley and Matt Sunderland are the captains and are the highest officers under Chief Archer.
- Polley coordinates trainings and personnel matters.
- When items need to be purchased, they typically see which member wants to "pick up the ball and roll with it."
- If Polley or Sunderland notice something is getting low they will order it or ask someone to go pick it up.
- If there is a big purchase they ask the chief for permission before buying it.
- For smaller items they just go out and buy it.
- Chief Archer doesn't tell them where they have to make the purchases at.
- He just wants them to find good products.
- Chief Archer owns AEC Fire Equipment store.
- For example, they recently had to purchase an exhaust fan.
- They got a price from AEC but also researched prices from other companies.
- AEC had the lowest price so that is where they purchased the fan.

- Sometimes they purchase from AEC and sometimes they do not.
- Polley is known as the tightwad on the department and is always looking for the best price.
- Sometimes Polley will just call John Archer or another member that works at AEC and tell them to pick up something small like a pair of gloves.
- AEC is the local Fire Equipment store and he doesn't want to wait for certain items to be shipped.
- AEC is the same local supplier that the department has been going through forever.
- Polley also searches online for products.
- Many of the items are purchased on Amazon.
- Everything they purchase has a receipt that goes to the secretary and everything is purchased with a credit card.
- Chief Archer has never told Polley that he had to buy an item through AEC.
- Chief Archer has never offered Polley money or any sort of kick back for buying something through AEC.
- Polley has worked for three chiefs now.
- The previous two chiefs also made purchases at AEC.
- There has been no increase in business with AEC since Archer took over as chief.
- The department does not spend money on unnecessary items.
- No one besides Trustee Martin Fairchild has had a problem with the department making purchases at AEC.
- Everyone on the board was aware of the spending with AEC and was aware that John Archer owned AEC.
- The board reviews the spending every month.
- Polley always assumed they were in compliance with whatever laws were in place.
- The attorney for the fire department advised them to stop making purchases at AEC.
- They have not had to purchase any fire-specific equipment since the decision was made.

This letter follows Mr. Leonard's request that we review transactions between the District and A.E.C. Fire Safety Security, a vendor of the District, since May 2018. This corresponds to the tenure of Chief Archer, who we understand to be a principal of A.E.C., with the District.

As we have previously advised, Section 4 of the Illinois Fire Protection District Act (70 ILCS 705/4) as well as the Public Officers Prohibited Activities Act (50 ILCS 105) place very stringent limitations on any transaction between the district and an employee (or trustee) of the District. I have laid this out in previous emails in May 2018 and November 2019. The basic rule under Section 4 is that "no trustee or employee of such District shall be directly or indirectly interested financially in any contract work or business or the sale of any article, the expense, price or consideration of which is paid by the District; ...." This is the general rule. For an employee of the District there is an exception to the general rule in Section 4(c) which provides that:

(c) in addition to the above exception, any trustee or employee may provide materials, merchandise, property, services or labor if:

A. the award of the contract is approved by a majority vote of the Board of Trustees of the Fire Protection District provided that any such interested member shall abstain from voting; and

B. the amount of the contract does not exceed \$1,000; and

C. the award of the contract would not cause the aggregate amount of all such contracts so awarded to the same person, firm, association partnership, corporation, or cooperative association in the same fiscal year to exceed \$2,000; and

D. such interested member publicly discloses the nature and extent of his

interest prior to or during deliberations concerning the proposed award of the contract; and

E. such interested member abstains from voting on the award of the contract, though he shall be considered present for purposes of establishing a quorum.

Based on review of the invoices from May 2018, it appears that the District has made purchases from A.E.C. which total \$25,279.37. It also appears that all but three of these purchases were below the \$1,000.00 per transaction limitation contained in section 4(c), and, except as to those three purchases, the transactions would be within the allowable limit. However, the combined total of the invoices exceeds the allowable \$2,000.00 per fiscal year limitation of section 4(c) C. This means that the purchases in the period from May 2018 would not be in compliance with the statute.

The statute does not contain any sort of additional exception. Because there is the potential of criminal penalties associated with the failure to comply with the provisions of Section 4 concerning transactions within the scope of the statute, it is important to maintain compliance with the statute.

Accordingly, it would be our recommendation that the District discontinue making any purchases from A.E.C. Fire Safety Security at this time and going forward except to the extent that such purchases fall clearly within the allowable exception of Section 4(c).

I will be happy to discuss this matter further with the Board at a meeting at any mutually agreeable time. If, in the meantime, there are any questions, please contact me.

Bill:

I believe the legal test would be governed by Section 4 of the Illinois Fire Protection District Act (70 ILCS 705/4) and it would be whether the Chief (who would be considered an employee of the District for purposes of Section 4) would be "directly or indirectly interested financially in...the sale of any article, the expense, price or consideration of which is paid by the district" in the purchase of the Ferrara truck through the purchasing program. That is something which, in turn, would depend on how the particular purchasing program the district uses is structured between the manufacturers in the program and their dealers in a particular area. If, when a program purchase is made by a buyer, the dealer who serves the buyer's geographic area receives no part of the purchase price (directly or indirectly) and only the manufacturer is paid and receives the full benefit of the transaction with the dealer taking nothing, the purchase might not be prohibited by Section 4. But if there is any financial benefit at all which goes back to the dealer (even though the sale was made via the program), Section 4 would prohibit it. It would be the Chief's responsibility to show, to the satisfaction of the District, that Section 4 is not violated. For its part, the Board would want to have clear proof that there is no violation of Section 4 by the transaction. (A violation, by the way, is a Class 4 Felony and would also result in a forfeiture of the Chief's position.)

Beyond the legal issues noted above, however, the District does need to consider the "optics" of a purchase of a truck brand for which the Chief's company serves as a dealer. Even if Section 4 is not violated, social media may make this look like an inappropriate transaction in which the District favored the Chief and no matter what is said to refute this, the damage will be done. In today's world, these kinds of transactions, even if legal, can create significant problems.





- John has been with the Rochester Fire Protection District since 2011.

- A.E.C sells equipment to local fire departments.
- Martin opposed John's appointment to Chief because of the conflict of interest he would have doing business with the company that he owned.
- Board members John Fox and Dennis Leonard assured Martin that John Archer would never put the Fire district in that position.

- As chief, John was allowed to spend up to \$1200 without the board's approval.
- Anything over \$1200 would need to be approved by the board before purchasing.
- The board reviewed Chief Archer's spending every month.
- Under the Fire Protection District Act (70 ILCS 705/4) (from Ch. 127 1/2, par. 24) Chief Archer would only be allowed to make a sale of less than \$1,000 with A.E.C.
  - According to the invoices there are several instances where the contract is over \$1,000
- Chief Archer would also be limited \$2,000 per fiscal year.
  - Fairchild believes Archer has done over \$40,000 worth of business with A.E.C since becoming chief in 2018.
- Martin knew Chief Archer was conducting too much business with A.E.C. from the beginning but let it go.
- The entire board knew Chief Archer was violating the Fire Protection District Act but did not tell him to stop.
- Martin even approved some of the purchases because he thought they were things that the fire department really needed.
- Martin decided to come forward with these allegations because he was left out of the process of buying a new fire truck.
- The board formed a committee to purchase a new fire truck.
- Martin was upset because he was not part of the committee and he has a lot of experience with the fire protection district.
- Martin voted against the purchase of the new firetruck but it passed anyway.
- The truck was not purchased through A.E.C but Martin believes Chief Archer will outfit the truck with \$50,000 \$70,000 worth of equipment from A.E.C.
- Martin contacted the Edgar County Watchdogs for help.
- During the February 2020 board meeting a member of the Edgar County Watchdogs asked Chief Archer if he was personally benefitting from his dealings with A.E.C and the Fire Protection District.
  - Chief Archer replied that he was not personally benefitting.
- The board never told Chief Archer "no" when it came to making purchases.
- Marty claims that he does not have any personal issues with Chief Archer and has known him for a long time.
