If you haven't already heard, a few in Springfield are once again attempting to revise each of our organization's legislation so that we no longer receive tax revenue from recreational cannabis sales of any type sold within our jurisdictions. Others affected by the current proposed legislation would be the Civic Center Code (I think a.k.a. the Peoria Civic Center), the Regional Transportation Authority, and all State Water Commissions organized under (70 ILCS 3720/).

Similar to other recent efforts (like <u>SB3469</u>), the following language would be added to each of our organization's legislation. "Notwithstanding any other provision of law, no tax may be imposed under this section on the sale or use of cannabis, as defined in Section 1-10 of the Cannabis Regulation and Tax Act (410 ILCS 705/)". Section 1-10 of the Cannabis Regulation and Tax Act basically defines cannabis as any product derived from cannabis, e.g. flower, concentrate, and infused products.

Here is a copy of the latest attempt filed yesterday. To find the section that affects your organization, click here, then click "Ctrl" and "f" at the same time, this will open up the find feature, then type a word or two of the name of your enabling legislation, then press enter. You'll see the legislative change referenced above will be underlined within your organization's section... meaning it is being added to the legislation.
