**COMPLAINT**

NOW COMES PLAINTIFF ROBERT EDWARD DORMAN, Pro Se for his complaint against the Defendant, THE MADISON COUNTY STATES ATTORNEY, and pursuant to 5 ILCS 140/1 *et seq.*, and in support of his complaint states as follows.

1. Pursuant to 735 ILCS 5/2-101, venue for this action lies in this court in that a) The Madison County States Attorney office is a public agency in Madison County, and b) the activity of which Plaintiff occurred is in Madison County.
2. Plaintiff ROBERT EDWARD DORMAN, is a resident of Madison County.
3. Pursuant to the fundamental philosophy of the American constitutional form of government, it is the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Illinois Freedom of Information Act ("FOIA") 5 ILCS 140/1.
4. Restraints on access to information, to the extent permitted by FOIA, are limited exceptions to the principle that the people of this State have a right to full disclosure of information relating to the decisions, policies, procedures, rules standards and other aspects of government activities that affect the conduct of government and the lives of the people. 5 ILCS 140/1

5. All public records of a public body are presumed to be open to inspection or copying. Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt. 5 ILCS 140/3

6. Under the FOIA Section 11(h), “except as to causes the court considers to be of greater importance, proceedings arising under [FOIA] shall take precedence on the docket over all other causes and be assigned for hearing and trial at the earliest practicable date and expedited in every way.”

### **THE MARCH 21<sup>ST</sup>, 2021 FREEDOM OF INFORMATION ACT REQUESTS BY PLAINTIFF**

7. On March 21<sup>st</sup>, 2021 via email, Plaintiff propounded under the provisions of the Freedom of information Act to the Madison County States Attorney FOIA Officer a request and amended request for

- II** Digital copies of any and all emails received replied to and or forwarded by Jennifer Mudge containing the attachment "RNP0026735A36A4 from October of 2016.
- III** A digital copy of Jennifer Mudge's outlook calendar for September, October, November and December 2016 and January 2017.
- IV** An amendment to the request to include Jennifer Mudge and or Jennifer Vucich and any email sent or received and or forwarded by her with the title "List" on June 15, 2016 including attachments.

### **THE FIRST RESPONSE BY DEFENDANT TO PLAINTIFF ON MARCH 29<sup>th</sup>, 2021**

8. The response by the Defendant was as follow:

*“Request I: After diligent search, this office has no documents responsive to Request 1 of your March 22, 2021, FOIA request. As there are no extant documents responsive to your request, this office now considers the matter of your Request 1 of your March 22, 2021, FOIA request closed.*

*Request II: After diligent search, this office has no documents responsive to Request 2 of your March 22, 2021, FOIA request. As there are no extant documents responsive to your request, this office now considers the matter of your Request 2 of your March 22, 2021, FOIA request closed.*

Request III: *We are determining the feasibility of accessing the information requested in Request 3 of your March 22, 2021, FOIA request, and will advise further.*

Request IV: After diligent search, this office has no documents responsive to *Request 4* of your amended FOIA request of March 22, 2021. As there are no extant documents responsive to your request, this office now considers the matter of your *Request 4* of your March 22, 2021, amended FOIA request closed.”

## **THE SECOND RESPONSE BY DEFENDANT TO PLAINTIFF ON APRIL 21st, 2021**

9. Request IV: *“Please Include a digital copy of Jennifer Mudge's outlook calendar for September, October, November and December 2016 and January 2017.”*

*Please find attached documents responsive to your request, redactions have been made under 5 ILCS 140/7(1)(c).*

*Under Illinois law, the following is exempt from inspection and copying:*

*Personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information. “Unwarranted invasion of personal privacy” means the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject’s right to privacy outweighs any legitimate public interest in obtaining the information. The disclosure of information that bears on the public duties of public employees and officials shall not be considered an invasion of personal privacy. 5 ILCS 140/7(1)(c).”*

## **ANALYSIS OF DEFENDANTS SECOND RESPONSE**

10. Pursuant to 5 ILCS 140/3(d) the public body must either comply or deny the request within 5 business days from the receipt of the request unless the time for response is properly extended under subsection (e) for an additional 5 business days.

11. Defendant improperly denied Plaintiff’s request by not providing a version of the records in accordance with established law pursuant to the Act and instead claimed broad exemption under 5 ILCS 140/7(1)(c).

## **ANALYSIS OF 5 ILCS 140/7(1)(c)**

### **12. 5 ILCS 140/7**

(1) When a request is made to inspect or copy a public record that contains information that is exempt from disclosure under this Section, but also contains information that is not exempt from disclosure, the public body may elect to redact the information that is exempt. The public body shall make the remaining information available for inspection and copying.

13. The Madison County States Attorney Office has improperly denied the requested records because there is no identification as to specifically why the redactions were done other than the claimed exemption en masse.

## **ANALYSIS OF 5 ILCS 140/1**

### **14. (5 ILCS 140/1)**

Sec. 1. Restraints on access to information, to the extent permitted by this Act, are limited exceptions to the principle that the people of this State have a right to full disclosure of information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of any or all of the people. The provisions of this Act shall be construed in accordance with this principle. This Act shall be construed to require disclosure of requested information as expediently and efficiently as possible and adherence to the deadlines established in this Act.

15. (5 ILCS 140/1.2) of the Act states Sec. 1.2. Presumption. All records in the custody or possession of a public body are presumed to be open to inspection or copying. *Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt.* (Emphasis added)

16. Because the Defendant failed to provide any specific reason for each of the redactions, the Defendant has failed to meet the burden by clear and convincing evidence that any of them are exempt.

## **A JUDGE NOT FROM THE THIRD JUDICIAL CIRCUIT IS APPROPRIATE TO ADJUDICATE THIS MATTER**

17. William “Bill” Mudge and his spouse Jennifer Mudge, formerly Jennifer Vucich ex wife of Madison County Public Corruption Task Force Commander David Vucich are both named subjects in the FOIA request responses.

18. Bill Mudge is the Chief Judge of the Circuit Court of the Third Judicial Circuit of Illinois.

19. As Chief Judge, Bill Mudge is responsible for general administrative authority in the circuit.

20. In order to uphold CANON 1 of the Judicial Code of Conduct so that the integrity and independence of the judiciary may be preserved and to uphold CANON 2 of the Judicial Code of Conduct in a manner that promotes public confidence in the integrity and impartiality of the judiciary it is appropriate that a Judge from another Circuit resolve this matter.

## **CODE OF JUDICIAL CONDUCT**

### **CANON 1**

#### **A Judge Should Uphold the Integrity and Independence of the Judiciary**

21. An independent and honorable judiciary is indispensable to justice in our society. A judge should participate in establishing, maintaining, and enforcing, and should personally observe, high standards of conduct so that the integrity and independence of the judiciary may be preserved. The provisions of this Code should be construed and applied to further that objective.

### **CANON 2**

#### **A Judge Should Avoid Impropriety and the Appearance of Impropriety in All of the Judge's Activities**

22. A. A judge should respect and comply with the law and should conduct himself or herself at all times in a manner that promotes public confidence in the integrity and impartiality of the judiciary.

23. B. A judge should not allow the judge's family, social, or other relationships to influence the judge's judicial conduct or judgment. A judge should not lend the prestige of judicial office to advance the private interests of others; nor should a judge convey or permit others to convey the impression that they are in a special position to influence the judge. A judge should not testify voluntarily as a character witness.

WHEREFORE, Plaintiff prays that this Court provide a Judge not from the 3<sup>rd</sup> Circuit to hear this matter and:

- i) In accordance with FOIA Section 11(f), afford this case precedence on the Court's docket except as for causes the Court considers to be of greater importance, assign this case for hearing and trial at the earliest practicable date, and expedite this case in every way.
- ii) Declare that the Office of the Madison County States Attorney has violated FOIA.
- iii) Order the Office of the Madison County States Attorney to un-redact the non-exempt information and produce the requested records.
- iv) Enjoin the Office of Madison County States Attorney from withholding or redacting non-exempt public records under FOIA.
- v) Order the Office of Madison County States Attorney to pay civil penalties
- vi) Award Court costs and other relief as the Court considers appropriate.
