#### **COMPLAINT**

NOW COME Plaintiffs, EDGAR COUNTY WATCHDOGS and EDGAR PAL, by their undersigned attorneys, Loevy & Loevy, and bring this Freedom of Information Act (FOIA) and Open Meetings Act (OMA) suit to force THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL ("OIAG") and OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD ("PPCMB") to comply with FOIA and OMA. PPCMB violated OMA by discussing issues in a closed session that must be discussed in an open session, by redacting minutes from open sessions, and by failing to produce the verbatim audio recordings and minutes from the improper closed session held during PPCMB's June 8, 2021 public meeting. OIAG violated FOIA by failing to produce the verbatim audio recordings and unredacted minutes from PPCMB's meetings that were held on May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, May 14, 2021, and June 8, 2021. In support of the Complaint, Plaintiffs state as follows:

#### **INTRODUCTION**

1. Pursuant to the fundamental philosophy of the American constitutional form of government, it is the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Illinois Freedom of Information Act ("FOIA"). 5 ILCS 140/1.

2. Restraints on access to information, to the extent permitted by FOIA, are limited exceptions to the principle that the people of this state have a right to full disclosure of information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of the people. 5 ILCS 140/1.

3. Under FOIA Section 1.2, "[a]ll records in the custody or possession of a public body are presumed to be open to inspection or copying. Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt." 5 ILCS 140/1.2.

4. Pursuant to the public policy of the State of Illinois, public bodies exist to aid in the conduct of the people's business and the people have a right to be informed as to the conduct of their business. Actions and deliberations of public bodies must be taken openly in order to promote transparency and accountability at all levels of government. Such openness is crucial to democracy. 5 ILCS 120/1.

5. Under the Illinois Open Meetings Act, citizens shall be given advance notice of and the right to attend all meetings at which any business of a public body is discussed or acted upon in any way. Exceptions to the public's right to attend exist only in those limited

circumstances where the General Assembly has specifically determined that the public interest would be clearly endangered or that the personal privacy or guaranteed rights of individuals would be clearly in danger of unwarranted invasion. 5 ILCS 120/1.

6. The General Assembly has declared that it is the citizen's right to know and the provisions for exceptions of the open meeting requirements shall be strictly construed against closed meetings. 5 ILCS 120/1.

#### PARTIES

7. Plaintiff EDGAR COUNTY WATCHDOGS is a non-profit news media organization located in Paris, Illinois.

8. Plaintiff EDGAR PAL is a resident of Chicago, Illinois.

9. Defendant THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL ("OIAG") is a statewide agency, located in Cook County among others, and a public body under FOIA and OMA.

10. Defendant OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD ("PPCMB") is a statewide agency, located in Cook County among others, and a public body under FOIA and OMA.

#### **OMA - JUNE 8, 2021 SPECIAL MEETING**

11. On June 8, 2021, PPCMB held a special meeting via telephone conference.

12. At this meeting, PPCMB entered into closed session "pursuant to section 2(c)(8) of the Open Meetings Act to discuss the redaction of minutes previously approved by the Board in May 2021, for reasons related to security procedures and the use of personnel and equipment to respond to an actual, threatened, or reasonably potential danger to the safety of the public and public property." Exhibit A at 1 and 3.

13. The closed session included a discussion about redacting the meeting minutes from PPCMB's May 7, 2021, May 10, 2021, May 13, 2021, and May 14, 2021 meetings. These minutes were previously reviewed and approved by PPCMB at the June 2, 2021 meeting.

14. PPCMB never voted to enter into closed session nor entered into closed sessions during its meetings held on May 7, 2021; May 10, 2021; May 13, 2021; and May 14, 2021.

15. All of the meetings from May 7, 2021; May 10, 2021; May 13, 2021; and May 14,2021 were open meetings under OMA.

16. Section 2(c)(8) of OMA authorizes discussions regarding security procedures to take place in a closed session.

17. Section 2(c)(8) of OMA does not authorize discussion in closed session of redacting minutes of public meetings.

18. Section 2(c)(8) of OMA does not authorize the redaction of minutes from open sessions.

19. Further, in response to Plaintiffs' FOIA requests to OIAG for verbatim audio recordings of PPCMB's public meetings held on the May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, May 14, 2021, and June 8, 2021, Defendants violated Section 7(e)(9) of OMA by failing to produce the verbatim audio recordings of PPCMB's meetings to the public.

#### ECW'S JULY 14, 2021 FOIA REQUEST

20. On July 14, 2021, ECW submitted a FOIA request to OIAG for 1) "[c]opy of meeting agendas for all meetings of the Procurement Policy Compliance and Monitoring Board held during May and June of 2021" and 2) "[c]opy of all meeting recordings (audio) for all meetings of the Procurement Policy Compliance and Monitoring Board held during May and June 2021." Exhibit B.

21. OIAG assigned reference number 104 to the matter.

22. On July 21, 2021, OIAG partially granted the request by providing some meeting agendas. Exhibit C.

23. OIAG failed to provide meeting agendas for PPCMB's meetings from May 7, 2021, May 10, 2021, May 13, 2021, May 14, 2021, and May 19, 2021. These meetings are not posted on PPCMB'S website, but PPCMB reviewed and approved the minutes of these meetings at the June 2, 2021 meeting. Exhibit D.

24. Regarding Item 1 of the request, the meeting agendas from PPCMB's May 7, 2021, May 10, 2021, May 13, 2021, May 14, 2021, and May 19, 2021 meetings are at issue in this case.

25. Regarding Item 2 of the request, which sought verbatim audio recordings of all PPCMB meetings held in May and June of 2021, OIAG took a five-business day extension. Exhibit C.

26. Over the next two weeks, OIAG produced additional records pertaining to Item 2 of the Request. Exhibit E.

27. On August 3, 2021, OIAG produced verbatim audio recordings of three additional PPCMB meetings. OIAG also issued a final response. Exhibit F.

28. OIAG withheld the verbatim audio recordings of PPCMB's meetings from May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021 by citing FOIA Section 7(1)(o) and 7(1)(v). *Id*.

29. Regarding Item 2 of the request, the verbatim audio recordings of PPCMB's meetings from May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021 are at issue in this case.

30. OIAG stated that it is "attempting to obtain the redacted copies of these recordings as quickly as possible" and will inform ECW when the redacted recordings are available. *Id.* 

31. According to the redacted minutes that PPCMB previously shared with the public on its website<sup>1</sup>, the May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021 public meetings were "emergency session[s]." Exhibit G.

32. PPCMB never voted to enter into closed session during these meetings. These were open meetings pursuant to OMA. *Id.* 

33. FOIA does not authorize a public body to redact the verbatim audio recordings or minutes of open meetings.

34. Even if FOIA allows the public body to retroactively redact and withhold verbatim audio recordings or minutes of open meetings, which it does not, in violation of Section 9(a) of FOIA, OIAG did not provide a "detailed factual basis for the application of any exemption claimed" to withhold the verbatim audio recordings of PPCMB's open meetings from May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021; more specifically, OIAG has not shown how the requested records are exempt pursuant to Section 7(1)(o) and 7(1)(v). 5 ILCS 140/9(a).

35. Section 7(1)(o) of FOIA exempts:

Administrative or technical information associated with automated data processing operations, including but not limited to software, operating protocols, computer program abstracts, file layouts, source listings, object modules, load modules, user guides, documentation pertaining to all logical and physical design of computerized systems, employee manuals, and any other information that, *if disclosed, would jeopardize the security of the system or its data or the security of materials exempt under this Section*.

#### 5 ILCS 140/7(1)(v). (Emphasis added).

#### 36. Section 7(1)(v) of FOIA exempts:

Vulnerability assessments, security measures, and response policies or plans that are designed to identify, prevent, or respond to potential attacks upon a community's population or systems, facilities, or installations, the destruction or contamination of which would constitute a clear and present danger to the health or safety of the community, but *only to the extent that disclosure could reasonably be expected to jeopardize the effectiveness of the measures or the safety of the personnel who implement them or the public*. Information exempt under this item may include such things as details pertaining to the mobilization or deployment of personnel or equipment, to the operation of communication system protocols, or to tactical operations

5 ILCS 140/7(1)(v). (Emphasis added).

37. OIAG has not demonstrated (1) how the disclosure of the records—verbatim audio recordings of these specific open meetings—would "jeopardize the security of the system or its data or the security of materials exempt under" Section 7(1)(0); and 2) how the disclosure of such records "could reasonably be expected to jeopardize the effectiveness of the measures or the safety of the personnel who implement them or the public" pursuant to Section 7(1)(v).

38. OIAG provided only a generic claim indicating that the verbatim audio recordings of these open meetings "contain information related to the security of this office's computer network and the steps taken to mitigate the harm resulting from the recent ransomware incident experienced" by OIAG. Exhibit F.

39. OIAG failed to demonstrate that the records responsive to the request are exempt under FOIA.

40. Even if OIAG does produce the redacted recordings in the near future as it indicated it would upon obtaining them, ECW alleges that OIAG failed to demonstrate that the redacted records are exempt under FOIA.

41. As of the date of this filing, OIAG has not complied with FOIA and has not produced all records responsive to the request.

#### EDGAR PAL'S FOIA REQUESTS

#### July 13, 2021 FOIA Request

42. On July 13, 2021, PAL mailed a FOIA request to OIAG for "the agendas, unredacted minutes, and verbatim recordings of the meetings of the Procurement Policy Compliance and Monitoring Board held on the following dates: May 7, 2021; May 10, 2021; May 13, 2021; and May 14, 2021." Exhibit H.

43. According to the USPS website, the request was delivered on July 19, 2021. Id.

44. PAL sent the identical request to OIAG via email on July 21, 2021. Exhibit I.

45. On July 22, 2021, OIAG confirmed receipt of the request. Id.

46. OIAG assigned reference number 115 to the matter.

47. On July 26, 2021, OIAG sought an extension of five business days. PAL received the letter on July 29, 2021, via email. Exhibit J.

48. On August 2, 2021, OIAG produced the written minute and verbatim audio recording of May 10, 2021 Emergency Meeting (2:01 p.m.). Exhibit K.

49. OIAG sought another extension regarding the remaining written minutes and verbatim audio recordings from PPCMB's meetings from May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021. *Id*.

50. On August 2, 2021, PAL stated that he does not agree to any further extensions that are beyond the single extension provided by the statute without the requester's consent. Exhibit L.

51. On August 4, 2021, OIAG stated that neither PPCMB nor OIAG possesses the agendas of the PPCMB's meetings from May 7, 2021, May 10, 2021 (both 11:04 a.m. and 2:01 p.m.), May 13, 2021, or May 14, 2021. Exhibit M.

52. OIAG stated that it is "still searching for the unredacted minutes" of PPCMB's meetings from May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021. *Id*.

53. Regarding the verbatim audio recordings of PPCMB's May 7, 2021, May 10, 2021 (11:04 a.m.), May 13, 2021, and May 14, 2021 open meetings, OIAG stated that it is "reviewing" them as the audio recordings of these meetings "contain information related to the security of this office's computer network and the steps taken to mitigate the harm resulting from the recent ransomware incident" experienced by OIAG. OIAG further stated that the information is "exempt under sections 7(1)(0) and 7(1)(v) of FOIA" and will provide the redacted copies of these recordings when they are available. *Id*.

54. OIAG's deadline to comply with the request was August 2, 2021.

55. Section 3(e) of FOIA allows the public body to take an extension for "not more than 5 business days from the original due date." Section 3(e) also states that the requester and the public body "may agree in writing to extend the time for compliance for a time period to be determined by the parties." 5 ILCS 140/3(e).

56. As stated in the August 2, 2021 correspondence, PAL did not agree to OIAG's second extension. Exhibit L.

57. Section 3(d) of FOIA states:

Each public body shall, promptly, either comply with or deny a request for public records within 5 business days after its receipt of the request, unless the time for response is properly extended under subsection (e) of this Section. Denial shall be in writing as provided in Section 9 of this Act. *Failure to comply with a written request, extend the time for response, or deny a request within 5 business days after its receipt shall be considered a denial of the request.* A public body that

fails to respond to a request within the requisite periods in this Section but thereafter provides the requester with copies of the requested public records may not impose a fee for such copies. A public body that fails to respond to a request received may not treat the request as unduly burdensome under subsection (g).

5 ILCS 140/3(d). (Emphasis added).

58. As of the date of this filing, OIAG has not complied with FOIA and has not produced all records responsive to the request.

#### July 14, 2021 FOIA Request

59. On July 14, 2021, PAL mailed a FOIA request to OIAG for "the closed session minutes and closed session verbatim recording of the Procurement Policy Compliance and Monitoring Board meeting held on June 8, 2021." Exhibit N.

60. Upon learning that the mail was delayed, PAL sent the identical request to OIAG via email on July 21, 2021. Exhibit O.

61. OIAG assigned reference number 112 to the matter.

62. On July 28, 2021, OIAG denied the request in its entirety. Exhibit P.

63. Regarding the closed session minutes from the June 8, 2021 meeting, OIAG stated that Defendants do not possess "transcribed or approved closed session minutes." *Id.* 

64. Regarding the request for the verbatim recording of the closed session held at PPCMB's June 8, 2021 Special Meeting, OIAG stated that the record is exempt by citing Section 7(1)(a) of FOIA in conjunction with Section 2.06(e) of OMA. *Id.* 

65. OIAG claimed that there has been no determination by PPCMB that the verbatim record of the closed session "no longer requires confidential treatment" or that PPCMB "otherwise consented to the disclosure of the recording." *Id.* 

66. Section 7(1)(a) of FOIA and Section 2.06(e) of OMA do not apply to the verbatim recording of the closed session held during PPCMB's June 8, 2021 meeting.

67. As stated in the previous section that details PPCMB's OMA violation, the closed session held at PPCMB's June 8, 2021 meeting was improper.

68. The records are not exempt under Section 7(1)(a) of FOIA and 2.06(e) of OMA.

69. As of the date of this filing, OIAG has not complied with FOIA and has produced no records responsive to this request.

#### **PROBABLE CAUSE OF FUTURE VIOLATIONS**

70. The positions taken by OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD regarding these meetings indicate either a misunderstanding of or unwillingness to comply with OMA.

#### COUNT I – OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD'S VIOLATION OF OMA: JUNE 8, 2021 SPECIAL MEETING

- 72. OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND

COMPLIANCE MONITORING BOARD is a public body under OMA required to hold open meetings.

73. OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD violated OMA by improperly discussing matters in a closed session, by redacting minutes from open sessions, and by failing to produce the recording and minutes of the closed session.

#### COUNT II - OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD'S VIOLATION OF SECTION 7(e)(9) OF OMA

### 75. OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND

COMPLIANCE MONITORING BOARD is a public body under OMA required to hold open meetings.

76. OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD violated Section 7(e)(9) of OMA by failing to make all verbatim recordings of its meetings available to the public.

## COUNT III – THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL'S VIOLATION OF FOIA: FAILURE TO PRODUCE RECORDS

77. The above paragraphs are incorporated by reference.

78. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL is a public body under FOIA.

79. The records sought in the FOIA requests are non-exempt public records of THE

OFFICE OF THE ILLINOIS ATTORNEY GENERAL.

80. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL violated FOIA by

failing to produce all records responsive to the requests.

## COUNT IV – THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL'S VIOLATION OF FOIA: FAILURE TO PERFORM AN ADEQUATE SEARCH

81. The above paragraphs are incorporated by reference.

82. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL is a public body under FOIA.

83. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL bears the burden of proving beyond material doubt that it performed an adequate search for records responsive to the requests.

84. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL has failed to come forward with sufficient evidence to carry this burden.

85. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL has violated FOIA

by failing to adequately search for records responsive to the requests.

#### COUNT V – THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL'S VIOLATION OF FOIA: WILLFUL AND INTENTIONAL VIOLATION OF FOIA

86. The above paragraphs are incorporated by reference.

87. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL is a public body

### under FOIA.

88. The records sought in the FOIA request are non-exempt public records of THE

OFFICE OF THE ILLINOIS ATTORNEY GENERAL.

89. THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL willfully and

intentionally, or otherwise in bad faith failed to comply with FOIA.

WHEREFORE, Plaintiffs ask that the Court:

- i. declare that OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD violated OMA;
- ii. enjoin OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD from improperly discussing matters in closed session;
- iii. order OFFICE OF THE ATTORNEY GENERAL PROCUREMENT POLICY AND COMPLIANCE MONITORING BOARD to produce the verbatim recordings and minutes of the June 8, 2021 closed session, and the verbatim recordings and un-redacted minutes from PPCMB's May 7, 2021, May 10, 2021, May 13, 2021, and May 14, 2021 open meetings;
- iv. declare that THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL violated FOIA;
- v. order THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL to conduct an adequate search for the requested records;
- vi. order THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL to produce the requested records;
- vii. enjoin THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL from withholding non-exempt public records under FOIA;

- viii. order Defendants to pay civil penalties;
- ix. award Plaintiffs reasonable attorneys' fees and costs; and
- x. award such other relief the court considers appropriate.
