Thank you again for your Freedom of Information Act Request submitted on August 17, 2021, and received by the City on August 18, 2021, wherein you requested the following documents:

1. A copy of the building permits obtained for the construction of the sidewalk in front of the Mayor's property.
2. A copy of all invoices received pertaining to the construction of the sidewalk in front of the Mayor's property.
3. A copy of the minutes of the Streets and Sidewalks Committee meeting minutes where the sidewalk construction in front of the Mayor's property was approved.
4. A copy of the agenda for the Streets and Sidewalks Committee meeting where they approved the sidewalk construction in front of the Mayor's property.

The City is granting your request and has enclosed responsive documents that you may download via the sharepoint link included in the email. **The City did not require a building permit when the City performs or contracts to perform work, such as the sidewalk in this instance, so none has been provided.** Please call me at (217) 428-0948 if you have any questions or have trouble accessing these documents.

You have a right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Attorney General. 5 ILCS 140/9.5(a). You can file your request for review with the PAC by writing to:



You also have the right to seek traditional review of your denial by filing a lawsuit in the state circuit court. 5 ILCS 140/11.

If you chose to file a Request for Review with the PAC, you must do so within 60 calendar days of this denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a request for review the PAC.
