## **RESOLUTION #2011-R-04**

WHEREAS, Chapter 55 ILCS 5/2-3001, et seq. provides for "Reapportionment of County for Election of County Board", and

WHEREAS, said Statutes further provide that reapportionment shall be concluded by the County Board on or before July 1, 1971, and each ten (10) years thereafter so that each member of the County Board represents the same number of inhabitants, and

WHEREAS, the said Statutes further provide for the determination by the County Board as to the number to be elected to the County Board, whether board members shall be elected at large or by County Board Districts, provide that the Chairman of the County Board be elected by the voters of the County or by the members of the Board, and determine the salary to be paid members to be elected and any additional compensation for the Chairman of the County Board.

NOW, THEREFORE, the members of the County Board resolve that the County of Crawford, State of Illinois, shall be divided into five (5) districts for the purpose of electing the County Board and that two (2) board members shall be elected from each district and that said districts are determined by precincts, population and numbers as follows:

2010 Census was 19,817 less 1200 prisoners for a total of 18,617 used for reapportionment for County Board redistricting.

BE IT FURTHER RESOLVED that the members elected from said district in April 1972, and every ten (10) years thereafter to said County Board shall determine by lot which members shall serve two (2) years and which for four (4) years and that their successors shall be elected to a four (4) year term with all terms commencing on the first Monday of the month following the month of election.

BE IT FURTHER RESOLVED that the Chairman of the County Board shall be determined by the members of the Board rather than having the chairman elected by the voters of the County and that the chairman must be a member of the Board having been elected to such position and the chairman elected by the members of the Board shall be elected for a two (2) year term to commence on the first Monday of the month following the month in which members of the county board are elected and at the same meeting, choose one of its members as vice-chairman for a term of two (2) years.

BE IT FURTHER RESOLVED that the compensation for the County Board members

shall be:

- 1. one-hundred twenty-five dollars (\$125.00) per diem for board meetings,
- 2. seventy-five dollars (\$75.00) for committee meetings
- 3. the prevailing mileage rates as determined by the Board for the County Officers and Board Members for travel to and from meetings
- 4. two-hundred and seventy-five dollars (\$275.00) for the Chairman of the Board for each Board meeting
- 5. one-hundred dollars (\$100.00) annually per board member for office supplies.


