#### **COMPLAINT**

NOW COMES Plaintiff, EDGAR COUNTY WATCHDOGS by the undersigned attorneys, Loevy & Loevy, and brings this Freedom of Information Act (FOIA) suit to force THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL ("AG'S OFFICE") to comply with FOIA. AG'S OFFICE has made an improper blanket assertion of FOIA's exemption for interference with pending law enforcement investigations over records that pertain to the Illinois State Police's investigation into the former Shelby County Sheriff regarding the sale of confiscated guns and other issues. In support of the Complaint, Plaintiff states as follows:

#### INTRODUCTION

- 1. Pursuant to the fundamental philosophy of the American constitutional form of government, it is the public policy of the State of Illinois that all persons are entitled to full and complete information regarding the affairs of government and the official acts and policies of those who represent them as public officials and public employees consistent with the terms of the Illinois Freedom of Information Act ("FOIA"). 5 ILCS 140/1.
- 2. Restraints on access to information, to the extent permitted by FOIA, are limited exceptions to the principle that the people of this state have a right to full disclosure of

information relating to the decisions, policies, procedures, rules, standards, and other aspects of government activity that affect the conduct of government and the lives of the people. 5 ILCS 140/1.

3. Under FOIA Section 1.2, "[a]ll records in the custody or possession of a public body are presumed to be open to inspection or copying. Any public body that asserts that a record is exempt from disclosure has the burden of proving by clear and convincing evidence that it is exempt." 5 ILCS 140/1.2.

#### **PARTIES**

- 4. Plaintiff EDGAR COUNTY WATCHDOGS ("ECW") is a non-profit news media organization located in Paris, Illinois.
- 5. Defendant THE OFFICE OF THE ILLINOIS ATTORNEY GENERAL ("AG'S OFFICE") is a statewide agency, located in Cook County among others, and a public body under FOIA.

#### **DECEMBER 6, 2021 FOIA REQUEST**

- 6. On December 6, 2021, ECW submitted a FOIA request to AG'S OFFICE for a "[c]opy of all reports, documents, audio/video recordings provided to the Attorney General by the Illinois State Police regarding the criminal investigation of the former Shelby County Sheriff's Office involving illegal gun sales and payroll fraud. This matter was turned over to the AG for a charging decision over a year ago and considering there has been no further action taken nor any ongoing investigation, I am seeking all the records provided by the ISP as a result of their investigation." Ex. 1.
- 7. On December 13, 2021, AG'S OFFICE acknowledged receipt of the request and sought an extension of five business days and assigned reference number 2021 FOIA 068840 to the matter. Ex. 2.

- 8. On December 20, 2021, AG'S OFFICE stated that it is "still searching for records responsive" to the request and sought another extension of five business days. Ex. 3.
- 9. On December 27, 2021, AG'S OFFICE stated that it has "located" records responsive to the request, but it is "still reviewing the records." AG'S OFFICE sought an extension until January 10, 2022, to "provide the next response." Ex. 4.
- 10. On January 10, 2022, AG'S OFFICE stated that it is "still reviewing the responsive records" and sought another extension until January 18, 2022, to provide "the next response." Ex. 5.
- 11. On January 18, 2022, AG'S OFFICE stated that it is "still reviewing the responsive records" and sought an extension until January 24, 2022, to "provide the next response." Ex. 6.
  - 12. On January 19, 2022, ECW agreed to an extension until January 21. Ex. 7.
- 13. Completely disregarding ECW's January 19, 2022 email, AG'S OFFICE sought another extension on January 24, 2022, and requested that ECW permit AG'S OFFICE until January 31, 2022, to provide "the next response." Ex. 8.
- 14. On January 25, 2022, ECW denied AG'S OFFICE's extension. Ex. 9.

  On January 31, 2022, AG'S OFFICE denied the request in its entirety by citing Section 7(1)(d)(i) of FOIA. Ex. 10.
  - 15. Section 7(1)(d)(i) states:

Records in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes, but *only to the extent that disclosure would*:

- (i) interfere with *pending or actually and reasonably contemplated law enforcement proceedings* conducted by any law enforcement or correctional agency that is the recipient of the request.
- 5 ILCS 140/7(1)(d)(i). (Emphasis added).
- 16. In violation of Section 9(a) of FOIA, AG'S OFFICE has not provided a "detailed factual basis for the application of any exemption claimed." 5 ILCS 140/9(a).
- 17. AG'S OFFICE provided only a vague claim indicating records responsive to the request "contain information related to the legal issues under consideration by this office and other government agencies." Ex. 10.
- 18. "Legal issues under consideration" is not a "pending or actually and reasonably contemplated law enforcement proceeding."
- 19. AG'S OFFICE has not demonstrated that there is a "pending or actually and reasonably contemplated law enforcement proceeding" by AG'S OFFICE.
- 20. Further, even if there is a pending or actually and reasonably contemplated law enforcement proceeding, which AG'S OFFICE failed to show, AG'S OFFICE has not shown how the disclosure of the requested records *would* "interfere with pending or actually reasonably contemplated law enforcement proceedings conducted by" the "law enforcement agency that is the recipient of the request." 5 ILCS 140/7(1)(d)(i).
- 21. Instead, AG'S OFFICE generally claimed that releasing such information "would interfere with this office's ability to fully assess all legal issues and pursue the appropriate courses of action." Ex. 10.
- 22. AG'S OFFICE has failed to demonstrate that the records responsive to the request are exempt under FOIA.
  - 23. The requested records are not exempt under FOIA.

24. As of the date of this filing, AG'S OFFICE has not complied with FOIA and has produced no records responsive to the request.

#### COUNT I – DECEMBER 6, 2021 FOIA REQUEST, FAILURE TO PRODUCE RECORDS

- 25. The above paragraphs are incorporated by reference.
- 26. AG'S OFFICE is a public body under FOIA.
- 27. The records sought in the FOIA requests are non-exempt public records of AG'S OFFICE.
- 28. AG'S OFFICE violated FOIA by failing to produce records responsive to the request.

### **COUNT II – DECEMBER 6, 2021 FOIA REQUEST, FAILURE TO PERFORM AN ADEQUATE SEARCH**

- 29. The above paragraphs are incorporated by reference.
- 30. AG'S OFFICE is a public body under FOIA.
- 31. AG'S OFFICE bears the burden of proving beyond material doubt that it performed an adequate search for records responsive to the requests.
- 32. AG'S OFFICE has failed to come forward with sufficient evidence to carry this burden.
- 33. AG'S OFFICE has violated FOIA by failing to adequately search for records responsive to the requests.

### COUNT III – DECEMBER 6, 2021 FOIA REQUEST, WILLFUL AND INTENTIONAL VIOLATION OF FOIA

- 34. The above paragraphs are incorporated by reference.
- 35. AG'S OFFICE is a public body under FOIA.

36. The records sought in the FOIA request are non-exempt public records of AG'S

OFFICE.

37. During the time period of December 6, 2021, to present, AG'S OFFICE was

aware that the mere "consideration of legal issues" does not meet the standard of "pending or

actually and reasonably contemplated law enforcement proceedings" outlined in Section

7(1)(d)(i) of FOIA.

38. During the time period of December 6, 2021, to present, AG'S OFFICE was also

aware that it must conduct its analysis of Section 7(1)(d)(i) on a document-by-document basis.

39. AG'S OFFICE did not conduct a document-by-document analysis before denying

ECW's FOIA request.

40. Because there was no good-faith basis for AG'S OFFICE to assert that the records

are exempt under 7(1)(d)(i), AG'S OFFICE willfully and intentionally, or otherwise in bad faith

failed to comply with FOIA.

WHEREFORE, ECW asks that the Court:

i. declare that AG'S OFFICE violated FOIA;

ii. order AG'S OFFICE to conduct an adequate search for the records responsive to

the request;

iii. order AG'S OFFICE to produce records responsive to the request;

enjoin AG'S OFFICE from withholding non-exempt public records under FOIA; iv.

order AG'S OFFICE to pay civil penalties; v.

award Plaintiff reasonable attorneys' fees and costs; and ix.

award such other relief the court considers appropriate. х.





Thank you for writing to the Office of the Illinois Attorney General with your request for information pursuant to the Freedom of Information Act (FOIA) (5 ILCS 140/1 et seq. (West 2020)).

In an e-mail received on December 6, 2021, you requested the following:

1. Copy of all reports, documents, audio/video recordings provided to the Attorney General by the Illinois State Police regarding the criminal investigation of the former Shelby County Sheriff's office involving illegal gun sales and payroll fraud. This matter was turned over to the AG for a charging decision over a year ago and considering there has been no further action taken nor any ongoing investigation I am seeking all the records provided by the ISP as a result of their investigation.

On December 13, 2021, we extended the time to respond to your request by five business days pursuant to section 3(e)(iv) of FOIA (5 ILCS 140/3(e)(iv) (West 2020)) because the requested records had not been located in the course of routine search and additional efforts were being made to locate them. We further extended the time to respond to January 31, 2022, in letters this office sent to you on December 20, 2021, December 27, 2021, January 10, 2022, January 18, 2022, and January 24, 2022.

Your request is denied pursuant to section 7(1)(d)(i) of FOIA. 5 ILCS 140/7(1) (d)(i) (West 2020). Section 7(1)(d)(i) exempts from disclosure "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement \* \* \* agency [created] for law enforcement purposes \* \* \* to the extent that disclosure would unavoidably \* \* \* interfere with pending or actually and reasonably contemplated law enforcement proceedings conducted by any law enforcement \* \* \* agency that is the recipient of the request." The records contain information related to the legal issues under consideration by this office and other government agencies. To release such information while the investigation is pending would interfere with this office's ability to fully assess all legal issues and pursue the appropriate courses of action.

You have a right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a) (West 2020). You may file your request for review with the PAC by writing to:

If you choose to file a request for review with the PAC, you must do so within 60 calendar days of the date of this denial letter. 5 ILCS 140/9.5(a) (West 2020).
