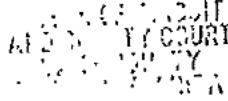

1. The weeks of Sept. 1 - Nov. 18 was in contact with my employer, the website, the people employed with, and the companies online presence to attempt to cause me a job loss. "Questioning my employment, position, duties and supplying fabricated info on me."
2. The weeks of Sept. 1 - Nov. 18 she was in contact with online media sites for my second job in Illinois, reporters sites, and political affiliates about me, in attempts to discredit me and my reputation as a Doctor + Worker "Joining their websites, FB sites, comments, calling people."
3. November 16th she was cyber stalking my Linked In account, looking at my personal information.
4. I filed a third police report on 11-20-2020 for cyberstalking + harassing.
5. Five years ago I filed a cease + Decist order for the same behavior.
6. Over 5 years she has tried to use false information to defame me.
7. I've asked her multiple times to stop cyber stalking + harassing me over 5 years.
8. We were never friends, just 2 people living in the same subdivision, yet she spends her life and every day digging into my life.
9. As a Top Secret DoD employee, my company has monitored her and deems her a high level security risk.
10. She not only cyber stalks me, she has my HOA cite me with false information, when I bring my RV to my house, by laws say I have 3 days. She reports it as being there 3 days on the first day. She reports my grass, weeds, etc. even not justified.

This Lady has a sick obsession with me and my family + now my employment. She will stop at nothing. I am afraid for her violence as well as her level of harassment + cyberstalking daily + escalating over 5 years.

2. Petitioner asks the Court to enter an Injunction for Protection prohibiting Respondent from committing any acts of stalking against Petitioner and:

a. Prohibiting Respondent from going to or within 500 feet of any place Petitioner lives;

b. Prohibiting Respondent from going to or within 500 feet of Petitioner's place(s) of employment and/or the school that Petitioner attends; the address of the Petitioner's place(s) of employment and/or school is: JHT (Galardo) + Citizens for a Better Bowlingbrook (Bowlingbrook, IL (JHT.com + FB & BB))

c. Prohibiting Respondent from contacting Petitioner by telephone, mail, by e-mail, in writing, through another person, or in any other manner;

d. Ordering Respondent not to use or possess any guns or firearms;

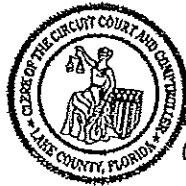

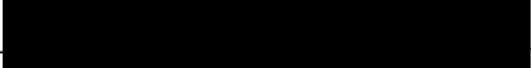
