on or about **June 19, 2022**, at and within Will County, Illinois, **ANGEL CONTRERAS**, a male person, committed the offense of:

**AGGRAVATED DRIVING UNDER THE INFLUENCE  
(Class 2 Felony - Category A)**

in that said defendant, while under the influence of alcohol, drove a vehicle, a 2007 Honda Ridgeline, on Western Avenue in Joliet, Will County, Illinois, and the defendant has previously violated 625 ILCS 5/11-501 or a similar provision on February 28th, 2008 in Mahaska County, Iowa under case number OWIN106389, and on August 15th, 2015 in Elkhart Superior Court, Indiana under case number 20D05-1508-CM-001334, said violation being a third violation, in violation of Chapter 625, Act 5, Section 11-501(a)(2) and (d)(1)(A) and (d)(2)(B) and (d)(3) of the Illinois Compiled Statutes, 2022, contrary to the Statute, and against the peace and dignity of the same People of the State of Illinois, AOIC 0014699 and

on or about **June 19, 2022**, at and within Will County, Illinois, **ANGEL CONTRERAS**, a male person, committed the offense of:

**AGGRAVATED DRIVING UNDER THE INFLUENCE**  
**(Class 2 Felony - Category A)**



**COUNT V**

on or about **June 19, 2022**, at and within Will County, Illinois, **ANGEL CONTRERAS**, a male person, committed the offense of:

**AGGRAVATED DRIVING WHILE LICENSE REVOKED**  
(Class 4 Felony - Category B)

in that said defendant drove or was in actual physical control of a motor vehicle, a 2007 Honda Ridgeline, upon Western Avenue in Joliet, Will County, Illinois, and he did so at a time when his driver's license was revoked for a violation of Section 11-501 of the Illinois Vehicle Code, or a statutory summary suspension or revocation under Section 11-501.1 of the Illinois Vehicle Code, and the defendant was previously convicted under Chapter 625, Act 5, Section 6-303 under 114700062 in Will County on December 8, 2020, and under 244100725 in DuPage County on July 8, 2021, and said previous convictions occurred when the defendant's driver's license was suspended or revoked for a violation of 11-401 or a similar out-of-state offense or local ordinance, 11-501 or a similar out-of-state offense or local ordinance, 11-501.1 or a violation of Section 9-3 of the Criminal Code of 1961 or the Criminal Code of 2012, relating to the offense of reckless homicide, or a similar out-of-state offense, and the current violation of Chapter 625, Act 5, Section 6-303 is the defendant's 3rd violation, in violation of Chapter 625, Section 5/6-303(d-2)(1) and (2) of the Illinois Compiled Statutes, 2022, contrary to the Statute, and against the peace and dignity of the same People of the State of Illinois, AOIC 0014057.
