ORDER

This matter coming to be heard on Mayor TIFFANY HENYARD’s Emergency Motion for a TRO and and for status, counsel for the parties being present, and the Court being advised in the premises;

IT IS HEREBY ORDERED THAT:

- (1) The Court finds that there does not exist an emergency as of today’s date with respect to this cause and the issuance of checks;
- (2) By agreement of the parties, all payroll checks and outstanding approved paper checks for expenditures previously authorized by the Corporate Authorities bearing the Mayor’s signature shall be honored by Fifth Third Bank and any other bank in receipt of same. Fifth Third Bank shall be notified of same.
- (3) By agreement of the parties, the Special Meeting set by the Trustees for today at 4:00 p.m. shall not review and pass upon the approval of bills. Specifically, Agenda Item No. 6 entitled “Corporate Bills” shall not be passed upon, considered or otherwise voted upon by the corporate authorities.


- (4) By further agreement of the parties, payroll checks not issued during the current pay period that were scheduled to be paid today to the Trustees and the Clerk shall be issued on October 7, 2022.
- (5) By further agreement of the parties, The Village Board may consider and approve warrants at the Village Board meeting of October 17, 2022; however, no checks other than the ones indicated above, any necessary additional payroll checks, and insurance checks shall be executed by the Trustees pursuant to their Check Signing Ordinance 22-004 prior to the hearing on the TRO as reflected in this Order;
- (6) , The Court grants Plaintiff's oral motion for leave to file an Amended Verified Complaint and an Amended Verified Motion for a TRO on or before October 11, 2022;
- (7) The Defendants shall file any response to the Amended Motion on or before October 18, 2022;
- (8) Courtesy copies shall be delivered to the Court via email by October 21, 2022;
- (9) This matter is set for hearing on Plaintiff's Amended Motion for a TRO on October 28, 2022 at 8:45 a.m. via Zoom. Zoom ID No.: 928 4730 2982, Password: 411367; Dial-in: 312-626-6799.
